Dear Chairman Perez,

On behalf of the Sierra Club's 3.8 million members and supporters, we demand that the Democratic National Committee (DNC) immediately reinstate the language originally included in its platform calling for the end of tax breaks and subsidies for fossil fuel companies. The climate crisis combined with the Trump Administration's mishandling of the COVID-19 pandemic has further exacerbated this country's ongoing public health crisis caused by pollutants - pollutants that lead to early death, heart attacks, respiratory disorders, stroke and asthma. As we approach one of the most consequential presidential elections in modern American history, the DNC has the important charge of developing a platform that rejects the Trump Administration's threats to our collective humanity by establishing principles of equity, justice, and opportunity for all.

What we know is that recent polling proves that eliminating federal subsidies to the fossil fuel industry is very popular with voters from all political party affiliations. What we also know is that the egregious fossil fuel industry is primarily responsible for our climate crisis. What's worse - fossil fuel industry executives have received billions of dollars from the federal government to keep their businesses afloat, but little or nothing has gone to the clean energy industry. This country is already on track to fall behind on its promise to reduce our carbon footprint thanks to President Trump's disastrous decision to withdraw the U.S. from the 2015 Paris Agreement.
