### **Nevada Ballot Initiatives**

The Sierra Club Toiyabe Chapter has NOT endorsed any of the 2020 ballot initiatives.

**Question No. 6:** Renewable Energy Promotion Initiative. Sierra Club endorsed this ballot initiative in 2018. It won with 59% of the vote. Because it would amend Nevada's constitution, it must pass twice. However, following the mandate of the people in 2018, the 2019 Nevada Legislature passed SB 358, which enacted Nevada's Renewable Portfolio Standard (RPS) to accomplish the same goals as Question 6. Your yes vote on this question in 2020 will be a pro-forma-but-necessary vote to satisfy the ballot initiative requirement and avoid awkward conversations about Nevada's RPS should the ballot initiative fail.
