#### **Concerned residents regarding CEMEX land trust plans**

Jake and Linda Bernstein; residents of Bonny Doon

Proposed development includes: hiking, biking, logging, and possibly many other uses Mentioned concerns about wildlife - mountain lions, etc.

Concerns about safety - increased bike use may lead to accidents on windy roads

Fire, sheriff takes time, water usage, patrolling, noise, parking lot

Many other areas nearby are accessible to people; this place may be best left untouched for wildlife

#### Guest, Bryan Largay, Conservation Director, Land Trust

- Living Landscape Initiative coalition of a five groups working to conserve the land and create wildlife corridors, etc.
  - Save the Redwoods League
  - Land Trust of Santa Cruz County
  - Nature Conservancy
  - Sempervirens fund
  - Peninsula Open Space Trust (POST)
- Public access may be off Empire Grade
- Illegal activity how monitored?
- Save the Redwoods would purchase land as easement
- Land trust role coordinate public access
- Plan creates zoning timber harvesting, recreation, reserves
- Timber cut for "restoration purposes only" likely species of oak that have overgrown;
   redwood clumps that with thinning could lead to larger redwoods

- National Monument status may provide higher level of ecological protection, first transfer to BLM needed; slightly higher revenue as Monument
- Claim that mountain lions benefit from increased logging
