APPROVAL OF THE PORT OF STOCKTON ANNUAL UTILITY WILDFIRE MITIGATION PLAN

Resolution #8151: WHEREAS, the Stockton Port District is a public corporation created for

municipal purposes under Section 6290 of the California Harbors and

Navigation Code; and

WHEREAS, the Port is generally subject to the legislative and regulatory requirements applicable to local publicly owned electric utilities (POU); and

WHEREAS, Senate Bill (SB) 1028 (stats. 2016), adding California Public Utilities Code, Section 8387, requires each POU to construct, maintain and operate its electrical lines and equipment in a manner that will minimize the risk of wildfire posed by those electrical lines and equipment; and

WHEREAS, SB 901 (stats. 2018), amending California Public Utilities Code Section 8387, requires all POUs to prepare a Utility Wildfire Mitigation Plan before January 1, 2020, and annually thereafter; and

WHEREAS, California Public Utilities Code Section 8387(b)(2) specifies the content that must be included in each POU's Utility Wildfire Mitigation Plan; and

WHEREAS, California Public Utilities Code Section 8387(c) requires each POU to have a qualified independent evaluator review its Utility Wildfire Mitigation Plan to assess the comprehensiveness of its plan and to issue a report that is made available on the POU's website and presented at a public meeting; and

WHEREAS, California Public Utilities Code Section 8387(b)(3) requires each POU to present its Utility Wildfire Mitigation Plan at an appropriately noticed public meeting and to verify that its plan complies with all applicable rules, regulations and standards, as appropriate; and

WHEREAS, SB 111 (stats. 2019), adding California Public Utilities Code Section 326.1, established the California Wildfire Safety Advisory Board; and

WHEREAS, SB 1054 (stats. 2019), amending California Public Utilities Code Section 8387, requires each POU to submit its Utility Wildfire Mitigation Plan to the California Wildfire Safety Advisory Board by July 1 of each year, starting in the year 2020; and

WHEREAS, pursuant to California Public Utilities Code Section 326.2, the California Wildfire Safety Advisory Board will review each POU's Utility Wildfire Mitigation Plan and will provide comments and advisory opinions on the content and sufficiency of each plan; and

WHEREAS, Port staff prepared a Utility Wildfire Mitigation Plan for calendar year 2020, addressing all statutory criteria; and

WHEREAS, the Port verified that the Utility Wildfire Mitigation Plan complies with all applicable rules, regulations, and standards; and

WHEREAS, the Fire Marshall is a qualified independent evaluator and, after reviewing the Port's Utility Wildfire Mitigation Plan, has determined that the plan meets the requirements of California Public Utilities Code Section 8387; and

WHEREAS, within 60 days, the Fire Marshall shall prepare a report to be presented at a public meeting of Port's governing board and posted to the Port's website; and

WHEREAS, Port staff will submit its Utility Wildfire Mitigation Plan, adopted today by the Port's governing board, to the California Wildfire Safety Advisory Board before July 1, 2020; now, therefore be it

Director of Development and Planning Villanueva presented an executive summary of this agenda item.

Project Overview

This project will provide infrastructure and connections to Port provided electric vehicle (EV) chargers and a cover to allow equipment to be sheltered from the environment. The replacement of the Port's current outdated equipment with newer clean zero-emission cargo handling

equipment would serve the Port's needs while leveraging grant funding to reduce the overall cost.

In collaboration with the Port of Oakland and the Port of Long Beach, Port staff proposes a bold, transformative emission reduction strategy that can be emulated throughout freight facilities across the state. Sustainable Terminals Accelerating Regional Transformation (START) is a multi-agency collaboration to deploy zero-emissions port technologies across an intermodal freight network under the California Air Resources Board (CARB) program to reduce diesel emissions and support Zero- and Near-Zero Emission Freight Facilities (ZANZEFF).

Benefit

The Port has the need and opportunity to take advantage of the START program collaboration to leverage existing grant funding to replace part of its aging fleet of cargo handling equipment. Current diesel emission control filters are causing the Port's existing equipment to become less efficient.

The legally required advertisement for this project appeared in The Record on September 11, 2019. It was also posted to the Port's website and distributed to local/regional plan rooms and building exchanges. A mandatory pre-bid conference and site visit was held on September 17, 2019. One (1) bid was received by 3:00 p.m. on October 23, 2019, and the bid result was as follows:

- Diede Construction, Inc., Lodi, CA for the amount of \$2,066,150

Port staff proposes that the Port pay for this project with funds from the ZANZEFF Grant at 100 percent (100%).

Environmental review and analysis of the ZANZEFF Grant Project Electric Forklift Charging Stations, pursuant to the California Environmental Quality Act (CEQA), determined its CEQA Categorical Exemption pursuant to Sections 15301(c), 15304 and 15061(b)(3).

FOR THE PORT POLICE FUSION CENTER PROJECT FOR \$670,000

Director of Development and Planning Villanueva presented an executive summary of this agenda item.

Project Overview

This project consists of the construction of a new Port Police Fusion Center at existing building 17A on the West Complex north of the main entrance. The new 1,601 square foot, single story office structure would be constructed on a new concrete pad foundation and include a covered walkway. The building would include two open offices, four private offices, two all-gender accessible restrooms and two open kitchen/coffee areas. This multi-departmental workspace will provide office spaces for the Port Police Department, United States Coast Guard (USCG), Department of Homeland Security (DHS), and the Transportation Security Administration's (TSA) Transportation Worker Identification Credential (TWIC) office.

Benefit

This project is a Technology and Security grant project with a focus on TWIC Final Rule Compliance, which will provide the necessary infrastructure to satisfy Maritime Transportation Security Act requirements and implementation according to the USCG, DHS, and the TSA.

The legally required advertisement for this project appeared in The Record on October 9, 2019. It was also posted to the Port's website and distributed to local/regional plan rooms and builder's exchanges. A mandatory pre-bid conference and site visit was held on October 16, 2019. Six (6) bids were received by 3:00 p.m. on November 20, 2019, and the bid results were as follows:

- Haggerty Construction, Inc. of Stockton, CA for \$670,000
- Swierstok Enterprise Inc., dba Pro Builders of Orangevale, CA for \$698,000
- Stratus Construction Co. of Stockton, CA for \$722,994
- T. Amaral's Done Right Construction of Brentwood, CA for \$730,000
- Diede Construction, Inc. of Woodbridge, CA for \$760,000
- Vaguero Construction of Gilroy, CA for \$999,049

Port staff proposes that the Port pay for this project with funds as follows:

- FEMA Grant 2016-PU-00450 at seventy-five percent (75%) which is \$502,500
- Port match at twenty-five percent (25%) which is \$167,500

COMMITTEE REPORTS

Ad Hoc Committee

On November 18, 2019 an Ad Hoc Committee comprised of Commissioners Allen and Christopherson met with the Port Director and staff to review and discuss the proposed amendments to the Stockton Port District Policy Statement.

PORT DIRECTOR'S COMMENTS

Port Director Aschieris provided an executive summary of recent Port activities.

- Since the last Commission meeting, the following short-term leases have been executed:

Lessee: University of the Pacific

Location: West Complex, Building 618, 880 square feet of storage space

Term: 1 year

Lessee: Contractors Cargo Company

Location: West Complex, 2.25 acres of land at 1006 Humphreys Drive

Term: 1 year

- Current calendar year-to-date shipping reflects 217 ships. Shipping activity for the same period in 2018 reported 238 ships. Since the last Commission meeting, 14 ships have called at the Port.

- Current calendar year-to-date tonnage totaled 4,179,289 metric tons. Tonnage for the same period in 2018 totaled 4,443,289 metric tons. Since the last Commission meeting, 243,324 metric tons of project cargo from Belgium, fertilizer from Chile, Norway and Trinidad, steel from Japan and Korea, sulfur to New Caledonia, food grade oil from Indonesia, cement from Vietnam and China and dry bulk to Japan have been handled.
- Director of Maritime Operations Katindoy gave an informational presentation about the Jones Act and the Penny Newman facility.
- The Port Director read Commissioner Mow's resignation letter. His resignation is effective December 3, 2019.

COMMISSION COMMENTS

Vice Chairman Duffy shared that he attended the Port presentation that the Port Director gave to the San Joaquin County Grand Jury on November 21, 2019. He shared that the Port Director represented the Port very well.

Commissioner Barkett shared that the Commission was invited to tour the Nautilus barge on December 11, 2019 in the Bay Area.

Commissioner Christopherson shared his positive comments about Commissioner Mow's public service to not only the Port of Stockton but the City Council of the City of Stockton and the Board of Supervisors for San Joaquin County. Chairman Griffen endorsed those remarks.

Commissioner Christopherson shared with those present an article from the Wall Street Journal about how ground-lease deals are growing in popularity.
