## PORT DIRECTOR'S COMMENTS

Port Director Aschieris provided an executive summary of recent Port activities.

- Since the last Commission meeting, the following short-term leases have been executed:

Lessee: Location: Term:	Transload Solutions, LLC West Complex, 4 rail tracks on 4.35 acres 5 years
Lessee:	County Plumbing and Restoration
Location:	East Complex, World Trade Building, Suite D, 1380 square feet of office space
Term:	1 year

- Current calendar year-to-date shipping reflects 187 ships. Shipping activity for the same period in 2018 reported 204 ships. Since the last Commission meeting, 8 ships have called at the Port.
- Current calendar year-to-date tonnage totaled 3,547,019 metric tons. Tonnage for the same period in 2018 totaled 3,721,176 metric tons. Since the last Commission meeting, 168,703 metric tons of cement/slag from China, fertilizer from Russia and Indonesia, molasses from Australia and corn from Turkey has been handled. The Port will look to secure biomass shipments during the last quarter of this year.
- The Port received notice that San Joaquin County would be removed from PG&E's Low Probability list of counties that may be impacted by a power shut off due to a Red Flag Watch due to a high-wind event starting Wednesday morning.

## COMMISSION COMMENTS

Commissioner Barkett thanked Chairman Griffen for his assistance with a Port tour.

Commissioner Blanchard thanked Port Director Aschieris for the presentation and Marketing Manager Grossgart for the tour that they gave to the new President of San Joaquin Delta College Dr. Omid Pourzanjani.

Chairman Griffen inquired about the return of the MV PACIFIC SPIKE. Port Director Aschieris shared that the partners had reached an agreement to continue providing the long rail for the next five years.
