Chapter Delegate: Dick Abood – MLC ExComm election of officers and committee assignments. Discussion at MLC focused on recruitment of young people. Banquet limited to 100 guests. Discussion of silent auction items. Paul Plathe moved and Richard Abood 2 nd'd that the D-S Group nominate Mary Elizabeth for the MLC chapter award. Aye 5, Nay 0. MLC Conservation Comm. –Discussion of how SC will approach Green New Deal. Discussion of legal issues surrounding LAFCO, Oroville Dam and Shasta Dam. New city to be developed between Lincoln and Placerville.

Chapter Delegate Alt: Steve Harvath

Conservation: Mary Elizabeth – Discussion of TriValley Cares, Site 300, and SB 1000 meeting. Mary Elizabeth proposed sending a letter of concern regarding the proposal to combine Dixon with Stockton so water utility can manipulate water quality issues. SJCOG-CAC: Paul Plathe – The "One Voice" lobbying effort is pushing for funding for improvements at the Stockton airport, railroad grade separation and ways to improve air quality. Discussion of safe routes to schools and state route 4 widening plan.

SJVAPCD-CAC: Ned Leiba – Discussion of how air quality mitigation funds are allocated including how urban trees have a beneficial impact on air quality. Discussion of Site 300 impact on air quality. Recommendation that Ned Leiba and Terilyn Chen connect on the idea for an asthma and air quality summit.
