

The Eastern San Joaquin Groundwater Authority (GWA) was established with a Joint Exercise of Powers Agreement on 4/11/2017 with memberst consisting of the 17 GSAs in the subbasin. The agreement specifies that the 17 GSAs will coordinate via the GWA to develop and implement a sir GSP. The GWA has not formally identified a Plan Member to represent the GSAs as a single point of contact for the subbasin. Each GSA has one board member at the board?s regular meeting on the second Wednesday of each month. Board meetings are open to all interested parties and generally are held at 9:30 a.m. at the Robert J. Cabral Agricultural Center Assembly Room#1 (2101 E. Earhart Avenue, Stockton). In addition to board meetings, more public outreach efforts are planned during the GSP development process. The GWA established a website (http://www.esjgroundwater.org/) where announcements and board meeting agendas are posted. GWA contact information is also posted for furth questions on public participation and involvement. The GWA is committed to developing its GSP in an open and transparent process that relies up stakeholder engagement and participation to ensure a widely accepted groundwater management plan to achieve sustainability in the subbasin.
