Do you support having the Wisconsin DNR undertake a 2-year pilot project to test if offering a healthy herds incentive payment to landowners and hunters can increase the testing rates and remove CWD+ deer to levels effective in reducing prevalence and slowing disease spread?	YES	We need to work together to reduce CWD and hopefully this pilot project will give us a guide forward.

Deer Management Tool Would you support the issuance of one either sex tag to a hunter who harvests a CWD positive antlerless deer in a county where the CDAC has made this recommendation?	YES	This offers an incentive for hunters to remove CWD deer from the landscape and curb areas of overpopulation.
Reallocation of Funding to Establish a Statewide Dumpster Program for Deer Carcass Disposal Would you support a reallocation of antlerless fund fees to establish a statewide dumpster program for handling deer carcass disposal?	YES	
Imposing stricter regulations on PFAS chemicals Would you support additional testing for PFAS levels Imposing stricter regulations on PFAS chemicals in drinking water across Wisconsin?	YES	PFAS are dubbed “forever chemicals” because they’re very difficult to break down, and, what’s more, are carcinogenic, interfere with our hormone systems, and have made their way into Wisconsin’s waterways and drinking water.
Imposing stricter regulations on PFAS chemicals Would you support the DNR continuing to advocate for strong PFAS protections and clean-up to ensure that everyone has access to clean drinking water and safe consumption of fish?	YES	
Allow the use of traps with a jaw spread up to 8 inches beginning on the opening day of wolf season Do you support a change to the Wisconsin trapping regulations to reduce the period during which the 7-inch size restriction is in place from the opening day of trapping season to the opening day of the wolf season, or November 30, whichever comes first?	NO	This question is confusing and asks that trapping restrictions be reduced to benefit wolf trappers, undermining shared resources.

<p>Allow an assistant to help a disabled person fish Would you support waiving the license requirement for an assistant who is helping a person with a disability with the process of fishing, including baiting, casting, retrieving and handling of the fish?</p>	YES	Everyone should have equal access to enjoy Wisconsin's natural resources.
<p>Funding Lower Chippewa River Parcels Do you support the State of Wisconsin identifying funds available to purchase of the remaining 760 acres?</p>	YES	The area is filled with precious natural diversity and along with the beautiful views above the Chippewa River that should be protected from private and commercial development.
<p>Should DNR permit and regulate all hunting contests to control wanton waste, and carcass dumping Do you support the Conservation Congress work with the DNR and legislature to develop a permitting and regulating process for hunting contests, similar to what they already do for fishing contests?</p>	YES	Currently, there are no laws governing Wildlife Killing contests, despite concerns that they are ecologically damaging.
<p>Wolf Population Goals Support wolf population goal of 350 or less wolves</p>	NO	The state's wolf population goals should be based on what the science says is the right number, with consultation with the Tribes. The number should not be based on politics, as the 350 number is.
<p>Pass the Recovering America Wildlife Act Do you support having all of Wisconsin's Congressional delegation support the passage of Recovering America's Wildlife Act in this session?</p>	YES	This bill would invest nearly \$1.4 billion for states, territories, and tribes to amplify their work in recovering, conserving, and protecting at-risk wildlife and habitat.
<p>Ban dogs from hunting wolves in Wisconsin (411221) (requires legislation) Would you support banning the use of dogs from hunting wolves in Wisconsin should wolves get delisted again?</p>	YES	This controversial practice sets up potential violations of Wisconsin State Statute Chapter 951.08, which prohibits instigating fights between animals.
<p>Wildlife killing contests Do you support the Conservation Congress working with the WDNR to develop and support a ban on all wildlife killing contests?</p>	YES	Science shows that killing animals does not reduce their population (the 'goal' of these contests) and can have adverse ecological effects.

Funding for WI Farmers for Non-Lethal Predator Prevention Programs

Do you support funding for farmers for non-lethal preventative measures to mitigate depredation?

Farmers need funding to prevent livestock depredation. Most predators can be discouraged by non-lethal means, while killing predators especially wolves and coyotes are often counterproductive.

Do you support the Wisconsin Conservation Congress directing the Natural Resources Board and DNR to avoid all new fossil fuel infrastructure?

With the threat of climate change looming and fossil fuel prices at an all-time high, we need to do everything we can to reduce our fossil fuel dependency and move to clean energy.

Every Kid Outdoors Program
Do you support the Conservation Congress

Eliminate Compensation for Hound Owners

Do you support the Conservation Congress working with the state legislature to end the payments to Hound Owners for dogs killed or injured by wolves while training or hunting bear?

Wisconsin is the only state that pays for the cost of a dog that is killed while hunting or training bears.

Oppose Sandhill Crane Hunting

The Wisconsin Conservation Congress needs to formally oppose SB 620 and the creation of a recreational Sandhill Crane hunt. Do you support the WCC taking a formal position against a Sandhill Crane hunting season in WI?

Sandhill cranes are an important migratory species. The eastern Sandhill crane has a low reproductive rate and are in population recovery status across most of their range.

Juvenile sandhill cranes can be confused with other, endangered cranes, like the whooping crane. ([More here](#))

Do you support the WCC advising the WDNR to seek a legislative ban on all wildlife killing contests?

Eliminate Compensation for Hound Owners

Do you support the Conservation Congress working with the state legislature to end the payments to Hound Owners for dogs killed or injured by wolves while training or hunting bear?

Wisconsin is the only state that pays for the cost of a dog that is killed while hunting or training bears.

Trap Warnings to Ensure Public Safety

Do you support implementation of public notification measures for areas where active trapping is taking place on DNR managed public lands and waters?

Our public lands should be there for everyone to use and this simple measure will make it safer for all to enjoy.

Eliminate Nighttime Hunting on Public Land

Do you support the Conservation Congress work with the WDNR to take action to correct this situation by introducing rule change restricting nighttime hunting of coyote and wolves on Multi Use Public Land?

Wolf hunting at night with dogs, ATVs, and snowmobiles raises public safety concerns, is disruptive to people who live in rural areas, and contributes to illegal poaching activities.

Ban the use of Hounds When Hunting Wolves

Do you support the WCC working with the Legislature to change state law to prohibit the use of hound dogs to hunt wolves to be consistent with Wisconsin State Statute Chapter 951.08, which prohibits instigating fights between animals?

This controversial practice sets up potential violations of Wisconsin's law that prohibits instigating fights between animals. The risk of it happening is significant and real as documented in DNR WI Wolf Season Report 2021.

Restrict Lead Fishing Tackle in Wisconsin

Do you support the WCC working with the DNR, the Natural Resources Board and our state legislature to implement a limitation on lead jigs and sinkers weighing 1oz or less? Limitation could be phased in.

As responsible hunters and stewards of the land, it is our responsibility to reduce lead in the environment to ensure a diverse and viable wildlife population for future generations.

Adjust the Time Period Bear Baiting Is Allowed

Would you support the WCC work with the DNR to develop a plan to safely and gradually decrease the number of days that bear bait may be placed, to reach a goal of 24 days?

Ban Chocolate Bear Bait

Would you support the Wisconsin Conservation Congress working with the DNR to implement a ban on chocolate bear baits?

Studies in WI have shown that 40% of a black bear's diet is from bait due to WI's extended baiting period of 5.5 months and brings the black bear population over it's natural biological carrying capacity. This unrestricted baiting, sets up high potential for conflict between wolves and bear hunters with hound dogs.

Chocolate is a known toxic substance and can make wildlife sick or even kill them. It is toxic to bears, wolves, foxes, coyotes and domestic pets. So much so, Michigan's Bear Hunters worked hard to have it made illegal there.

Restrict Lead Ammunition for Hunting in Wisconsin

Do you support the WCC working with the DNR, the Natural Resources Board and state legislature to implement limitations on lead ammunition? This would exclude ammunition used in target shooting and could be phased in over time.

Lost tackle has a direct impact on populations of loons, swans, eagles, and osprey. In the last 27 years, Northern Wisconsin's Common Loon population has decreased by 22%. A recent study that sampled 1200 eagles in thirty-eight states, including Wisconsin, found nearly half of all bald and golden eagles suffer from chronic lead poisoning.

Reduce the Hound Training Season Pursuing the Black Bear

Do you favor adopting a shorter hound training season that will benefit the physical health and welfare of the bears and dogs? If yes, the WCC will propose the DNR and NRB implement a rule change.

Requiring hound owners to register will provide a revenue stream to the DNR. It also spreads out the training pressure on the landscape for the hunter doing the training and also reduces the harassment of wildlife from hounds running free in the woods.
