#### Saturday, January 30, 10:00 a.m.: Kayak the Ichetucknee River



# Climate Reality and the Road from Paris: Jacksonville's January Program

At the COP 21 Paris climate negotiations in December, almost 200 countries signed onto a global climate deal. For the first time, nearly every country committed to lowering greenhouse gas emissions, to set their own path to limit global warming to 1.5-2°C.

Learn more about this bold and historic agreement, why it's so critically important for us all and what comes next, when local Sierra Club member Tom Larson, a trained Climate Reality Leader, presents a review of Climate Change, plus Perspectives and Outcomes from Paris.

Since 2000, Tom Larson has been active with the Sierra Club, focusing on energy & climate issues. For six years, he worked with the Southern Alliance for Clean Energy on energy policy research. In 2007-08, Tom served on the Climate Change Advisory Group of the Florida Energy Commission. For over nine years, Tom has conferred with the Jacksonville municipal utility, JEA, in its Clean Power Stakeholder Group.

This will be a chance to run thru the basics of climate science, risks to global ecosystems, governance& the economy—and what we can do about it to assure a good future for all.

## Ponte Vedra Program January 4, 2015 @ 6:00pm

Hiking the Camino de Santiago in Spain

The NE FL Sierra Club in Ponte Vedra will host a presentation by Miriam Gallet, Co-Coordinator for the St. Augustine Chapter of the American Pilgrims, about their trips to Europe to Hike the Camino de Santiago – which stretches across Spain. She'll talk about their adventures, and show many photos of the diverse scenery and historic landmarks. El Camino de Santiago, in English "The Way of Saint James," is the pilgrimage to the Cathedral of Santiago de Compostela in northwestern Spain, where legend has it that the remains of Jesus' apostle Saint James the Elder lie. The Camino has existed as a Christian pilgrimage for well over 1,000 years, and there is evidence of a pre-Christian route as well. Throughout the medieval period it was one of the three most important Christian pilgrimages undertaken - to Jerusalem, to Rome, and to Santiago de Compostela.

All kinds of people walk the Camino de Santiago. According to the records, 237,886 people completed the pilgrimage in 2014. While many will walk the Camino for religious reasons, others will look on it from a more secular viewpoint. A pilgrimage, after all, is not necessarily religious. There are many routes, many Caminos, to Santiago de Compostela. The best known route today, is the Camino francés, which crosses the north of Spain from the French border through Pamplona, Burgos and León all the way to Santiago. So come and learn more about this historical hike.
