

Rollback of Protection Possible for Manatee

The U.S. Fish & Wildlife Service (USFWS), under pressure from special interests such as big developers, is considering reducing manatee protection from "endangered" under the Endangered Species Act to a much lower level of protection. The fact remains that manatees still face many of the same threats which existed when they were originally listed under the Act. This is why Sierra Club, the Save the Manatee Club, and other groups, are working to preserve the manatee's endangered status.

Boaters killed more manatees in 2015 than in 2014 even with speed zones and no-entry zones to protect the mammals. Florida's increases in both human population and tourism further endanger manatees and



the down listing could bring relaxed restrictions on waterfront development and higher boat speed limits. Boaters and developers have been seeking a manatee down listing since 1999 in order to gain friendlier regulations.

State of Florida Readies for Second Bear Hunt

At its April 13 meeting of the Florida Fish and Wildlife Conservation Commission, commission chairman Brian Yablonski told his fellow commissioners to be ready to set a quota for the second annual bear hunt at the next meeting of the commission. This action was taken despite continued opposition to the hunt that was carried out last year which killed 304 bears.



Up until 2011, Florida Black Bears were classified as a threatened species under state law. However the commissioners voted in 2011 to remove bears from the state's list of protected species with the resulting hunt and killing of bears. In March of this year a coalition of scientists and environmental activists petitioned the U.S. Fish and Wildlife Service to place the Florida Black Bear on the federal endangered species list. In the petition it was noted that the bears were confronted with serious challenges including the shortage of saw palmetto berries, the loss of habitat to development, and the possibility of a second annual hunt.

The petition noted that: "Without Endangered Species Act protection, the Florida Black Bear could again find itself on the precipice of extinction." Federal offi-
