# First urban fitness hikers explore downtown resources—at a brisk pace

A group of Sierra hikers tried something new for our area on Saturday, Sept. 24: an urban fitness hike.

Club executive committee member Logan Cross organized the five-mile walk along what he called the Cowford Loop, using downtown streets, sidewalks, and urban park trails.

The hike began at the parking area underneath the Acosta Expressway at the intersection of Prudential Drive and San Marco Blvd.

The hikers visited Treaty Oak in DuPont Park, crossed the Main Street Bridge, headed east to Metropolitan Park, traced Hogan Creek northwest to Broad Street,

and then went across the Acosta Bridge to the hike starting point.

Fitness hikes are known for their fast pace, and this one was no exception, even on a hot Saturday morning. Everyone got a good workout.

In addition to fitness, though, the walk featured stops along the way to emphasize the natural resources of the urban area, the work being done to help protect and preserve them, and the long-term effort this work requires.

Logan said feedback from the hike was positive.

As a result, he's considering fitness hikes in the Riverside/ Avondale park systems and in the Southbank park system.

- Oct. 31. Last date to request a vote by mail ballot. (We are encouraging everyone to take advantage of this option whether you need it or not; vote in person by bringing the absentee ballot to the polling site.)
- Oct. 24 to Nov. 3, Duval County and St. Johns County early voting.
- Nov. 6. Election Day.

The Army National Guard funded the \$8 million purchase.
