# Transportation a Hot Topic

Changes in San Antonio's transportation scene are looming, if the flurry of public activity means anything. In October and November several meetings highlighting transportation issues took place. Both VIA and the Metropolitan Planning Organization (MPO) held a number of hearings to obtain public input on transportation alternatives.

Three October transit-focused meetings on three successive days are of particular interest. The October 26 meeting of the MPO Transportation Policy Board took place at the Alzafar Shrine Auditorium in order to accommodate the large crowd expected for a vote on toll roads, widely opposed in San Antonio. MPO chair Tommy Adkisson was disappointed when the majority of the board, in front of several hundred very vocal toll-

## Nuclear Still an Option?

CPS top leadership returned from Japan in mid-November without a new, lower cost estimate for the South Texas Nuclear Project expansion, but with a promise from Toshiba, the general contractor and a partner, that a new figure would be available by December 31. The new figure is expected to be revealed at a CPS board meeting January 15.

With the yen more solid than the dollar, it appears unlikely Toshiba will give a significantly lower cost figure. The multitude of companies and executives involved in the STP expansion, the need for security and redundant safety features, the importation of materials and equipment as well as

road opponents, voted in favor of tolling large sections of Loop 1604 and Hwy. 281. Among those who voted for toll roads were Bexar County Commissioners Chico Rodriguez and Kevin Wolff, State Senator Jeff Wentworth, and San Antonio City Councilmen John Clamp and Ray Lopez.

Toll opponents cite numerous reasons why Loop 1604 and U.S. Hwy. 281 should not be tolled. Tolling would more greatly impact the environment than other remedies to traffic congestion, which include overpasses and mass transit options. The tolling of existing roadways in Texas is a violation of the state's constitution. Opponents question the Texas Department Transportation's motives for tolling when other, less costly alternatives are available, including the more equitable raising of gasoline taxes.

On October 27, KSTX Radio held a town hall meeting on transportation issues, with a panel featuring State Representative Ruth Jones McClendon, UTSA Professor of Public Administration Heywood Sanders, VIA President and CEO Keith Parker, Office of Environmental Policy Senior Management Analyst Julia Diana, and Michael Miles, Senior Manager of Government Relations for the Dallas Area Rapid Transit (DART) Authority. Their dialogue cited the issues that confront San Antonio, including the fact that 90 percent of San Antonians go to work by car, with 12 percent carpooling and only 2 percent using public transit.

Sanders pointed out that Texas is handicapped because a large amount of the Texas Department of Transportation's budget must be spent on roads. Parker stated that San Antonio is challenged because its downtown area is not the economic center of the city, with only 25,000 employers downtown compared to 45,000 in the medical center area and even more in the airport area.

Miles noted that DART now has 47 miles of light rail, which has given the downtown area new vitality and encouraged new business relocation.

DART moves 70,000 people a day in Dallas.

Parker noted that, through a grant, San Antonio will get three fully electric buses, rechargeable in 15 minutes, that will begin running here within a year.

On October 28 the city's newly expanded Office of Environmental Policy held a luncheon meeting with electric vehicle and charging experts Robert F. Babik, General Motors' Director of Vehicle Emissions Issues, and Guy Mannino, President and CEO of Verdek-EV, a company that manufactures electric-car charging stations.

Babik, citing statistics that show increased future energy demands globally, spoke about the GM Volt, due out by the end of next year, which will get 40 miles on a charge from a 120 or 240 volt outlet and can use E85 gasoline for backup. GM is working to accelerate electric vehicle use by collaborating with the Electric Power Research Institute and utilities, including CPS Energy, to provide the infrastructure needed.

personnel at nuclear plants are among the reasons nuclear is expensive compared to other modalities. High grade uranium ore is becoming increasingly scarce, with lower grade ore more expensive and more energy-intensive to refine, which may increase operating costs, as may decommissioning and waste disposal costs, which may or may not be borne by the federal government.

Cost figures given before 2012, when licensing is decided, are largely moot. Cost overruns that may occur after construction begins may have to be borne by owners, despite fixed-price contracts, if the contractor refuses to shoulder them.

Both the CPS Board of Trustees and the San Antonio City Council have expressed the wish that the CPS share be reduced from 50% to 20-25%, but despite a long search, other partners have not come forward. The likelihood some will is not great, given the extraordinary costs for nuclear and the uncertainty of need for it in the ten years it takes to bring a nuclear plant on line.

CPS has indicated that if the nuclear option is eliminated, CPS has five years before it will need to look into other electricity sources. During that time, solar

and wind will have reached a level of maturity and cost parity that are becoming increasingly evident. Geothermal is already a mature modality whose costs are low. According to a recent New York University study, "Geothermal is the cheapest source of alternative electricity and shows the fastest improvement per dollar invested" (Emma Ritch, CleanTech.com, 8-25-09). The kind of geothermal that is eminently suitable for South Texas is dry hot rock geothermal. The report indicated that "The U.S. has enough hot dry rock resources to serve as the primary energy source for 30,000 years" (ibid).

CPS has been criticized for underestimating the costs for nuclear while overstating those for efficiency and renewables. The CPS projected cost for efficiency is \$1102/kW of energy saved. The Texas average cost for efficiency is \$200-\$400/kW, and CPS's own experience indicates a cost of \$276/kW (when CPS spent \$11.5 million to save 40 MW of energy). CPS figures for solar and geothermal are likewise higher than recent investment has shown them to be elsewhere.

## FEB 15-19: Mesa de Anguila, Marfa, Guadalupe Peak

This will be an extreme event for those who want to push themselves to the limit. The rewards promise to be spectacular. Expect to spend one night up on the Mesa. The Mesa de Anguila extends and becomes the Northern Rim of Santa Elena Canyon. There are numerous options, including, but not limited to, hiking southeast cross-country to the rarely visited Rim of Santa Elena Canyon as well as a cross-Mesa route past five tinajas down Bruja Canyon and out the other (eastern) side. Then it's off to Guadalupe Mountains National Park to summit Guadalupe Peak (at 8749 ft the highest point in Texas) as a dayhike, weather permitting. It's 8 1/2 miles round trip, 3000 ft of gain, and takes 6-8 hours. If weather doesn't cooperate, we'll do something different. Expect to hike through snow on the Guadalupe Peak hike.
