## **Master Naturalist**

Are you fascinated with the outdoors? When you see a strange insect, do you: A) jump on a chair and immediately look for a rolled up newspaper or B) run for your field guide (or Google) to identify it... and then tell everyone about the experience? If you answered B, then you might be an aspiring Texas Master Naturalist! Through the Texas Master Naturalist program, you will learn all about our amazing bio-region and have access to a wide variety of exciting volunteer opportunities. And you will meet many interesting people along the way. As applications are now being accepted for the program, Robin Sowton, our Conservation Chair, will provide a short but timely talk on how you can get involved. Robin joined the Texas Master Naturalist program in 2009.

#### The Dirt Doctor

Howard Garrett, the Dirt Doctor, will talk about the organic approach at our January meeting. Come and hear Howard's advice on soil, lawns, gardens, pests, etc., and let him answer your questions.

Howard Garrett is a landscape architect by training, with extensive experience in landscape contracting, greenhouse growing, golf course planning and maintenance, and organic product development. Howard has devoted his life to establishing a leadership role in the natural organic marketplace. He provides advice on natural organic gardening, landscaping, pet health, pest control, and natural living.

He received his Bachelor of Science degree in Park Administration and Landscape Architecture from Texas Tech University in 1969. After a stint in the U.S. Marine Corps Reserve, Howard started his business career at

Club Corporation of America where he was a laborer and assistant golf course superintendent.

In 1985, the birth of Howard's daughter Logan was the turning point in his education into organic gardening, landscaping, farming and ranching. By 1988 he had committed his entire career to the research, education and promotion of organic products and practices. In addition to teaching organics to homeowners, he began the conversion of numerous commercial projects such as the Frito-Lay National Headquarters in Plano. His work also includes research on natural organic planting techniques, use of native and well adapted introductions, and water saving solutions. Organic projects in the studies have realized 40-50% cost savings in water use.

# JAN 12 (WED) Dallas City Council Will Hear Public Comments on Gas Drilling

On Wednesday, January 12th the City of Dallas will convene a city council meeting that should be of interest to everyone who lives in Dallas. Beginning a 1 p.m. that afternoon, a decision will be made as to approve or not approve an application for the first of many gas wells proposed within the city limits of Dallas on city owned land. Even though this pad site is for as many as 14 gas wells, hints have been slowly leaking out over the past few months that there are other sites on the same land parcel that XTO would like to explore.

Comments should be ready to be delivered in a 3 minute format. If you want to bring friends to speak or to warm seats, by all means please do so. The city council has not heard from the public before so please do not hold anything back. Please talk in facts, if you have handouts, have enough for all (16). It does not matter if you do not live in the affected neighborhood. The more citizens we have from all over Dallas, the better. This is about the Dallas environment, and not Oak Cliff or

Southwest Dallas.

## JAN 14 (FRI) Important EPA Hearing 10:00 AM - 7:00 PM

On Friday, January 14, there is an EPA hearing by which to comment on the proposed State Implementation Plan ("SIP") call and Federal Implementation Plan ("FIP") rule which EPA has called for to ensure that Texas takes greenhouse gases/CO2 into account into industry permitting.

As you may have heard, Gov. Rick Perry and other Texas state officials have been grandstanding against the EPA's authority on everything from regulating greenhouse gases to the taking of TCEQ's air authority on its lax permitting on coal plants. The state is resisting the regulation of carbon dioxide, a big polluting factor with coal-fired power plants, cement kilns, and other large polluting facilities. New facilities, and facilities conducting major modification and construction projects, are now required to use the "best available control technology" to limit their emissions, and to obtain permits containing these limitations before they begin construction. These industry preconstruction permits must contain greenhouse gas limits beginning January 2, 2011, which Gov. Perry and Texas regulators are resisting.

Come show your support for the EPA rule, voice your support for clean air and tell the Governor not to play politics with your community's health. Email/or call the EPA now for this hearing to reserve your spot:

**Recent Recycling News - January 2011** 

Top Four Items to Recycle This Season

#### 1. Live Christmas Trees

TreTrees are biodegradable! Most municipalities offer free tree recycling at drop-off sites. Cities include Dallas, Lewisville, Farmers Branch and Grand Prairie.

Dallas tells you to bring your Christmas Tree to one of the Christmas Tree recycling locations from until January 11, 2008 between the hours of 9 a.m. and 4 p.m. (Remove all tinsel, ornaments, lights, nails and tree stands before dropping off the tree for recycling)

Dallas Christmas Tree Recycling Locations Northwest (Bachman) Transfer Station 9500 Harry Hines Blvd. (Monday – Sunday)

Southwest (Oak Cliff)Transfer Station 4610 S. Westmoreland Road (Monday – Sunday)

McCommas Bluff Landfill 5100 Youngblood Rd. (Monday – Saturday)

Fair Oaks Transfer Station 7677 Fair Oaks Ave. (Monday – Sunday)

Flag Pole Hill Buckner Blvd. at Northwest Hwy. (Monday – Sunday)

Lewisville offers free tree recycling through Jan. 15. Trees can be dropped off at Lake Park and North Mill Street near the soccer fields. Free mulch will be available starting Dec. 30. 972-538-5949.

Farmers Branch residents may recycle Christmas trees through Jan. 8 at the parking lot of Oran Good Park, Tom Field Road and Valley View Lane. Residents who want their trees turned into mulch can take them there from noon to 4 p.m. Sunday or 9 a.m. to 4 p.m. Jan. 8. 972-919-2597.

Grand Prairie - Christmas tree recycling will start today and run through Jan. 14. Trees can be dropped off at The Home Depot parking lots at 3850 S. Carrier Parkway or 5280 State Highway

360; or the Grand Prairie Landfill, 1102 MacArthur Blvd. Trees also may be left curbside on normal garbage collection day. 972-237-8061.

#### 2. Used Electronics

Got new electronic goodies for Christmas? Don't throw away those old model phones, gaming systems, or hardware. Recycle or donate them. Options include trade-in websites, office supply or electronics stores, and Goodwill collection centers.

# 3. Packing Materials

DonDon't forget the cardboard gift boxes, shipping boxes and other packing materials! Recycle along with other paper goods. Got Styrofoam peanuts? Take back to shipping stores to be reused.

#### 4. Holiday Light

There's a movement afoot to replace old incandescent holiday lights with LEDs. Some retailers are offering a trade-in program to upgrade to LED lights. HolidayLEDS.com will accept your broken or nonworking lights and give you credit toward your next purchase of LED lights.

#### What Not To Recycle!

ThrThree items create big problems at the recycling sorting center: Styrofoam, plastic bags (they get caught up in the whirling blades) and wire coat hangers. As a previous edition of Recycling Round-Up pointed out, the cost of wire hangers has gone up tremendously in the pasty 18 months. Many dry cleaners/laundries will take back wire hangers and provide a container to collect them.
