Wingert, conservationist and Dickinson College biologist, will give a short introduction to river ecology and the day's adventure ahead. We'll work on cleaning the river from Marysville to West Fairview focusing on the islands along the way. We'll get to West Fairview between noon and 1 p.m., where we'll have lunch



and drinks provided by the Sierra Club. Gene will then give a 20-minute presentation focusing on the river and its challenges with questions welcomed. # Stop Corbett's Plan To Drill Our Parks and Forests



People who love our beautiful state parks and forests are alarmed by **Governor Corbett's** plan to open these public lands up for gas drilling. In February, Corbett announced his goal to raise \$75 million from a new round of gas leasing as a way to balance his state budget. The gas drillers already have the right to drill in 700,000 acres of our state forests. To make matters worse. Corbett wants to open up state parks to gas drilling for the first time in history

Drilling causes air, water and noise pollution. It destroys important wildlife habitat. Drilling

interferes with all other uses of our public lands, including hiking, bird watching, fishing, hunting and simple peaceful enjoyment.

The state parks and forests are managed by DCNR. DCNR is accepting private bids from drilling companies, and efforts to learn what parks and forests are under consideration have been blocked by the Corbett administration. In response, Rep. Greg Vitali has filed a Right to Know request with DCNR to force disclosure of what public lands are threatened by Corbett's plan.

#### Brunner Island Coal Power Plant adds to Smog

York County is home to the Brunner Island power plant, which is the 6<sup>th</sup> largest coal power plant in the state. It is also the only remaining large coal power plant that has <u>not installed</u> a common control for smog-causing pollution known as Selective Catalytic Reduction or SCR. This technology is like a much bigger version of the catalytic converter on your car, and can reduce smog-forming pollution by 80-90 percent. Without SCR, Brunner Island is contributing unnecessarily to the air quality woes not only of York County, but of Lancaster and Philadelphia, which have their own serious smog problems. DEP is aware that Brunner Island is out of compliance. To add to the problem, DEP is proposing that the operator of Brunner Island, PP&L, average emissions over its fleet of coal plants to comply with the already weak standard. That means that even if the overall pollution limits were lowered, PP&L could comply by slashing
