Proof of that can be found in research from the Wisconsin Public Service Commission.

Every two years the PSC publishes a Strategic Energy Assessment to evaluate the current and future electricity supply. The PSC just released this year's draft, which shows that Wisconsin's electricity generation capacity in 2021 and 2022 consistently had the ability to make more electricity than would be needed to power our state, even under extreme conditions like prolonged heat waves.

So why have many media outlets run stories questioning the reliability of Wisconsin's electric grid? These stories are inaccurately representing a different recent report showing that the Midcontinent Independent System Operator (MISO) could face peak capacity shortfalls beginning this summer in its northern and central U.S. regions.

It's true that one or two zones within its footprint have generation reserve margins at or below MISO's liking, but those zones lie

Notes from the Chair

The work of environmental activists can seem thankless and daunting at times, especially in the face of recent setbacks. Among those are the U.S. Supreme Court's ruling prohibiting the Environmental Protection Agency from regulating greenhouse gas emissions from power plants; the state Supreme Court's decision to deny standing to Friends of the Black River Forest, a group that has long been fighting to protect Kohler-Andrae State Park from development; and the announcements by Alliant Energy and We Energies of plans to delay the retirement of coal plants in the state.

Rather than being crushed by these events, it's more important than ever to band together and work to create the future we want to see.

Many opportunities exist to join forces with fellow Sierra Club volunteers in activism and fellowship. Our monthly programs return in September with chances to learn about sustainability efforts at the Indian Community School in Franklin and efforts to protect Cedar Gorge Clay Bluffs in Ozaukee County. Our popular outings started up again in May and continue into the fall with hikes and more at area parks. The energy burden work group is trying to ensure that the state's Focus on Energy program addresses the needs of predominantly Black and Latinx Milwaukee residents who spend a disproportionate amount of their incomes on electricity and gas bills.

Among many other things, Nearby Nature works to restore and protect Lincoln Creek to make it an inviting space for neighbors to gather. And our friends at the Wisconsin Chapter host a volunteer night via Zoom on the second Wednesday of every month to work on things like letters to the editor, data entry, social media posts and graphic design.

Even in the midst of gloomy news, there are myriad ways we can join forces to enjoy and protect our planet. Reach out to anyone on the Great Waters Group Volunteer Leadership Council to help build a sustainable future.

well south of Wisconsin. In short, there is no reliability crisis in Wisconsin today. And there won't be in 2023, with 500 MW of solar and wind generation coming online by next July.

This narrative shift opened the door for utilities to announce delays to coal plant retirements as if they were for the public good. In June, WEC Energy Group and Alliant Energy announced they will delay the retirement of three of Wisconsin's largest coal plants, the South Oak Creek plant near Racine, Columbia in Portage and Edgewater in Sheboygan County, by 12 to 18 months.

To quote Michael Vickerman of RENEW Wisconsin, "This announcement underscores the risks involved in putting all of our clean energy eggs in the utilities' basket." Though utility-scale wind and solar are a necessary component of the clean energy transition, without regulatory and legal requirements, utilities can back out of their promises to meet Wisconsin's ambitious greenhouse gas emissions reduction goals.

Wisconsinites deserve lawmakers who take emissions reduction legislation seriously. We deserve utilities that keep their promises to make changes supporting health and safety. We deserve investments in energy-efficiency measures that keep electricity prices low, especially for low-income households. We will continue to fight for that future for our state.

Print newsletter will continue

Thanks to everyone who responded to our recent survey about the Great Waters Group's printed newsletter. Not surprisingly, the people who answered by mail preferred keeping a print newsletter, whereas the majority of those who filled out the online survey preferred moving to an online newsletter.

Of the 25 total who responded, about half would prefer an online newsletter instead of the quarterly printed newsletter.

We aren't making any changes in the near future: Most respondents said they read almost all the issues and said they use the printed newsletter more to get information about upcoming programs. At this point, an opt-in online newsletter wouldn't necessarily save money or our volunteers' time. We will try other options to conserve money, paper and time, including reducing the number of pages to four.

In addition, we don't have email addresses for all members, and more than half of respondents said they don't receive the monthly E-letter.

Cedar Gorge Clay Bluffs update

The Ozaukee County Planning & Parks Department, in partnership with Ozaukee Washington Land Trust, has been raising funds for years to buy undisturbed Lake Michigan shoreline and natural areas known as the Cedar Gorge Clay Bluffs. However, the project hit a snag when an anonymous objection blocked Knowles-Nelson Stewardship funds. Director of Planning and Parks Andrew Struck will give an update on this preservation project as well as his 1,000mile (Bicycle) Ride for Lake Michigan to raise funds for this and two other projects.
