Cedar Gorge Clay Bluffs threatened

Sierra Club members who were looking forward to hiking at the Cedar Gorge Clay Bluffs were dealt a setback this spring when an anonymous member of the Wisconsin Legislature's Joint Committee on Finance raised an objection to \$2.3 million in funding to the Ozaukee Washington Land Trust.

OWLT has been engaged in a 10-year effort to preserve the area, which provides unique lake bluff and migratory habitat on Lake Michigan. The group then expressed willingness to accept a smaller, \$1.6 million grant from the state even though the DNR had already signed off on the higher amount.

But Joint Finance refused to move ahead before the session ended

in March. Conservative legislators on the committee feigned surprise when a buyer appeared who wants the bluffs for a profit-making venture. The anonymous buyer issued public comments on why they should become the owner of the bluffs and promised to be "sensitive" to the environmental importance of the area.

OWLT's preservation effort was to be funded using Knowles-Nelson Stewardship Fund dollars, money that has been set aside for conservation purposes. Conservative lawmakers have been pushing back against the popular program in recent years.

Notes from the Chair -

This year marks the quadrennial review of Focus on Energy, a statewide program that provides rebates to businesses and homeowners that make energy efficiency upgrades to their properties. The Public Service Commission, which conducts the review, is accepting comments and will implement changes to the program based on what it hears from constituents.

The Great Waters Group is using this review as an opportunity to raise awareness about energy-burdened Milwaukee neighborhoods and to ask the PSC to shift the aims of Focus on Energy to address the needs of those who have to spend a high percentage of their incomes on energy bills.

In March GWG members delivered fliers door-to-door in high energy-burden Milwaukee neighborhoods and did extensive phone banking urging residents to submit comments to the PSC. Thanks to these efforts, 323 comments were submitted, 27 of them from high energy-burden ZIP codes. Some of the comments include:

"In my area we are paying too much for utilities. It's hard

deciding to pay my rent or light bill or eat healthy all month."

"I'm handicapped and low income. Yes, I agree that my energy bill has gotten overwhelming, and I can use extra help."

"My neighborhood has many residents who have housing instability – utility costs are part of that! People are passionate about sustainability, but they need the financial barriers to sustainability overcome. This can also be a step towards updating many of the duplexes' utilities in my neighborhood in a way that can prevent future house fires and other safety issues."

Because of comments like these, the PSC is considering implementing a Focus pilot project in a high energy burden neighborhood. There will be more opportunities to submit comments later. If you are interested in helping with canvassing or phone banking in May or August, please contact me or Linda Frank.

Thanks for all you do to preserve and protect our environment.

That proposed expansion plan is also a giant step backward in protecting our planet's climate. It is time to move decisively away from fossil fuels, not to build new infrastructure to transport them.

Key point: DNR's environmental impact statement (EIS) on the Line 5 proposal is seriously inadequate. Left unchallenged, that EIS would weaken protections for our waters, our community health and our planet's health.

Insist that officials follow the clean government procedures that protect clean water.
