## Valley Oak Planting at Anderson Marsh

Anderson Marsh Interpretive Association mitigation fund. Funding a replanting project on (AMIA) is partnering with the City of Clearlake and California State Parks to plant 100 native Valley Oaks at Anderson Marsh State Historic Park (AMSHP). The project, which will begin in the fall of 2022, is funded by fees paid to the City of Clearlake under its Native Tree Protection Ordinance, which requires developers who cut down native oak trees to either replant trees of the same species or pay a fee to fund replanting by the city.

This project had its genesis in a conversation between Lake Group Chair Deb Sally and Clearlake City Manager Alan Flora, who mentioned that the city had accumulated quite a few thousand dollars in its oak

city-owned land was one possibility, and doing so at Anderson Marsh—part of which is inside the city limits, and all of which is an important recreational resource for Clearlake residents—was another.

"AMIA was approached by the City of Clearlake about partnering with the City and State Parks to plant Valley Oaks at Anderson Marsh State Historic Park," stated board member Henry Bornstein. "We contacted State Parks, which agreed to do the initial planting, with AMIA agreeing to do the follow-up watering, weeding and maintenance necessary to help the trees survive."

## Molok Luyuk Gets Senate Hearing

On June 8 Senator Alex Padilla testified before the Senate Committee on Energy and Natural Resources Subcommittee on Public Lands, Forests, and Mining of on behalf of his Berryessa Snow Mountain National Monument Expansion Act, S4080; the bill is a companion to HR6366, sponsored by Congressman John Garamendi.

This hearing was an important step towards the permanent protection of nearly 4000 special Lake County acres commonly known as Walker Ridge "The sacred lands within and around the Berryessa Snow Mountain National Monument are central to thousands of years of tribal origin stories," said Senator Padilla. "This bill would expand the existing Monument to include nearly 4,000 acres of sacred Tribal land, require federal agencies to finally develop a management plan for the monument, and give Tribal governments a seat at the table to better manage and care for these lands. It is our duty to protect the abundant natural resources and the rich history on Molok Luyuk for today's children and for future generations, and I look forward to working to ensure we see this bill to fruition."

BLM Deputy Director of Policy and Programs Nada Culver also spoke in favor of the legislation, which is co-sponsored by Senator Dianne Feinstein.

This Senate hearing was an essential next step in the pathway to votes in both Houses and passage of the legislation—an event that the Molok Luyuk coalition is hoping will take place before the end of the year.

# Let's Stop PG&E's War on Trees

Pacific Gas and Electric's antiquated, poorly maintained power lines have caused major wildfires throughout its territory, including the 2018 Camp Fire, the most destructive in California's history.

Instead of upgrading its lines with modern equipment that will automatically shut down when broken, the utility has implemented an "Enhanced Vegetation Management" plan with the objective of cutting down 1 million trees a year within or adjacent to its right of way. These actions destroy habitat, exacerbate climate change, and conflict with 30x30 goals, all while increasing wildfire risk rather than reducing it. The EVM program has outraged residents throughout PG&E's service area, whose trees are being destroyed without their consent and sometimes over their strenuous objections.

Desperate people are looking to the Sierra Club for leadership as they attempt to confront a monopolistic corporation. Redwood Chapter is now trying to pull together all five affected Sierra Club Chapters and partner organizations throughout the region to force PG&E to abandon this program, either voluntarily or by regulatory compulsion.

We need your help.
