Next Community Forum: Botanical Wonders of Walker Ridge

Lake Group's next community meeting will be held virtually at 6:00 PM on Thursday September 30. We are looking forward to welcoming California Native Plant Society Conservation Program Director Dr. Nicholas Jensen, who will give us an in-depth look at one of Lake County's very special places. Walker Ridge, located just north of Highway 20 on the Colusa county line, is a marvel of biological diversity, intriguing geology, and recreational opportunities, but despite its outstanding characteristics it was left just outside the boundaries when the Berryessa Snow Mountain National Monument was created in 2015. Congressman John Garamendi is now proposing legislation to rectify that omission, and to require the BLM and Forest Service to prepare a comprehensive management plan for the Monument. 

A Closer Look at Walker Ridge



Lake County has so many special places we sometimes tend almost to take them for granted.

One of those special places is Walker Ridge. This remarkable landscape, administered by the BLM, is located on the border Lake between and Colusa Counties just north of Highway 20. complex Its geology supports SO many rare serpentine-dependent plants that the entire region has been

proposed for designation as an Area of Critical Environmental Concern. Many other habitats, ranging from ancient oak woodlands to flower-strewn meadows, support outstanding biological diversity. Breathtakingly beautiful and still wild, this is the kind of country where rugged outcrops jut from grassy swales carpeted by spring wildflowers, where black bears and mountain lions roam, where both bald and golden eagles soar overhead. It also supports a greater variety of dragonflies and damselflies than anywhere else in California, and the views are to die for. Numerous natural springs, carbonated, salty, and freshwater, pour from the hillsides, even during times of drought, providing refuge for the animals that live here and cool water for visitors.

The area has been important to several local tribes for thousands of years as a spiritual and cultural center—and is still important. It also provides a wealth of recreational opportunities for hikers, mountain bikers, OHV users, equestrians, hang gliders, rockhounds, and others.

So it is a bit surprising that such an outstanding place was left out when the Berryessa Snow Mountain National Monument was designated in 2015.

Now Congressman John Garamendi proposes to rectify this omission by sponsoring legislation to expand the Monument to include nearly 4000 acres in the Lake County portion of Walker Ridge. The Sierra Club applauds the Congressman's leadership, and hopes that his vision will become legislative reality before this session of Congress comes to an end.
