Next Meeting: Greg Giusti on Forest Health

The next Lake Group general meeting will take place at **6:00 PM on Wednesday November 13**, in the Round Room at the Mendocino College Lake Center, 2565 Parallel Dr in Lakeport. Emeritus University of California Community Extension Advisor Greg Giusti will give a presentation on forest management from a fire recovery and resiliency point of view. We'll be discussing subjects such as how to determine when to replant burned areas and when to let natural regeneration take its course, best practices for avoiding introduction of invasive species, and whether it's better to attempt to restore the plants that existed in an area before a devastating wildfire, or to shift to those that may be better adapted to a warmer, drier climate. Please bring your questions—Greg has answers. As always the meeting is free and the public very cordially invited.

Walker Ridge Update

As previously mentioned, earlier this year Lake Group learned that a project to construct a wind generation facility on BLM land at Walker Ridge just north of Highway 20 was once more under active consideration. Three previous proposals of this sort have been abandoned by their developers, most recently in 2013.

Although the Sierra Club supports renewable energy projects in concept, it also recognizes that they may have unacceptable effects on wildlife, air and water quality, and other resources. On Walker Ridge the risk of contaminating two watersheds with asbestos and mercury seems high, impacts to biological resources including birds, bats, and butterflies may be severe, and rare endemic plants could be at risk. There are other concerns as well, including impacts to Double Eagle and Spring Valley neighbors, visual blight from Mount Konocti to the Sutter Buttes, and violation of nationwide

restrictions on allowable uses of acreage purchased with Land and Water Conservation Fund appropriations.

Lake Group representatives attended a scoping workshop on the reincarnated project in July, and signed on to detailed scoping comments submitted by Tuleyome to the BLM in collaboration with several other environmental organizations. Those (con't)

(Walker Ridge, con't.) comments suggested that even though the identified project site was entirely on federal land and therefore subject to review under the National Environmental Quality Act (NEPA), impacts to neighbors and to adjacent private lands meant that evaluation under CEQA was also advisable.

We have now received a request from the county to submit additional comments as part of a supplementary CEQA process. Although it is unclear just where the county's jurisdiction lies, this additional opportunity for input is welcome, though limited by an extraordinary narrow window for comment submissions—a bare two weeks!—and lack of public involvement. Aside from reiterating a number of environmental concerns, Lake Group's letter recommended that the request for review be recirculated with at least a 45 day comment deadline, and that the county conduct at least one public scoping meeting to give neighbors and others a chance to weigh in.
