The Sierra Club Loma Prieta Chapter and our partners have been working behind the scenes for several months to bring a request for clean energy action to the Santa Clara County Board of Supervisors. Therefore we would like to use this opportunity to share our requests with the Board, so you can give fair consideration to this larger program idea, along with the fracking moratorium you will consider.

We developed the attached letter to the Board and have been gathering additional signatories. Our letter suggests a General Plan amendment similar to what was passed in Santa Cruz County.
