RE: SCCOE Partnership with BOS to Support Comprehensive Environmental Literacy and Education

Dear Board Members of the Santa Clara County Office of Education,

The Sierra Club Loma Prieta Chapter encourages the Office of Education to take swift action to formalize a partnership with the Board of Supervisors to develop comprehensive environmental literacy and education programs, with opportunities for students to get involved. The urgency of the climate crisis requires us to act quickly, and an informed public is critical to the County's success in climate action.

On October 5<sup>th</sup>, the Board of Supervisors unanimously approved a referral to Administration and County Counsel to report to the Board with options for consideration to establish a Santa Clara County Sustainability Commission. The referral passed with a motion stating that the Board of Supervisors should partner with the County Office of Education to support comprehensive environmental literacy and education.

Details of the motion for your review:

The following motion was made by Supervisor Chavez (as written in the meeting minutes): "At the request of Supervisor Chavez, the Board directed Administration to provide an off-agenda report to the Board on date uncertain relating to an analysis of the impact of the Commission on existing staff workloads in the Office of Sustainability; and, to partner with the Santa Clara County Office of Education relating to the formation of the Commission."

The specifics of Chavez's suggested partnership with the Santa Clara County Office of Education can be found in the meeting video, in which she stated "the idea that the students raised about the partnership with the Santa Clara County Office of Education" within her motion.
