<u>Maryland Sierra Club – 2019 General Assembly Session</u> <u>Report on Testimony Submitted</u>

In the 2019 session of the Maryland General Assembly, the Maryland Sierra Club again was a strong, active, and committed voice for the environment, lobbying our state's elected representatives to enact new significant measures to fight climate change, strengthen protections for Maryland's environment, and better protect the health of Maryland residents.

<u>Sierra Club priorities</u>: This session, the Sierra Club had four priorities: ban single-use foam food containers; take significant strides to increase our state's use of clean energy, at the same time benefiting workers and the economy (the Clean Energy Jobs Act, and a companion bill to provide for long-term clean energy contracts); protect the state from the environmental dangers presented by Governor Hogan's plan to expand the Capital Beltway in Maryland and I-270; and ensure that the state undertakes full and complete environmental reviews under the federal Clean Water Act of any new, proposed fracked-gas pipelines. *The foam ban and the Clean Energy Jobs Act passed, and Governor Hogan allowed both to become law without his signature.* The other priority bills did not pass.

<u>Overall Sierra Club testimony</u>: The Sierra Club submitted written testimony on 75 bills (priority and non-priority). We testified in support of, or in support of with specified amendments, 70 bills; nearly half (31) passed, an outstanding accomplishment. As to these 31, 27 have been signed by the Governor or have become law without his signature, one was vetoed during the legislative session and the veto was overridden, and three were vetoed after the session concluded (these vetoes may be overridden when the General Assembly reconvenes, probably in January 2020). We testified in opposition to five bills; none passed but one was amended into another bill that passed and has become law.

Non-priority bills: Our testimony on non-priority bills, by subject matter, may be summarized as follows.

- Cross-cutting environmental issues: Support, or support with amendments 4, of which 0 passed. Opposed 0.
- Energy: Support, or support with amendments 7, of which 3 passed and have become law. Opposed 3 bills, of which 1 was amended into another bill that passed and has become law.
- Land, water, and natural resources: Support, or support with amendments 12, of which 9 passed; 8 have become law (1 through a veto override) and 1 was vetoed after session. Opposed 1 bill, which did not pass.
- Public health: Support, or support with amendments 10, of which 5 passed and have become law. Opposed 0.
- Transportation: Support, or support with amendments 23, of which 9 passed and have become law and 1 was vetoed after session. Opposed 1, which did not pass.

- Zero waste: Support, or support with amendments 5, of which 1 passed and has become law. Opposed 0.
- Other public policy issues: Support, or support with amendments 2, of which 1 passed and was vetoed after session. Opposed 0.
