New Years Resolution: #ActOnClimate in 2020!

The New Year is an opportunity to reflect on where we have been and where want to go. Let's build on the momentum of the Green New Deal and the youth climate strikes to

Because of the way the MA state legislature works, we only have until July 31st to pass new state laws. Sierra Club and Mass Power Forward asks, as one of our resolutions for 2020, to consider the following:

- I resolve to be active for environmental justice. When our state allows any community to be over-polluted, then we allow for that possibility in any community. Right now, communities of color and poor communities bear the brunt of pollution in Massachusetts.
- I resolve to be active for 100% renewable energy for all. We know what we need, and we need it now.
- I resolve to be active for equitable investment of any funds. As our world considers taxing carbon, I reflect that we cannot punish low-income people with a flat regressive tax.

Hundreds of Youth Flood the Statehouse

On December 6th, hundreds of youth activists flooded the Statehouse to demand climate action from Governor Baker and Speaker DeLeo. The action started with a rally at Copley Square and march to the Statehouse, organized by Massachusetts Climate Strike. This transitioned into a rally inside the statehouse and sit-in in Governor Baker's office, where 27 individuals with the Sunrise Movement were arrested following the 5:00pm closure of the Statehouse. The Sierra Club commends these youth organizers for their leadership in calling upon Governor Baker and Speaker DeLeo to take action to pass Mass Power Forward legislation and to stop the Weymouth Compressor Station.

Beyond Fossil Fuels

Brookline Leads the Way With Gas Ban

Last month the Town of Brookline <u>approved a bylaw</u> banning the use of oil and gas heating for all new construction projects beginning in 2021. Developers have a full range of new technology available, ensuring that the cost of heating a home will remain similar to the use of oil and gas heat. Additionally, increasing wind and solar energy available to the grid will ensure that clean, carbon-free energy will be affordable and will continue to reduce greenhouse gas emissions over time. Kudos to the Town for their local leadership, which paves the way for more communities in Massachusetts to follow suit. Already, Newton and Cambridge have begun the process of drafting similar ordinances.

Telling the Stories - Health Impacts in the Fore River Basin

This short film tells the stories of people who have been impacted by air pollution in the Fore River Basin, a community that has been overrun by toxins. The Fore River Basin is located on the South Shore in MA and is home to ten different toxic facilities, including a power plant, diesel tanks, and a sewage treatment plant. Air quality testing has shown levels of carcinogens, including benzene and formaldehyde, that are above state quidelines. Despite this data, the state



approved key permits for yet another toxic facility, the Weymouth compressor station. Community members are still actively fighting that proposal. You can learn more about their fight here: nocompressor.com.



The preliminary International Code Council (ICC) voting results are in: Together, we've achieved a huge victory for building energy efficiency!. The new 2021 International Energy Conservation Code (IECC) is a huge gain for both commercial and residential efficiency and a big step forward for putting our nation's model energy code on a glide path to net zero buildings. Our coordinated efforts with allies Mass Climate Action Network (MCAN) and Metropolitan Area Planning Council (MAPC) paid off because so many town officials who care about building efficiency across the state took action, registered and voted. Protecting our Planet

MassDEP Action on PFAS

The Baker-Polito Administration and the Department of Environmental Protection (MassDEP) have filed two rules with the Secretary of State related to PFAS: a *final* soil and groundwater cleanup rule and a *draft* drinking water rule. The draft drinking water standard would establish a Maximum Contaminant Level (MCL) for drinking water of the sum of 20 ppt for six PFAS compounds. The proposed standards cover a larger subgroup of compounds than any other state and provide a greater degree of protection, particularly for sensitive subgroups including pregnant women, nursing mothers, and infants. MassDEP will be hosting five public hearings on the draft standards and comments will be accepted through February 28, 2020. The dates and locations of the meetings are below:
