Take Action for Climate Legislation!

Today, the Massachusetts House of Representatives released their version of the MA Senate's Next Generation Climate bill that passed earlier this year. However, this bill is significantly different from the original Senate version. This new bill, H.4912, most closely resembles Rep. Meschino's roadmap bill, but there are some substantial changes worth noting. This bill is a step in the right direction, but there are also significant pieces missing.

That's why we're asking you to contact your State Representative TODAY! Please ask your legislators to:

- Pass environmental justice protections for historically marginalized and impacted populations in Massachusetts,
- Allow a rapid statewide transition to 100% renewable energy and renewable electricity,
- Accelerate the timeline to reduce our states' emissions,
- And build more infrastructure for electric vehicles.

The House is scheduled to vote by midday on July 30, so time is of the essence.

BIG NEWS FOR BOSTON 🚱 🔌 🎉

After a multi-year process beginning with authorization by the Boston City Council in 2017, the City of Boston's <u>Community Choice Electricity plan</u> has finally been approved by the state's Department of Public Utilities, enabling the City to begin implementation. This program will allow the City to purchase electricity on behalf of all residents and businesses, and leverage its purchasing power to provide affordable renewable electricity, moving us closer to becoming a Carbon-Free Boston!

<u>Research on other programs across the Commonwealth</u> has proven this to be a cost-effective way for municipalities to reduce carbon emissions while increasing demand for renewable energy, and stabilizing consumer rates. This is a victory to be shared amongst many advocates, stakeholders, and members of the public who have participated in the process, with much credit to our partners at Boston Climate Action Network and the Green Justice Coalition who organized a strong campaign to achieve this critical win for the climate and our community. The Massachusetts Sierra Club is excited to continue working with the City of Boston to see through an equitable implementation of the program that: reduces carbon emissions, prioritizes new and local renewable energy projects, provides affordable and stable electric rates, delivers benefits and economic opportunities to

environmental justice communities, and strengthens community protection around electricity supply.

After three-year grassroots campaign, citizen petitioners convince Cape Cod Commission to include greenhouse gas reduction goal in Cape Cod Regional Policy Plan

On Wednesday July 23rd, the Cape Cod Commission voted to develop <u>amendments to the Cape</u> <u>Cod Regional Policy Plan</u> (RPP) that will integrate a new greenhouse gas emission reduction goal for use in managing and regulating future growth and development across the 15 communities comprising Barnstable County.

The Commission's vote occurred during a hearing sparked by a citizens' petition signed by more than 300 Cape Cod voters. The petition, which included 11 amendments, was filed on April 1, 2019, after more than a year of grassroots advocacy designed to sharpen the RPP's focus on climate mitigation consistent with the state's Global Warming Solutions Act. Typically amended every five years, the RPP enacted in 2019 is now on schedule for a 2021 update.

Keith Lewison, chair of Sierra Club Cape Cod Group, said, "The Commission's vote is a victory for every Cape Codder concerned we are not doing enough to cut our greenhouse gas emissions and address our climate emergency. Convincing the Commission to amend the RPP at an accelerated pace through a first-of-a-kind petition process demonstrates the power of grassroots action."

Rosemary Dreger Carey, an organizer with 350 Cape Cod, added, "After hundreds of activists testified at multiple public hearings, submitted written public comments, and attended demonstrations, we are seeing tangible progress. It is clear that the Commissioners are listening to constituents when they call for the changes we need to face the existential threat of climate change. The vote yesterday shows the Commission's embrace of leadership on climate while serving all of its stakeholders."

Transportation Matters

MA Commits to Electrification of Medium and Heavy Duty Trucks

Massachusetts joined 14 other states and the District of Columbia released in a joint commitment to truck electrification and eliminating toxic air pollution from medium and heavy-duty trucks and buses by 2050. The new MOU calls for 30 percent of new truck and bus sales to be zero-emission by 2030, and 100 percent zero-emission by 2050. Massachusetts Voting Options for September 1 Primary

In Massachusetts, most state elections are determined in the State Primary on September 1st, not the November General Election. At the crossroads of multiple crises, **your vote is more important than ever this year**. Cast a vote for our health, our communities, and our planet.

There are three ways to vote this year in the Massachusetts State Primary:

- Vote by absentee ballot/by mail. Ballots must be received by your city/town by Sept 1 at 8pm.
- Vote early at your municipal office (Aug 22-28)
- Vote at your polling location on the Sept 1 Election Day

<u>The safest way to vote this year is by mail</u>. You no longer need a reason to request an absentee ballot (e.g. out of state or sick), so there's no reason not to take advantage of it. Just fill out <u>this application</u>. <u>Click here for more information about voting this year</u>.

Stand in Solidarity

Help Prevent a Tsunami of Evictions when the Eviction Moratorium Expires

Now is one of the most crucial moments of our lives to take action for housing justice. Everybody deserves stable housing — but a tsunami of evictions will push tens of thousands of families in Boston and across Massachusetts



out of their homes when our eviction moratorium expires. The moratorium is set to end on August 18th, and the Massachusetts legislature has a bill in their hands — the Guaranteed Housing Stability Act — that will prevent this eviction crisis if they pass it this legislative session.

Take action in the following three ways to help stop the flood of evictions:

- 1. <u>Call your Massachusetts legislators immediately</u>. Thank them if they're co-sponsoring the Guaranteed Housing Stability Act (HD.5166 / SD. 2992), and request that they ask House Speaker DeLeo and Senate President Spilka to schedule a vote on the bill before July 31st.
- 2. <u>Email your Massachusetts legislators too</u>. You can email your legislators with the click of a button (no need to open your email account).
- 3. <u>Record video testimony for social media</u>. Use this tool to tell the world why you took action to stop evictions and stabilize housing.


