Call Mayor Walsh TODAY about Suffolk Downs!



The Boston Planning and Development Agency (BPDA) is planning to vote on the Suffolk Downs development on September 24th, when the Planned Development Area document has only just been released. The proposal includes 7,000 units of luxury housing, commercial development, but only 13 percent income restricted housing on-site, the City of Boston's minimum requirement under

the Inclusionary Development Policy. That means 87 percent of housing units would be too expensive for any family earning less than \$80,000 per year and open space. There has not been time for local residents to digest this before BPDA to approve it, and local resident organizations are very against this approval.

We are asking you to take two actions for Suffolk Downs. First, please <u>call Mayor Walsh</u> and tell him that Suffolk Downs needs more affordable housing and net-zero carbon development. Second, please <u>register to attend the BPDA meeting</u> on Thursday, September 24th at 5:30pm, and to speak, simply to ask questions like: "How much carbon will this project release over the next thirty years?" or make a statement like: "The BPDA vote on this project must be delayed to give impacted residents a say and understanding of this massive proposal." Stop Dirty Fuels on National Forest Lands

On September 1st, the Trump administration published proposed revisions to its regulations governing Federal oil and gas resources on National Forest System lands. The rule change would undermine public participation and limit the environmental review to assess oil and gas development risks on these delicate landscapes. The move eliminates safeguards important to ensuring the Forest Service will properly assess oil and gas activities' impacts and inform its decisions to allow or prohibit them. This action continues the thread of reckless environmental rollback attempts during a public health crisis. Tell the Trump Administration that this rollback is terrible. Forests should be protected, not opened for oil and gas drilling! The comment period is open until November 2nd.

Tell Your State Legislators: Less Road, More Transit in Allston Mass Pike Project!

MassDOT is gearing up to replace the elevated Mass Pike viaduct in Allston. The section of this roadway between Boston University and the Charles River is nicknamed "the throat" because the Pike and Soldiers Field Road are squeezed into it, leaving minimal space for pedestrians, cyclists or parkland. The replacement of the Mass Pike viaduct in Allston will affect thousands of residents and commuters. Take action now by emailing your state legislator to urge MassDOT to do it right by reducing lanes for cars while boosting transit, walking, and cycling.

Opt-Out Of Toxic Mosquito Spraying In Massachusetts

Oregon Wildfires

A million acres have burned in Oregon. Across the state ten people were killed by the fires, and 40,000 people have evacuated from their homes. Many of them are still sleeping outside without any gear, in air so toxic it's breaking the sensors. Thousands of people have lost their homes, several towns have been burned to the ground. The governor says this will likely be the largest loss of life and property in the state's history. Rural, poor and working class communities, BIPOC, people with disabilities or chronic health conditions, farmworkers and people working outside, houseless people were hit the hardest. The need is **enormous** right now.
