Kansas City Sierra Club Members Demand Clean Air for All

"Clean air is important to me because we all breathe. Every single one of us in this room is breathing right now," stated Cymone Turner. Cymone is a student and Sierra Club member who attended the Missouri Air Conservation Commission (MACC) meeting in Kansas City on September 25. Activists turned in more than 250 petitions asking for the MACC to take action immediately on toxic Sulfur Dioxide (SO2) Air Pollution.

SO2 causes breathing problems in as few as five minutes, is particularly dangerous to older adults, children and asthmatics. Downtown Kansas City has been designated as a nonattainment area, an area having hazardously high levels of SO2 air pollution, by the Missouri Department of Natural Resources and the Environmental Protection Agency.

KC is already seeing the effects of SO2 pollution—Jackson County has one of the highest rates of asthmarelated

Emergency Room visits and hospitalizations in the state. However, some populations feel these effects more than others. The majority of people living in

the non-attainment area are people of color. Black and Hispanic populations experience shocking health disparities in our state, particularly asthma and heart disease which are associated with SO2 air pollution.

Cymone is right: We all deserve clean

Clean Power Plan Tackles Power Plant Carbon Pollution

In June, as part of the President's Climate Action Plan, the U.S. **Environmental Protection Agency** (EPA) proposed the first-ever carbon pollution standards for existing power plants, known as the Clean Power Plan (CPP), signaling an end to the era of power plants dumping unlimited amounts of carbon pollution into our atmosphere.

The standards create a strong framework for states as they move towards renewable energy and energy efficiency. States have been put in the driver's seat and allowed great flexibility to create plans to limit carbon pollution, and

local leadership is now more important than ever.

The CPP would reduce carbon pollution from power plants by 30% nationwide by 2030 and the target for reductions in Missouri would be 21%. EPA took public comment on the proposal through December 1 and will issue a final rule in June 2015. Missouri DNR will then have until June 2016, with possible extensions, to develop its own state plan.

Missouri is already well on its towards meeting its carbon reduction goal. In addition to phasing out the oldest and dirtiest power plants, Missouri is already taking climate action with a growing clean energy sector. EPA projects an increase in Missouri's use of clean energy to reduce reliance on highcarbon energy sources. Missouri is actually poised to exceed EPA's projection with smart investments in energy efficiency, wind, and solar.

Clean energy creates jobs right here in Missouri as well as saves ratepayer dollars. According to the Solar Foundation's 2013 Solar Job Census. Missouri is ranked 12th in the nation with 2,800 Missourians currently working in the solar field. In January 2014, Kansas City Power & Light announced its new investment in 400 MW of wind power would save its customers hundreds of millions of dollars

Building Codes: Rebuilding America's Future

Greenhouse gasses from human activities are the most significant driver of climate change. In the Midwest, heat waves are becoming more frequent and our winters are becoming milder – we know climate change is real and is already happening. The consequences of climate change affect our lives in very intimate ways including access to water, natural disaster and health problems.

This needs to stop. In the US, buildings account for 46.9% of greenhouse gas emissions. By adopting the current standard in energy efficiency building codes (IECC 2015), most communities in Missouri would see as much as a 40% increase in their energy efficiency—that is a significant reduction in greenhouse gasses!

Energy Efficiency profits our environment, our wallets and our health. When cities invest in energy efficiency, benefits include: the creation of local jobs, reducing energy costs for families and reducing health costs from respiratory disease such as asthma and allergies. We know Sierra Club members care about this issue. In Columbia and University City 43 members and supporters joined together and convinced local leaders to adopt the then current codes standard (IECC 2012). Among those standing up for our future were: Carolyn Amparan, Terry Ganey, Andrew Linhares, Herbert Tillema, Bob Elgin, Neville Rapp, Carolyn Pufault, Jessica Freiberger, Harry Alper and Janet Cuenca. Thank you for your dedication! Thanks to these Sierra Club members, Columbia adopted the 2012 IECC Codes in September of 2013 and University City adopted the 2012 IECC Codes in October of 2013.

Despite these successes, some Missouri jurisdictions are lagging. St. Louis County and St. Louis City are still using building codes from 2009. Springfield is using energy efficiency building codes from 2006 and in

We had a relatively old AC unit that

had needed servicing repeatedly for several seasons. There were times when we couldn't keep the house cool. We saw buying a new AC and furnace as a long term investment that would pay off in terms of lower costs with noticeably improved comfort.

Our gas and electricity bills have been lower but beyond that, the comfort levels in our home are much better—this is particularly important in our household since my husband, Jeff, works from home so the house has to stay comfortable at all times.

What would I tell others considering this process? It was worth it and the rebates really helped.

My air conditioner was about 20 years old and needed to be replaced so last year I invested in a new AC and programmable thermostat. I was interested in energy efficiency and the \$250 Ameren rebate was an incentive to not waste anymore time.

I love my new system. My new air conditioning is better, nicer and more reliable. My old AC had an EER (Energy Efficiency Ratio) of 8.5 and my new system is a 14.5 so I am saving 30-50%-- I have already saved a few hundred dollars this year. My thermostat is great because I can control my home's temperature through an app on my phone. Now I can have more control over how much energy I use and can still keep the house comfortable.

What would I tell others considering this process? The rebate system is fast and easy. Do it!



The Sierra Club in Missouri is organized in a state-wide chapter, and in four "groups" which cover the state but are centered around Columbia (Osage Group), Kansas City (Thomas Hart Benton Group), Springfield (White River Group) and St. Louis (Eastern Missouri Group). The chapter is managed by a volunteer Executive Committee (or "ExCom"), nine of whose members are elected at large meaning chosen in an election in which members across the state can participate. The ExCom makes important decisions for the Missouri chapter about financial and conservation issues.

- You must use this ballot with your address label attached to the back. The ballot portion will be detached from the label portion before counting Ballots without address labels will not be counted.
- 2) Vote for up to four (4) candidates. Indicate your choices by marking an X through the box to the left of the candidate's name. If yours is a joint membership, two (2) members may vote, each in their own column.

2014 State and National Elections

The Missouri Sierra Club mobilized for elections in August and November, gaining some important victories.

This year the Sierra Club had an increased presence in Missouri elections, endorsing 47 candidates and opposing two ballot initiatives. On August 5, the Sierra Club helped defeat Constitutional Amendment 7, which would have used a regressive sales tax to fund highway-centered transportation projects, with little going to public transportation. Unfortunately voters narrowly approved the deceptively worded Amendment 1, which hurts organic farmers and communities trying to protect themselves from factory farms.

Members in the White River Group put in a tremendous amount of effort into the spirited (but unsuccessful) campaigns of fellow Sierra Club members Jim Evans for the United States House and Angie Filbeck for Missouri House.

This year we sent out over 12,000 election postcards to members and delivered over 20,000 emails to members and supporters. A number of people volunteered to go door to door throughout the state in support of our endorsed candidates and made thousands of calls to members.

The make-up of the Missouri legislature may not bode well for environmental policy the next couple of years. We'll continue to work for pro environmental legislation in the state legislature and to support the folks that work toward that goal.
