Jenny Abel

I have served on the Mount Vernon ExCom since 2006. I serve as treasurer of the group and write a Meatless Monday column for the *Mount Vernon Sierran*. I have been active in the Group's Ready for 100 campaign in Arlington and helped to organize the pre-rally that we held last April before the People's Climate March. I have also organized several Meatless Monday cooking classes at the Arlington Central Library and hope to do more over the next year. Outside of the club I serve on Arlington's Solid Waste Committee, the R4 (Reduce, Reuse, Recycle, Rot) committee, and co-founded the Energy Masters program, an initiative in which teams of volunteers conduct energy and water saving retrofits in low-income apartments. If elected to another term I look forward to continuing to help with local efforts on the Ready for 100 campaign, transportation, waste reduction, and encouraging the adoption of plant-based diets.
