

#### The San Gorgonio Chapter Outings Leadership Training Course is a

comprehensive program designed to equip outdoor enthusiasts with the skills and knowledge to lead safe and successful outings. Over the course of two days, participants will learn essential leadership and organizational strategies, as well as important safety protocols. Led by experienced instructors, this course is a must for anyone looking to take on a leadership role within the San Gorgonio Chapter Outings program. **Join us on April 13th at the San Bernardino County Museum** and take the first step towards becoming a confident and capable outings leader.

The Leadership Training Course will continue with a focus on map and compass skills during a hiking field exercise in the **San Bernardino National Forest, starting at Keller Ski Hut.** Instruction will begin at 8:00 AM on Saturday, with the option to arrive Friday evening for those needing extra time or altitude conditioning. Participants must have completed the first part of the LTC training on April 13 before registering for this event. Registration will open after April 13.

While eyes are on the crucial Presidential race this year, it is also critical that we pay attention here to local leaders. ### **Current Projects We're Watching**

**Aquabella Specific Plan to be amended by developer for** 15,000 residential units/apartments on 770 acres located south of Alessandro Blvd and west of Nason St which could be a model for environmentally friendly large-scale housing projects. Our Moreno Valley Group submitted comments with suggestions on how they can accomplish this with less impact on the environment and residents of Moreno Valley.

#### The Village of Moreno Valley (VMV):

Project located at busy intersection northwest corner of Nason Street and Fir Avenue on about nine acres, includes 8 buildings with retail, restaurant, fueling station, car wash, and drive-thru restaurants; adding over 6,000 daily trips; Aquabella's project is adjacent to area. **The Nason Street/Fir Street intersection is already very congested; with this project's more than 6,000 daily trips it will only get worse. Those living in Aquabella's 15,000 units will also use Nason Street as one of their main routes.**

## Update from the Clean Transportation for All Campaign (CTFA) by Katherine Garcia

#### READY FOR 100% CLEAN TRANSPORTATION

As we shift to 100% renewable sources of electricity, plug-in vehicles become 100% clean. By reducing vehicles miles traveled, increasing and cleaning up public transit, and accelerating a switch to electric cars and buses, cities are reducing their dependence on oil and clearing the air.

#### Infrastructure Investment and Jobs Act Funding Implementation: Electric School Buses

On Monday, January 8th, the EPA announced \$1 Billion in grant awards for clean school buses, 95 percent of the funding will go towards electric school buses. The grants will help selectees purchase over 2,700 clean school buses in 280 school districts serving over 7 million students across 37 states.

#### EPA and State advocacy: Advanced Clean Cars II Standards

On Wednesday, Sierra Club staff and volunteers testified at the EPA hearing in support of the Advanced Clean Cars (ACC) II waiver. This is an essential hearing to ensure that all the states that have adopted ACC II can enforce the standards.

## Infrastructure Investment and Jobs Act Funding Implementation: EV Chargers

On Thursday, the U.S. Department of Transportation announced \$623 Million in grants to continue building out the EV Charging Network. These grants will fund 47 EV charging and alternative-fueling infrastructure projects in 22 states and Puerto Rico, including construction of approximately 7,500 EV charging ports.
