2021 LEGISLATIVE SESSION

The 2021 Oklahoma state legislative session—officially the First Session of the 58th Oklahoma Legislature—was a difficult and troubling session that clearly showed Oklahoma's legislature is firmly under the control of extreme conservatives in a powerful trifecta—House, Senate, and Governorship are all in Republican hands—that continues to trade protecting Oklahoma's environment for pursuing and benefiting corporate interests.

We had a very active lobby session, with all of our efforts taking place online and virtually due to the ongoing COVID-19 pandemic. You can review all of our efforts for 2021 by visiting our chapter's legislative web page: https://www.sierraclub.org/oklahoma/legislative

One interesting note-- although 2 positive poultry bills did not make it out of their committees this session, they are still alive, and we will be able to work on them again first thing next session (2022):

- HB1918 (new setbacks for poultry operations)
- HB2719 (new poultry reporting requirements)

The passage of HB1674-- the bill that lets people run over protesters without prosecution-- was one of many low points this session. But, we are excited to report that Oklahomans are stepping up to legally challenge this terrible bill. State Question 816 is currently in the signature gathering stage, as of July.

One other action we would like to mention—the Oklahoma legislature passed a bill to fund more than \$4 billion in debt bailout to Oklahoma monopoly utilities to pay their natural gas bills accrued as a result of the winter freeze event that left many Oklahomans without electricity. This issue is not settled, and it may carry over into the next session, following public outcry. No legislative effort was undertaken to prevent a repeat of the exact same "winter freeze episode" from happening again

GRASSROOTS EFFORTS

The Oklahoma Chapter of Sierra Club is the only environmental organization in the state of Oklahoma to employ a full-time environmental lobbyist—but it is our amazing volunteers that make us truly powerful! The Oklahoma Chapter of Sierra Club has a dedicated Volunteer Lobby Corps that gets to the state capitol every week of the legislative session to meet with legislators on issues and bills that matter to Oklahoma's environment. The best part— anybody can become an environmental lobbyist, and the Oklahoma Sierra Club is here to support and educate anybody interested in doing so—no experience needed, just a passion to protect Oklahoma's air, land and water.

The Legislative Committee

Oklahoma Sierra Club also has a chapter-level Legislative Committee to wade through the countless bills, to help focus where the most attention is needed, and to help with the non-stop outreach efforts needed throughout session, as well as to help make specific events the best that they can be. LEGISLATIVE SCORECARDS

The scorecards are based on votes on bills chosen from our pieces of priority environmental legislation--taken together these votes provide a composite representation of each legislator's relationship to environmental issues in the State of Oklahoma as a whole. The scorecard includes their voting record and their final "Grade" for the session, in a traditional A to F format.

The Senate bills list and scorecard are shared first, followed further down by those of the Representatives.

BILLS ON SENATORS'SCORECARD

SB448 (Sen. Taylor and Rep. Boles): Adds and modifies definitions within the Oklahoma Solid Waste Management Act to allow for chemical recycling and other processes like hydrolysis. We opposed it because all forms of chemical recycling have been shown to be highly toxic and bad for the environment without actually reducing plastic waste. Also-- we believe these processes should have MORE oversight, not less-- by qualifying them as "Solid Waste," they will be less strictly monitored. This bill was signed into law.

SB1022 (Sen. David and Rep Boles): Gives the executive director of the Oklahoma Water Resources Board the power and duty to issue temporary permits and regular permits that have not been subject of a protest from an interested party. Oklahoma Sierra Club OPPOSEDED this bill. This bill was signed into law.

SJR0023 (Sen. Standridge and Rep. Echols): Adds the State of Oklahoma to the list of U.S. states calling for a new Constitutional Convention. We opposed this bill because there are no clear limits on what could happen if a Constitutional Convention is convened—we strongly believe it would open a proverbial can of worms that could damage the very fabric of the United States Constitution. This bill was signed into law.

HB1674 (Rep. West and Sen. Standridge): declares every person who knowingly obstructs the normal use of any public street, highway or road within the state will upon conviction be guilty of a misdemeanor punishable by imprisonment in the county jail for a term not exceeding 1 year or a fine of not less than \$100 and not exceeding \$5,000 or both. We opposed this bill because this is a violation of Americans' right to protest. This bill was signed into law.

HB1815 (Rep. McBride and Sen. David): Requires the Oklahoma Corporation Commission to, no later than December 1, 2021, issue a report to address a recommendation for the state's renewable fuel standard or goal to more proactively promote biogas, renewable natural gas and hydrogen as solutions for reducing methane emissions and other environmental problems. We opposed this because this bill falsely promotes methane-producing systems and claims they REDUCE methane. Also, they are not renewable systems in most cases, and therefore should not be added to Oklahoma's "Renewable Portfolio Standards." This bill was signed into law.

HB2095 (Rep. Lepak and Sen. Daniels): Modifies the definition of racketeering activity used in the Oklahoma Racketeer-Influenced and Corrupt Organizations Act (RICO) to include relating to unlawful assemblies. We opposed this because this bill has been proven to be a violation of freedom of speech/ right to protest in other states. It is a harsh attempt to scare people away from protesting. This bill was signed into law.
