n Tuesday, May 3rd, Chris Roholt will present a program illustrated with slides on wilderness restoration work in the California Desert. Chris, recently retired after 20 years with the Bureau of Land Management (BLM), was Program Lead for the BLM's National

Landscape Conservation System. Many of the restoration projects that Chris managed involved the Student Conservation Association (SCA).

The BLM's National Landscape Conservation System contains some of the West's most spectacular landscapes. It includes over 886 federally recognized areas and approximately 27 million acres of National Monuments, National Conservation Areas, Wilderness Areas, Wilderness Study Areas, Wild and Scenic Rivers,



National Scenic and Historic Trails, and Conservation Lands of the California Desert.

The BLM's California Desert District manages almost half of the wilderness acreage in the BLM. There are many tasks associated with managing that resource, such as monitoring wilderness resources, restoration of damaged lands, and eradicating non-native vegetation.

The Student Conservation Association (SCA) has worked with the BLM and many other agencies to provide conservation service opportunities for young adults. A decade ago, the SCA formed working corps of college age students to focus on conservations tasks.

Chris obtained funding and helped organize one of the first three SCA Corps in the country. He will share their journey of doing good work in BLM's desert wilderness. Then . . .

n Tuesday, June 7th, we'll have a great presentation! Our beautiful Southern California landscape – our mountains and our deserts – is the creation of our dynamic geology. We live along the San Andreas Fault, one of the world's most famous. It's been over 300 years since there has been a major earthquake on our part of

the fault. What would happen if we were to have one now? Scientists say that it's likely to happen in our lifetimes.

Kathleen will tell us how our mountains and deserts were created and what we can do to protect ourselves if an earthquake happens. She will explain what government is doing to help us prepare. Now in its fourth year, the Great California Shakeout, set for 10:20 am October 20, is the world's largest earthquake drill. Kathleen will tell us how we can take part and how it will help make all of us safer.

Kathleen Springer has over nineteen years' experience in leading geologic and paleontological investigations throughout southern California, Arizona and Nevada. Kathleen specializes in paleontological field work, and she emphasizes the importance of detailed data recovery and full preservation of recovered resources. Her efforts have led to the discovery and protection of thousands of significant fossils and their associated data that currently reside in the San Bernardino County Museum.

A resident of Claremont, she has been recognized by the Association of Environmental Professionals for environmental education and by the California Mineralogical Society.

Second Annual San Gorgonio Mountain Backpacking Trip

The Big Bear Group has scheduled its second annual three-day wilderness backpacking adventure to the top of the San Gorgonio Mountain starting on Friday, September 16, 2011, and completing Sunday, September 18, 2011. The adventure gets underway at 7:30 a.m. Friday morning from the South Fork Trail Head and completes it first day of backpacking by reaching Dry Lake camp grounds. This is a 7.2 mile distance.

On Saturday, we leave our camp site and hike to the top on San Gorgonio Mountain. Along the trail, we will have the opportunity to see the aircraft remains of a C-47 military cargo plane that crashed into the mountain killing all 13 passengers aboard in 1953. Later, we will reach the top of the San Gorgonio Mountain, the highest peak (11,500') in Southern California. After taking in the views below and photos, we return to our base camp at Dry Lake.

Sunday morning, we will break camp and return to the base of the mountain and the South Fork Trail head. You will have completed a 25 mile hike, gained backpacking hiking skills, overnight camping, and experienced a 5,000 foot elevation gain during the trip. This is a strenuous effort worth taking

Big Bear Group Challenge Recognition Program

ach calendar year the Big Bear Group awards special recognition badges for accomplishing special hiking achievements. A new program for 2011 is described below:

Hike Section C of the Pacific Crest Trail: Hike the historic Section C (between San Bernardino, Interstate 10 to Interstate 15 near Cajon Pass) Pacific Crest Trail during the summer of 2011 and/or 2012 and receive a special achievement patch and recognition in the Palms to Pines bi-monthly newspaper. Background: The Pacific Crest Trail (PCT) designated for hikers to travel from the Mexico border to the Canadian border covers a total of 2,638 scenic miles. Section C of the PCT travels through the San Gorgonio wilderness and the Big Bear area for a total of 132.9 miles. Challenge Description: The hiking challenge is separated into eleven (11) segments, culminating in a three-day backpacking trip. The hiking segments can be accomplished over the years 2011 and 2012. In other words, a hiker may choose to complete all segments over a two-year period. Enthusiastic hikers may contact Hiking Leader, Ed Caliendo, at (909) 878-3813 or contact either co-leader Ed Wallace at (909) 584-9407 or co-leader Vicki Hobbs (909) 771-9899 for additional information. The hiking schedule will be confirmed by-monthly and published in the Palms to Pine publication and on the Sierra Club website. The 2011 tentative hiking schedule is provided below.

Hike#1: May 14, 2011 –Interstate 15 near Cajon Pass to Silverwood Lake Area entrance road – This is a 13.1 mile PCT through-hike.

Hike#2: May 21, 2011 –Silverwood Lake Area entrance road to 2N33 near Cedar Springs Dam – This is a 6.0 PCT through-hike.

Hike#3: <u>June 4, 2011</u> –Cedar Springs Dam to Mojave River Forks Reservoir Dam – This is an 11.1 PCT through-hike.

Hike#4: June 11, 2011 – Mojave River Forks Reservoir Dam to Deep Creek Bridge (near Lake Arrowhead – This is a 14.4 mile PCT through-hike.

Hike#5: <u>June 25, 2011</u> – Little Bear Springs Trail Camp to Deep Creek Bridge/Lake Arrowhead – This is a 12.8 mile PCT through-hike.

Hike#6: <u>July 2, 2011</u> – Van Dusen Canyon Road to Little Bear Springs Trail Camp, northwest of Fawnskin, CA – This is a 10.7 mile PCT through-hike.

Hike#7: July 16, 2011 – Van Dusen Canyon Road, near Big Bear City to Hwy 18 Cushenberry Pass near Baldwin Lake – This is an 8.9 mile PCT through-hike.

Hike# 8: $\underline{\text{July } 30, 2011} - 2\text{N}02$ to Hwy 18 Baldwin Lake Cushenberry Pass – This is a 10.5 mile PCT through-hike.

Hike# 9: August 13, 2011 – 2N02 to Cienaga Seca Creek turn-off on Hwy 38 – This is a 7.0 mile PCT through-hike.

Hike# 10: September 10, 2011 – Cienaga Seca Creek turn-off to Mission Creek Trail Camp- Day

Hike – Southeast of Big Bear, located on Hwy 38. This is approximately an 8.9 mile PCT through-hike. Hike#11: October 21, 2011 to October 23, 2011 – This is the final leg of our PCT Section C journey, a three-day backpacking adventure from Mission Creek Trail Camp to Interstate 10 near Whitewater River Canyon Preserve. This last leg of the journey is a 29.5 mile PCT through-hike. This completes the 132.9 mile PCT Challenge.

Mojave Group

he real cost of generating Solar Power in the Desert will be the burden of rate payers through new transmission lines. While companies get huge subsidies from the Federal Government to destroy the desert landscape and make a profit for their investors, YOU, the customer (or rate payer) will bear the burden of the BILLIONS of dollars needed to get that energy to the Southern California grid.

Southern California Electric Company says that they need to upgrade or build a new transmission line to accommodate solar power generated east of Lucerne Valley and get it to the Southern California grid. Alternatives were discussed at a meeting in Hesperia on March 3. Green Path North is dead, but the Lugo-Pisgah Transmission line may take its place through our local communities of Lucerne Valley, Apple Valley and Hesperia or around the Juniper Flats Area.

Stated NEED (this is the biggest question of all and was not adequately answered):

Currently, there are two sets of power lines in this area. One corridor coming from Hoover Dam has two 220 Kv capacity. This one crosses Roundup Way east of Kiowa in Apple Valley. The other one is the corridor with two 500Kv capacity. This one goes through Johnson Valley, Lucerne Valley and above Milpas Highlands and goes through primarily BLM land (Juniper Flats Area) and crosses Deep Creek Road about 5 miles south of Rock Springs Road (where does this line originate and what kind of electrical power does it carry?). Both then go through Hesperia to the LUGO station. SCE stated they need 1400Kv capacity. Don't they have that with the existing lines? Apparently not. They stated the corridors are not wide enough to accommodate the height needed for 500Kv lines (180' to 200' high). They need two more 500Kv lines. Lines can lose from 7-10% of the power generated.

Alternatives included widening the corridor through the Juniper Flats BLM lands or upgrading the other existing 220Kv lines which necessitates a widening of the corridor. That is feasible only up to the point of crossing the Mojave River because on the Hesperia side of the river there are too many houses in the way. So one alternative is to use this corridor up to a point east of Kiowa and then run a NEW TRANSMISSION line south to meet the Juniper Flats one and cross Deep Creek and the Mojave River along the same, but widened, corridor. The Lugo station is already upgraded, but the Pisgah station would need an expanded location for needed upgrades. The following impacts are regarding the transmission lines.

NONE of the alternatives includes one for distributed solar where it can be generated closer to where it will be used. This is called "distributed Solar" or "Roof top Solar" and should be considered thoroughly.

COST: \$21.5 billion will be the burden of (all?) SCE rate payers with a general rate increase and will be paid for in 3 years. This rate increase will have to be approved by the Public Utilities Commission (PUC) and proposed to the customers (rate payers). What is the cost per megawatt? How many customers does SCE have? JOBS: SCE and other companies rely on the public need for jobs to push their project through. However, the jobs that SCE is talking about are very limited and very temporary jobs. Transmission lines do not need a lot of maintenance, and do not provide ongoing jobs once they are built. However, the alternative that is not mentioned-distributed solar-would provide a lot of local, less specialized jobs which would continue with every house built and ever more retrofitting for houses as people need new roofs. This alternative MUST be discussed in the Environmental documents.

Significant IMPACTS:

SCE will conduct an environmental review and impacts for various criteria will be evaluated from low to high. When evaluating the suitability of

the line routes SCE also considers the mitigation potential of different locations. This review includes the impact on aesthetics, biology, community, cultural resources, electromagnetic fields, existing land use, geology, and land acquisition (none required only easements, although in reality it could be a big chunk of a 2.5 acre parcel).

Private property along ALL of the

alternatives will be impacted. Some property will be **taken** by an expanded width of the current easement or by a new easement (*SCE will give the owner fair market price*). Towers no longer used across easements that contain the 220Kv lines west of Kiowa will NOT be taken down and the easement will NOT be given up (SCE may need to use that easement in the future). Do these land owners get reduced rates for electricity? Why not?

Aesthetics: All alternatives have a significant impact on viewshed from private properties and points around the valley. None would have more impact than the proposed connection around the corner of the Ord Mountains South of Roundup Way to the existing Powerlines through the Juniper Flats Area (alternatives A and C). This new line would spoil the view of the mountains from everywhere in the Victor Valley. Views from and of the Juniper Flats ACEC (Area of Critical Environmental Concern) will be severely compromised with the proposed increase in powerlines and towers.

Biology: Habitat loss due to fire has ravaged the area and the proposals will increase that habitat loss. Wildlife movement will be impacted, but especially along the ridges of the Ord Mountain escarpment where raptors are seen enjoying the thermal currents (alternatives A and C). The Powerline Road through the Juniper Flats area has caused the flooding near the Waterfall in 2005 and that road has not been repaired. That road has been subjected to increased OHV play and that activity is now spreading like wildfire south into Arrastre Canyon, destroying riparian habitat and causing erosion on the hillsides. This illustrates how poorly SCE views their use of **YOUR** public lands. These are just a few of the noted impacts of the Lugo-Pisgah Renewable Transmission Corridor Project.

The San Jacinto River Levee Project, Stage 4 has been in the planning stages for many years (since 2000). The project would build a levee from State Street to Sanderson Avenue in San Jacinto (approximately five miles) so 2,000 acres of flood plain could be filled for development. The project will have impacts on the San Bernardino kangaroo rat, burrowing owl, least Bell's vireo and destroy riparian habitat for wildlife. It will ultimately affect Mystic Lake (where the San Jacinto River naturally pools) and the San Jacinto Wildlife Area. The draft environmental impact report for the project will be released this some time this spring.

The Friends of the Northern San Jacinto Valley and the Sierra Club filed a lawsuit in April 2010 to challenge the approval of the Villages of Lakeview (Specific Plan 342) development on the southern boundary of the San Jacinto Wildlife Area. The 11,250 unit project will have devastating impacts on the wildlife area and the communities of Lakeview and Nuevo. The project is the centerpiece of Riverside County's plan for a new''city' in the middle of this rural valley. Please take time to support this lawsuit and make a donation. The California Department of Water Resources hopes to release the final environmental impact report on the Lake Perris Dam Project in the summer of 2011. According to county planners, the draft environmental impact report for the update of Riverside County's General Plan (GPU) is still a work in progress. They hope to have the next General Plan Advisory Committee meeting in either late spring or early summer. George Hague and alternate Ann McKibben have represented the environmental community on the committee which is dominated by those connected to development interests. The GPU will impact all of us within Riverside County as it will lay out land use designations for years to come; address sprawl, global climate change, noise and open space issues. Land use designations will significantly impact the San Jacinto Wildlife Area and open up valuable agricultural lands for development. hate to say "mission accomplished" but we do have completion of the transfer of 50+ acres of forested property (see photo in next column) from the Royal Rangers (and their planned Adventure Camp) to the San Bernardino Mountains Land Trust. Lots of work by local environmental groups (including the Mountains Group) and more involvement from the community, in general, than we have seen in a number of years preceded the sale and helped convince the Royal Ranger organization that selling the property to the Land Trust was the best thing to do for all involved. Congratulations to everyone that helped make it happen!

In addition, here are a few words from Peter Jorris, Executive Director of the San Bernardino Mountains Land Trust:

On February 28, 2011, the San Bernardino Mountains Land Trust purchased the 50.31-acre Royal Rangers property in Twin Peaks that has been the center of controversy for a decade over a proposed large-scale camp complex and conference center.

The property lies within a prominent wildlife corridor, linking Strawberry Creek with the Grass Valley Creek area. It also is critical habitat for the southern rubber boa, a small friendly snake listed as 'threatened' by the state Dept. of Fish & Game and found only in our local National Forest. The land will be offered for sale to the Forest Service as a protective buffer to the west flank of Strawberry Peak in addition to the site's other unique habitat values.

In March 2010, the Sierra Club partnered with the San Bernardino Valley Audubon Society, Center for Biological Diversity, Save Our Forest Association and Christians for the

Earth in filing a court challenge against the Board of Supervisors for approving the Royal Rangers project. Issues included violations of the California Environmental Quality Act (CEQA), like disregarded Biological impacts, major Aesthetic impacts, Fire Safety concerns, and inadequate Alternative Project analyses. The legal petition also cited significant conflicts with the policies and codes of the County General Plan, which had been ignored.

A standing offer by the San Bernardino Mountains Land Trust to buy the land persuaded the Royal Rangers to sell and settle the lawsuit, rather than undergo a protracted and costly legal battle.

A special letter-writing campaign (directed at both the Forest Service and Congress) is being planned to help identify this site as a major acquisition priority and to request the necessary LWCF appropriations for it to be added to the National Forest.



And that means we can focus all (almost all) of our attention on the next oversized, inappropriately located development – the Church of the Woods-"Sonrise" project in Rimforest.

The draft EIR (the sorriest example of an EIR I have ever seen) has been reviewed and commented upon and we are waiting to see if the next step is as poorly executed. Hard to imagine that it could be but, then again, San Bernardino County is always able to surprise us with creative and innovative reasoning (?) to support approval of development.

It would be nice, but unexpected, to see them do the right thing for a change and the documentation for this project is so inadequate that it would be easy for the County to decide that it cannot let it proceed. Just point to the CEQA violations; just point to the lack of adherence General and Community Plans; just ask that the requirements of other State agencies be properly addressed; and just insist upon conformance to development codes. Just say no!

Caltrans recently presented us with a traffic signal (on the Rim of the World Highway) that we neither needed, nor wanted, and this huge complex of church and recreation facilities would add another NINE traffic signals to our rural (currently anyway) community.

A letter writing campaign has been ongoing (thanks Sue Walker for your work there) and by the time you read this we will have had our first Town Hall meeting to further spread the word about the project and its problems.

On a more positive note, the Forest Festival is set for June 4 at the Brulte Baseball field on Highway 18 just east of Charles Hoffman Elementary School in Running Springs. Across California, A Trek From The Colorado River to The Pacific


Cal, 74, a member of the Sierra Club for 42 years, is trekking 530 miles to highlight the threatened natural corridors between the Colorado River and the Pacific Ocean. Cal sits on the Sierra Club Santa Lucia Chapter Board. He is blogging from a BlackBerry.

n 1826, my much-removed cousin Jedediah Smith, a 27-year-old fur trapper, led a band of 16 men from Utah into California, which was then part of Mexico. Now, 186 years later, and 47 years older than he was, I will be following part of Smith's route, on which he reached the nearly-dry Mojave River. He was actually looking for the mythical great Buenaventura River, which of course he never found. It supposedly would connect the interior of North America to the Pacific Ocean, serving as a vein for commerce. I, on the other hand, will be looking to see how the different ecoregions from the eastern Mojave Desert across the mountains to the Pacific connect with each other.

The point?

Cousin Jedediah had only the sketchiest of maps if any, whereas my companions and I will have almost too much information with GPS, topographic maps, and Google Earth

as resources. Thousands of articles, scientific papers, and books describe the areas my route covers. You can drive from the start to finish in a long day. So why do it? Aside from its being a personal accomplishment such as doing the Pacific Crest Trail, my larger purpose is to show that someone can walk on public and conservancy land, avoiding roads and highways, over an area that still looks natural. And it is through this personal connection with the land across about 530 miles that I hope to speak for the necessity of preserving and protecting what wildness remains. Not only that: If this wildness is isolated it will eventually die of starvation.



Jedediah Smith, first white man to travel from Rocky Mountains to California, lead the first expedition of trappers from California to the Pacific Northwest. Although he lost most of his men and all of his supplies to Indian attacks on the way, he established the first link between California and the Pacific Northwest.

That starvation will come about when connections are severed. For example, biologists have told me that the San Joaquin Valley kit fox population on the Carrizo Plain National Monument—through which the trek will pass—could die out unless it maintains connections with populations to the north and south of the Monument.

Another example: Joshua trees in Joshua Tree National Park are starting to suffer from excessive summer heat; meanwhile, other groves of these picturesque spiny plants are extending west of the hottest deserts.

The Route

Beginning at the Colorado River near Laughlin, Nevada, on March 20, four of us will cross the Dead Mountains and head for Hole in the Wall in the Mojave National Preserve, which we'll reach in six days. Spencer Berman and Stacy Goss will leave the trek there. Four days later, Tom Landis and I will be

at the strangely-named Zzyzx, now a center for desert studies, where Tom's wife Madeleine will join us.

Eventually, backed up by new supplies from my wife Letty, we'll reach the Pacific Crest Trail at Jawbone Canyon and take it south to the Tejon Ranch, probably the most vital ecological link between the desert, Sierra, San Joaquin Valley, and southern California mountains and valleys. With kind permission we'll cross the Ranch and enter the Wind Wolves Preserve, which also greatly enhances connectivity among ecoregions. Then we're on to Bitter Creek National Wildlife Refuge, the Carrizo

Plain National Monument, the Carrizo Ecological Reserve, and the Los Padres National Forest ending in Morro Bay on May 1st or 4th or whenever we get there.

Santa Margarita Group

bout 100 Sierra Club members and area residents came to our February 17th General Meeting to hear Riverside County Supervisor Jeff Stone described the Temecula Valley Wine Country Community Plan.

The proposed plan as presently written would significantly expand the boundaries of the current Wine Country, as well as enlarge the types of development that would be permitted.

There are currently about 34 operating wineries in the Wine Country with that number projected to grow to more than 100 in the years ahead if the proposed plan is approved by the Riverside County Board of Supervisors. The long term plan is being compared by supporters as well as opponents to Napa Valley's famous wine country with its major hotels, convention centers, out-door entertainment venues and numerous bed and breakfasts. One of the primary goals of the Temecula Wine Country Plan is to create a setting that would attract large numbers of tourists. As most agree, the big challenge is going to be the creation of a world class wine growing area while at the same time preserving the Temecula Valley Wine Country's very unique rural and equestrian life style that prompted hundreds of homeowners to move into the area.

The Temecula Valley Wine Country Community Plan is still in the formative stage with many issues still to be resolved. Over the months ahead, the Sierra Club plans to participate with residents and local community leaders in guiding certain aspects of the plan that could impact the local environment. Among the issues we are concerned about are water availability, habitat preservation, trail systems as well as increased noise and traffic.

In addition, here are some of the other projects our Group is following:

The Santa Margarita Group had a great activity on Saturday, March 12th with a selection of docentled hikes through the beautiful Torrey Pines State Reserve. We had 4 wonderful docents offering a nice selection of walking hikes and our group of approximately 30 Sierra Club SMG members was divided in to 4 small groups. Two of the groups were led on a wildflower hike and the other 2 embarked on a more strenuous Reserve hike which included a walk down to Torrey Pines beach. All 4 of the docents shared their knowledge and insights about Torrey Pines, with a special emphasis placed on wildflowers, Native Plants and geology. We were even lucky enough to have a gorgeous afternoon of sunshine!

Immediately after our adventure at Torrey Pines, we met for dinner at Tony's Jacal, a longtime Mexican Restaurant located in Solana Beach.

I have two hikes planned for May and June and may add a third.

On Sunday May 1st, starting at 9 AM we going

to hike the Morgan Trail. This is an easy to moderate out and back hike of 9 miles. Because the trail ends at the junction with the Bear Canyon trail, there is an option for a shorter hike if 9 miles is more than you are looking for. From the Bear

Canvon Trail junction it is an easy 1 mile hike down to the Candy Store on The Ortega Highway. You would need a car parked at the trail head parking lot on the north side of the road. A wilderness pass is required for the car. Those hikers could share a ride back to The Morgan Trail head and pick up their cars (also displaying wilderness passes). From the Morgan trail head we travel

east through an oak woodlands with the sound of a stream below the trail. After about two miles the trail opens up into a forest of chaparral with some great vistas of the mountains and valleys. The hike should take about 3.5 hours. Directions: From the Ortega Highway in Lake Elsinore head west up the mountain. When the road begins to level out there is a left turn with a turn lane. This is South Main Divide Road. Turn left and the trail head is about 2.8 miles on the right. As always bring plenty of water, a lunch, comfortable hiking shoes, dress in layers and don't forget the sunscreen and a wilderness pass is required for all cars parked at trail heads

Then on Sunday June 5th starting at 8:30 AM we will hike an area in view of Beauty Mountain. Because of the tremendous interest in Beauty Mountain and it's designation as a Wilderness Area, I would like to revisit an area that will give you a close up view of the mountain. Shauli led us on this hike last April and was a great success. It is both a great hike and a chance to actually see the area we so often talk about at Sierra Club meetings. It is a moderately strenuous hike of between 5.5-7.0 miles depending on how we decide to hike it and about 800' of elevation gain. Bring plenty of water, a lunch, comfortable hiking shoes, and dress in layers and bring sun screen. Directions: Take 79s to the 371 and drive about 11 miles to Cahuilla Casino. We will meet at 8:30 AM and ride share from the parking to the trail

Local residents and members have reported their concerns about projects such as the Temecula Valley Wine Country Community Plan, the Galway Downs sports field expansion, the Lake Elsinore Hydro Electric Plant (LEAPS) transmission lines proposed route into Cleveland National Forest and Pacific Aggregate's land swap in Temescal Canyon. We are investigating and identifying any environmental impacts our Club may be able to address.

The final Environmental Impact Report (EIR-475) for Liberty Quarry is now available for the public to read. You can find it online at (www.rctlma.org/planning/content/temp/ <u>liberty≠ quarry.html</u>) or at the Temecula Public Library, the Grace Mellman Community Library (Temecula County Library), the Murrieta Public Library or the Fallbrook Branch of the San Diego County Libraries.

The long-awaited County Planning Commission hearing to approve or deny the proposed Liberty Quarry project is scheduled for Tuesday, April 26th, and if needed, Tuesday, May 3rd. The hearing will start at 4:00 PM at the Rancho

> Community Church Temecula Parkway, approximately one mile east of the I-15.

It is important to get the maximum number individuals to attend this hearing to show the County that we re opposed to this potential environmental disaster, which would be located next to SDSU's Santa Margarita Ecological Reserve. The Reserve is

located in the MSHCP (Multi Species Habitat Conservation Plan) which will be significantly impacted by Liberty Quarry. The quarry would also sever the wildlife corridor between the Santa Ana and Palomar Mountains. The quarry is also located in the Santa Margarita River Watershed, which is a major source of drinking water for Camp Pendleton's Marines and their family members.

Tahquitz Group

Spring has sprung in the low desert and the hillsides are rife with myriad wild flowers. However, invasive Saharan mustard is a mounting problem both in Joshua Tree National Park and in the sand dune preserves in the Coachella Valley. The great news lately is that the bulk of the Palmwood project site has been acquired (see writeup below). Other than that, Tahquitz activists continue to work on Chino Canyon and other issues, including solar projects small and large, good and bad.

> Desert Treasure to be **Protected in Perpetuity!** Bye Bye Palmwood, Hello Big Morongo Saved

Remember the giant "Palmwood" project in eastern Riverside County that threatened the Big Morongo Area of Critical Environmental Concern back in 2006 and 2007? With Chapter and Group assistance, the Club successfully sued against Palmwood's proposed 2600 houses, 400 room hotel, golf courses, and a million square feet of big box stores, — all proposed around the mouths of Big Morongo and Mission Creek Canyons in the sensitive ecotone between the Mojave and Colorado deserts.

Not only is this area an ecotone between these major ecosystems, but also it is a major recognized regional wildlife corridor and host to rare and sensitive species found few other places in the world.

Winning the lawsuit against the actual project was just half the battle, since the three square miles in question were still privately owned. But thanks to joint land acquisition efforts, Palmwood is rapidly becoming

About a year and a half ago, the Commission implementing the Coachella Valley Multiple Species HCP bought the easternmost portion of the Palmwood site. Then just recently Friends of the Desert Mountains bought the western third of the

Thus, the original Palmwood project is essentially book-ended, leaving only the center square mile, which is more mountainous terrain but nevertheless important to preserve. While this final parcel remains a high conservation priority for acquisition, the threat of another Palmwood is largely gone.

From the early days of the battle up till today, there were many important players: Chapter and Tahquitz Group; Center for Biological Diversity attorney Jonathan Evans and Club attorney Wayne Brechtel; Robin Kobaly and other biologists who commented on the EIR; County Supervisor Marion Ashley who hung tough to prevent the area from being annexed into an errant City of Desert Hot Springs; Coachella Valley Mountains Conservancy that granted bond funds to accomplish this critical conservation initiative; and Friends of the Desert Mountains who facilitated the most recent acquisition.

A debt of gratitude is owed to all the above for helping protect the treasure we know and enjoy as Big Morongo ACEC, for now and into the future.
