

## Clean Power Plan and the Illinois Jobs Bill

In lieu of any action being taken by Congress on climate change, the Obama administration has undertaken an initiative to reduce CO<sub>2</sub> emissions at U.S. power plants. It's called the Clean Power Plan and it hopes to reduce overall carbon emissions from power plants by 30% by 2030.

The Obama administration has been working on this initiative for several years. In 2011, they started requiring power plants to report their CO<sub>2</sub> emissions. This data will help the government track emissions and measure compliance. Several states, most notably Texas, have opposed this, saying it is unconstitutional for the administration to move forward, since Congress has not approved the overall plan. But the Supreme Court had already ruled in 2007, in *Massachusetts v. EPA*, that CO<sub>2</sub> can be regulated as a pollutant (because of related health impacts) under the Clean Air Act. The EPA is the agency that administers the Clean Air Act, and it is the agency that will administer the new "rule" for power plants.

Although the EPA is responsible for this initiative, it is giving states considerable leeway in how to reduce their emissions. States can move to "cleaner" burning fuels, improve efficiencies, or rely more on renewables like wind and solar. A preliminary rule has been issued to give states an idea of what is coming in the final rule which is coming out sometime this summer. Already, some states have sued, like the ever-environmentally-conscious Texas, but the courts have said any further suits will have to wait until the final rule is published.

In Illinois, the reaction to the Clean Power Plan is much different, and we hope to keep it that way! One bill being considered now in Springfield anticipates the new rule. It's called the Illinois Clean Jobs Bill. It requires power companies to increase the portion of renewable energy they produce to 35% by 2030. This is known as the Renewable Portfolio Standard because Illinois' energy portfolio will contain 35% renewable energy. The bill also requires another 20% reduction in overall energy consumption through efficiencies.

One of the hallmarks of the bill is that it will promote the creation of renewable energy jobs here in Illinois - as many as 32,000 per year for an unforeseeable number of years, according to one study. This means Illinois will not only be in good shape when EPA's final rule is published, but we will also be reaping the benefits of being at the forefront of the renewable energy economy.

Sierra Club has teamed up with other groups, such as other environmental groups, unions, and renewable energy companies to promote this effort. On February 10th, the Illinois Sierra Club organized a Town Hall meeting at Moraine Valley College hoping that 50 concerned citizens would attend. Instead, 115 showed up. Several Sauk-Calumet Group members attended, including Mr. and Mrs. Lorch, Mr. and Mrs. Thiesen, Ben Armstrong, Patrick Coffey, Mary Curtin, Jerry Dagenais, Audrey Fischer, Susan Nicholas, Sharon Rolek, Elise Ziemann, among others ; and Melinda Elliott, who also did phone work and helped organize the event.

Then on April 22, Earth Day, Sierra Club helped organize a rally in Springfield that hundreds of people from all over the state attended. Six buses made the trip from the Chicago area alone. While they were there for the rally, many people were able to talk with their legislators about the Illinois Clean Jobs Bill. Terry Treacy, Illinois Sierra Club's political advocate in Springfield, has said that several legislators commented on the success of the rally, indicating that the rally and lobbying effort had an impact.

Keep tuned-in in the weeks ahead for emails about another Town Hall meeting to be held in the south Suburbs, possibly in Park Forest. We want to show our state and federal lawmakers and the Obama administration how much support there is for climate action. It appears that, around the nation and in particular in Illinois, people are no longer willing to remain silent on this issue. It's time for all of us to stand up and make our voices heard. And the good part of it is, we are actually doing just that.

## Brookfield Zoo Keepers Plant Trees

On November 17, 2013, Washington, Illinois was devastated by an EF-4 tornado that hit their community. The tornado damaged as many as 500 homes and cut a path through the center of town. Since this tragedy, the town has been rebuilding, but not only buildings were lost - over 10,000 trees were also destroyed.

Trees for You and Me is a competition fund raiser between zoo keepers to raise money to plant trees and to help the polar bears ice habitat that is being affected by climate change. The competition is supported by the American Association of Zoo Keepers (AAZK) and Polar Bears International (PBI). For the 2014-2015 competition, the Brookfield Zoo AAZK Chapter wanted to do a local tree planting and decided that Washington, Illinois was the perfect place. The first phase of the tree planting was done in the fall of 2014 and the second phase in 2015 on Arbor Day, April 24.

The Brookfield AAZK Chapter raised \$3,395.45 for Trees for You and Me and was the mid-point and winner of this year's competition. The midpoint winner gets \$25 towards a shrub and the winner gets \$100 towards a tree from PBI. With the added \$125, the Brookfield AAZK was able to donate \$3,520.45 toward the Trees for Washington Phase II.

Five members of the Brookfield AAZK Chapter also traveled to Washington, IL to assist the City of Washington and the Washington Park District in their tree planting project and to explain why planting the trees was so important. Climate change is causing

extreme weather, like the EF-4 tornado that devastated Washington, IL, and the warmth in the arctic that is causing the polar bear habitat to shrink. Trees absorb carbon dioxide, one of the leading greenhouse gases that cause climate change, and release oxygen into the air. By planting 58 trees, we helped both the residents of Washington, IL and the polar bears in the Arctic.

Besides planting trees, members of the Brookfield AAZK Chapter also discussed other ways to reduce, reuse and recycle with the Washington community to continue reducing the effects of climate change and the extreme weather patterns that are affecting the whole planet.

**Sunday, June 14th at 1:30 pm**                      **Esker Trail**, Palos Forest Preserves, Palos area - about 2 miles  
This afternoon hike is in the woods, when we should be cool and in the shade. This site is a hill or "esker" created by the retreat of the last glaciers.

**Sunday, June 28th at 7:30 am**                      **Lockport Prairie**, Lockport, IL - about 1.5 miles  
We are getting up early to avoid the sun, and to see if we can catch sight of the Hine's Emerald Dragonfly and to maximize birding on this rare dolomite prairie.

**Sunday, July 12th at 9:30 am**                      **Rock Run Preserve / Black Road Access**, Joliet, IL - about 2 miles  
A paved trail with lots of reconstructed natural areas: prairie, savanna, wetlands. This site contained at one time a quarry.

**Sunday, July 26th at 9:30 am**                      **Braidwood Dunes**, Braidwood, IL - about 2 miles  
A great sand prairie with prairie vegetation and even prickly pear cactus.

**Sunday, August 9th at 9:30 am**                      **Gensburg Prairie**, Markham, IL - about 1.5 miles  
One of Illinois' premier quality prairies. This site was never plowed since pre-settlement times. With possible trips after the hike to other Markham prairies for those who wish.

**Sunday, August 23rd at 1:30 pm**                      **Cowles Bog**, Indiana Dunes National Lakeshore, IN - about 3 miles  
Part of this hike will be forested and in the shade. There will also be views of the bog and open water, and possibly a Sandhill Crane.
