## Annual Sierra Club Celebration of the Solstice

Featuring "Ansel Adams and the Sierra Club"

5:30 p.m. Thursday, December 6th, 2001 at Chestnut Court, St. John's Meadows\*

Did you miss it? Well here's a chance for a replay of our winning program "Ansel Adams and the Sierra Club". ## Wild Utah: America's Redrock Wilderness 7:30 p.m., Tuesday, Nov. 20, Hoyt Hall\*, University of Rochester

Wild Utah: America's Redrock Wilderness is a unique multi-media slideshow documenting citizen efforts to designate some public lands as Wilderness in southern Utah's spectacular canyon country and deserts. This 20 minute journey through redrock splendor invigorates and motivates viewers to participate in the movement to protect these unique lands. Wild Utah: America's Redrock Wilderness was made possible through the generous donation of photos, music and words from concerned Utahns who wish to pass this heritage on to future generations. It includes a special reading by Pulitzer Prize winning author Wallace Stegner from his famous Wilderness Letter.

The University of Rochester Sierra Student Coalition and Rochester Regional Group of Sierra Club are cosponsoring *Wild Utah: America's Redrock Wilderness.* The program is free and open to the public.

This program will be hosted by Dave Pacheco. Dave has worked with the Southern Utah Wilderness Alliance for seven years after receiving a degree in Sociology from the University of Utah. He grew up in Utah and loves its wild landscapes passionately. Dave oversees a team of grassroots organizers across the nation and educates members and the public about current threats, actions, and events surrounding the Utah wilderness issue.

Two environmentalists - two styles. "Walkin Jim" Stoltz has devoted his life to tramping through

deep wilderness, walking over 25,000 miles in search of music and his soul. Those who attended his "Forever Wild" concert of songs, stories, poems and spectacular nature slides benefited from his vision of saving the last great American wilderness by creating a "Forever Wild" corridor from Yellowstone to the Yukon. Jim is a unique and exceptional environmentalist with a flamboyant road show.

In contrast to 'Walkin Jim' our Sierra Club Group has been lucky to have in our ranks another environmentalist with a totally different style who has worked quietly and effectively behind the scenes to help run our organization over a number of years. Dave Ruekberg, our treasurer, was responsible for organizing and running the "Forever Wild" show, which raised over \$500 for the group. #### What Kind Of Sustainability? Questions About the Future of Hemlock Lake Forest by Hugh Mitchell

The City of Rochester owns an old growth forest on the west side of Hemlock Lake. Two visions for the future of this forest are now under consideration. Both purport to be based on a philosophy of sustainability. But the question is "What *kind* of sustainability – economic or natural?"

In 1873, state law gave Rochester the right to preserve Hemlock and Canadice lakes as the source for drinking water. Since then the forests on the steep western side of Hemlock Lake have been untouched. As a result,

moderate logging will create "a younger, healthier, more vigorous, fast growing forest" which can be sustainably logged in the future. But is this the kind of sustainable future we want for a rare old growth forest?

The little-touched section of Hemlock forest is about half-a-mile wide and approximately 1,958 acres. No one knows exactly how many acres are true old growth forest. Considering the small size of this forest and the scarcity of old growth in this part of the country, we need to ask if it should be traded

for a young forest which can be exploited again and again. Wouldn't it be better to let this forest manage itself following its own well-developed sustainability scheme?

Most Sierra Club members

would support a sustainable yield of "forest products" as long as the forest remains unharmed and healthy. But the case of logging in or near old growth is different. It should be excluded from the economic equation because it is all that is left of the dream of Eden which the American continent gave to our ancestors. In the case of the Hemlock Lake west-side forest, we need to think beyond economics to natural sustainability.

A better answer would be to use the new road for access to the forest, and develop trails to the ancient hemlock groves so citizens can witness and appreciate a true old growth forest. I guarantee it is a spiritual experience to be in the presence of such greatness.
