PETER BUCK – A CLIMATE-ORIENTED CANDIDATE

The Sierra Club is proud to endorse **Peter Buck**, Democratic candidate for PA House District 171 in the upcoming General Election on **Tuesday**, **November 3rd**, **2020**.

Peter Buck demonstrates the knowledge, dedication, and energy to provide the proenvironmental leadership needed in Pennsylvania. The scientific community has been clear that we need to aggressively address climate change in order to protect people and the planet. Peter has pledged to work in a bipartisan partnership to address both environmental, social and economic concerns, and incentivize job creation and infrastructure improvements in environmentally friendly sectors. He is challenging incumbent Kerry Benninghoff, who has a lifetime Environmental Scorecard rating of 10%, and who often votes in support of legislation that advances the interest of polluters, not the interests of people.

Peter has a record of environmental service. He represented Ferguson Township on the Spring Creek Watershed Commission, volunteers in the watershed to monitor its waters, advances renewable energy at Penn State and in local and

regional government, and leads an environmental justice project. He has pledged to end subsidies for the fossil fuel companies and redirect those funds toward more socially responsible goals. He is supportive of land conservation, sustainable agriculture, and outdoor recreational opportunities. Peter has dedicated many years to protecting our environment and was active in the passage of the Community and Environmental Bill of Rights. As the former Chair of Ferguson Township Board of Supervisors, he helped secure the passage of a resolution that placed them on a path to net zero emissions. He has served on various intergovernmental agencies to promote increased energy efficiency, solar power, climate change mitigation and adaptation and the protection of our region's source water.

Additionally, Buck supports equitable funding for public schools, increasing the minimum wage, protection for our unions, and the advancement of rural people. He recognizes the impact of environmental hazards on our health, and believes strongly that everyone should have access to good health care.



RYAN GRIMM – AN **OUTDOORSMAN**

The Sierra Club proudly endorses Ryan Grimm, Democrat, for State Representative in District 75. This is an open seat and a great opportunity to elect someone who cares passionately about the environment and protecting the beauty of the area and the health of its residents.

Quick Tips to Make Your Vote Count on November 3rd:

- If you vote by mail, place your ballot inside the smaller "Official Election Ballot" security envelope before placing it in the mailing envelope. Seal both envelopes. Fill, sign, and date the Voter's Declaration on the back of the mailing envelope. No postage is necessary. - If you deposit your envelope
- in one of the official ballot boxes that are scattered throughout the Commonwealth, make sure it is an approved site. You may not
- deposit anyone's ballot other than your own.
- If you vote in person, please wear a mask.

- Only first time voters at a precinct may be required to show ID.
- If you obtained a mail-in ballot, but changed your mind and want to vote in person, bring the mail-in ballot to the polling place to be voided. Then you can vote a regular ballot.

This year there 4 two-year positions on the Moshannon Group's Executive Committee (ExCom) up for election by the membership (that means YOU!!). TRUMP'S ENVIRONMENTAL LEGACY: IS HE REALLY *THAT* BAD? ANSWER: NO – HE'S MUCH WORSE!

Maybe Donald Trump is from another planet — because he certainly doesn't value this one. In less than four years, he has rolled back at least 100 environmental rules and regulations. Here is a partial compilation of the environmental wreckage of the Trump administration. Don't give him another four years to destroy our home.

Jan 24, 2017 – Trump issues a memorandum calling for expediting permitting of the Keystone XL and Dakota Access pipelines.

Feb. 16, 2017 – Trump signs a Congressional repeal of the stream protection ruling for surface coal mining.

Aug. 15, 2017 – Trump issues an executive order removing a requirement that infrastructure projects must consider climate change.

Dec. 22, 2017 – Trump signs a tax-cut law that authorizes oil and gas drilling in the Arctic National Wildlife Refuge.

Dec. 29, 2017 – Bureau of Land Management relaxes regulations on fracking on federal and Indian lands.

April 11, 2018 – The Interior Department weakens protections under the International Migratory Bird Treaty Act.

July 30, 2018 – The EPA eases rules on storage of coal ash containing contaminants, including mercury.

Nov. 30, 2018 – Trump rescinds a ban on using seismic air guns to search for oil and gas under the ocean, imperiling whales.

June 19, 2019 – EPA removes electric utility emission limits aimed at reducing carbon emissions.

July 18, 2019 – EPA refuses to ban pesticide chlorpyrifos (causes neurological, developmental, and autoimmune disorders).

Aug. 21, 2019 – Trump gives states authority to set their own coal emission standards.

Aug. 12, 2019 – Trump weakens habitat protections under the Endangered Species Act.

Aug. 29, 2019 – EPA proposes eliminating rule that requires fracking operations to detect and fix methane leaks.

Sept. 12, 2019 – Trump (through the EPA and Army Corps of Engineers) repeals the protections of the Waters of the United States Rule.

Nov. 4, 2019 – Trump begins process of withdrawing the United States from the Paris Climate Accord.

Feb. 13, 2020 – Trump announces he plans to divert \$3.8 billion of military funds to build border wall which will block animal migration, destroy endangered species habitat, and dam watercourse.

March 31, 2020 – Trump revokes Obama-era mandate for improved automobile fuel efficiency. June 1, 2020 – EPA finalizes rule under the Clean Water Act, limiting state authority to impose clean water restrictions on projects seeking federal permits.
