Surfriders from the Rise Above Plastics Coalition will talk about plastics in our oceans. Each year humans are adding 8.8 million tons of plastic to the estimated 300 million tons of plastic that is already in the oceans. Why is this happening and what can you do to stop it? The RAP Coalition is educating consumers and recruiting "Ocean Friendly" restaurants and businesses willing to significantly decrease single-use plastic waste in addition to advocating for sustainable policy at the city, county, and state level.

<u>The Conservation Committee Report</u>: The Conservation Committee will meet on Monday July 9, and August 13, at 6:30pm. Join us at <u>St. Paul Lutheran Church at 5103 North Central Ave., Tampa, FL.</u> We meet in the <u>Snyder Building</u> directly behind the church. Follow the Tampa Bay Sierra Club signs.

<u>Silver Dollar Shooting Range Zoning:</u> County Commissioners denied the Silver Dollar zoning request! Thank you to everyone who contacted the county commissioners. You made a difference! They will now have to remove 3 Shooting Stands, in addition to the 3 already removed that were facing directly into the wetlands. This will minimize future contamination of the surrounding area from the lead shot. <u>Next Up:</u> Making sure the contamination is cleaned up and advocating for ELAPP to preserve the Clearwater Property.

<u>Hillsborough County Charter Review:</u> We are delighted that the proposal to change the county commissioners from 4 single district and 3 at large to 9 single district members was abandoned after a massive public outcry. Thank you all who voiced your opposition - your voices were heard.

Rocky Point - Open Water Fill for Townhouse Development: Sierra Club is working with the Dana Shores neighborhood association and other groups to oppose filling in part of the lagoon near Rocky Point to build townhomes. June 28: Item TA/CPA 17-10 requesting a land use change from Water to Residential-35 will be heard at Tampa City Council Meeting. Plan to attend or write the City Council members asking them to deny this proposal

<u>Trees:</u> The City of Tampa is updating its tree ordinance. There are two areas to watch:

<u>Tree Removal:</u> The builders would like more certainty that they can remove certain trees to build. Hence their proposal in February and the tree code amendment we've been opposing as currently written. Neighbors are interested in preserving the tree canopy. We are working on a solution that satisfies both satisfies both.

<u>Tree Mitigation:</u> A new proposal would require mitigation of any trees removed to be replaced not by equivalent trunk size, but by canopy size and other factors. We are hoping to add wording to get the replacement trees closer to where trees were removed, perhaps even on private property.

Sprawl Wars: Another plan to build dense developments in **Rural Land**, creating sprawl but asking to reduce land use fees! This one affects 4,413 acres in the Balm Riverview Area and would redefine the rural RP-2 designation from 2 homes per acre to 3 homes per acre. There is a total of more than 15,000 acres in this category in the county. There are two items:

Balm Riverview Comprehensive Plan Text Amendment application (CPA) 17-21 and companion.

Land Development Code (LDC) 18-0370 Text Amendment to LDC PART 5.04.00 PLANNED VILLAGE. Please plan to attend these upcoming Public Hearings, or write your County Commissioners asking them contain sprawl and to deny these two amendments.

<u>July 12, 6:30PM:</u> Public Meeting, Riverview High School, 11311 Boyette Rd., Riverview, FL 33569. This is an opportunity to hear the developers plan and provide feedback to them.

July 23, 5:30 PM: HCCC Planning Commission, County Center, 18th floor, 601 E. Kennedy Blvd. This is an opportunity to speak out to the County Commissioners against sprawl.

<u>Protection of Deep Sea Corals in Gulf of Mexico:</u> Sent a letter to the Gulf of Mexico Fishery Management Council urging increased protection in 15 hot spots and adding 8 sites as Habitat Areas of Particular Concern

Florida Judge Rules in Favor of Conservation Groups on Constitutional Amendment for Land Acquisition

Florida Circuit Judge Charles Dodson ruled today in favor of environmental organizations that the land conservation constitutional amendment overwhelmingly approved by voters requires funding to be used

75% YES on 1

for land acquisition, and restoration and management of those lands, not for other purposes. Frank Jackalone, Sierra Club Florida Chapter Director said, "After four years of blatant misappropriation of taxpayers' money, the Legislature has been forced by the Florida Courts to obey the voters mandate that it use a dedicated source of state funds to preserve and protect Florida's natural lands."
