# Remembering Kent Bailey

Kent Bailey was a passionate speaker on behalf of Tampa Bay Sierra Club and the environment. SIERRA

The Hillsborough County Environmental Protection Commission (EPC) will be honoring Kent Bailey with a Lifetime Achievement Award at their January 14, 21 meeting, tentatively set for 9 a.m. at County Center, 601 E. Kennedy Blvd., Tampa, but may be moved online due to COVID. Go to www.epchc.org in January for an update.

The chair of Tampa Bay Sierra Club and climate change activist died September 22 after suffering a massive heart attack. His accomplishments during the past decade are innumberable. He was a tireless advocate for the environment and had a huge heart. He was considered a local expert on sea level rise in the Tampa Bay region and was sought after a speaker at workshops, press conferences and panel discussions. He was respected by all who met him as a kind, honorable and passionate person.

One of his first and greatest accomplishments was spearheading the preservation of Cone Ranch (the Lower Green Swamp Preserve). At 12,800 acres, the preserve is now the largest undeveloped tract of land in Hillsborough County and a Hillsborough County ELAPP property that will never be developed.

The loss for our community, our State, and Sierra Club is immeasurable. We have lost a giant for the environmental movement.

Wesley Kent Bailey was married to Cathy Bailey, the father of six children and 22 grandchildren.

Conservation Committee Report: The Conservation Committee and Transportation, Water and Land Use Sub-Committees will meet Mondays, November 9 and December 14 at 6:30 PM via Zoom.

No Cementing the Wetlands! One of the last projects Kent worked on resulted in saving a portion of our Florida wetlands. Kent was outraged to learn that a homeowner was requesting a variance so he could put concrete on the wetlands in his backvard. He spent time researching, writing a letter, then going to a hearing to speak against the variance, which was denied.

**READY FOR 100:** We are working with a coalition of groups asking Tampa to join 167 other cities and commit to 100% clean renewable energy by 2030. City Council is working on a draft resolution. The Mayor has hired a Sustainability and Resiliency Officer who is working on a Climate Action and Equity Plan.

**M-CORES UPDATE:** The Florida legislature approved a bill to fast track three major new toll roads and the task forces for them have released their first draft report after months of meetings and tons of public comment, overwhelmingly negative.

Frank Jackalone, Sierra Club Florida Chapter Director and Timothy Martin, Sierra Club Florida Chapter Conservation Chair called it "a disastrous Toll Roads to Nowhere Bill that would be ruinous to the rural heartland of Florida and our state's nature coast. The urban sprawl that would accompany the new toll roads would be deadly, devouring hundreds of thousands of acres of rural and natural lands, fragmenting wildlife habitat and polluting our rivers, springs, lakes and coastal waters "

It faces broad public opposition and would cost more than \$135 million a year. The Multi-use Corridors of Regional Economic Significance program (M-CORES) task force released a draft report on Sept. 28th that questions the need for all three roads, expresses a preference for improving existing highway corridors, and asked that a "No build" option be considered in future project actions.

FDOT in October held M-CORES task force meetings and open houses to finalize the reports that will be submitted to

Gov. DeSantis and the Legislature on November 15.
