important to our food supply, to say nothing about how healthy their "golden nectar" is. Jan will also share a taste of honey with us following her presentation. Don't miss it!



Join us at **Westshore Audubon Sanctuary.** Volunteers Needed Tampa Bay Sierra Club and Tampa Audubon Society volunteers will partner to clean up the Sanctuary, a mangrove forest in a residential neighborhood, along Old Tampa Bay, which serves as critical habitat for many wading birds and marine life such as horseshoe crabs and juvenile fish.

Volunteers, please wear comfortable light weight long plants, closedtoe shoes, hat/ visor and sunglasses. Be prepared to get wet and muddy. Gloves, trash bags, water and a light snack will be provided. In addition to removing litter, we may also be tearing down and hauling out any illegal structures that have been built on Sanctuary property. This event is not recommended for young children.

<u>Conservation Committee Report</u>: The Conservation Committee and Transportation and Water Sub-Committees meet on Mondays, March 9 and April 13 at 6:30 PM at <u>St. Paul Lutheran Church, 5103 North</u> <u>Central Ave</u>, Tampa. We meet in the <u>Snyder Building</u>, directly behind the church.

The 2020 Tampa Bay Sierra Club Planning meeting resulted in 5 conservation goals and leaders.

- 1 Ready for 100 Tampa Linda Hugues
- 2 Transportation HART Electric Buses Christopher Gleason
- 3 Land Use Hold the Line on the Urban Service Area -Karen Michalski
- 4 Increase public awareness of sea level rise Kent Bailey

5 - Secure Conservation Easements. This fits in with the Sierra Florida Chapter conservation goal: Increase Protected Lands by 30% by 2030 and 50% by 2050 – Nancy Stevens Also a Tree Committee will be formed at the Florida Chapter Level.

Volunteers are needed for all the above initiatives, no experience needed.

**CLEAN AIR: Ready for 100:** Sign a petition to encourage Tampa City Council to work with Mayor Jane Castor, to commit Tampa for 100% Clean energy at <u>https://addup.sierraclub.org/campaigns/tampa-is-ready-for -100-clean-energy-for-all/petition</u>. LAND USE: To encourage development inside the Urban Service Area (USA) and protect Rural Land Use designation. Currently the county's low mobility fees subsidizes residential development outside the USA. New road construction cost including lights, sidewalks are prioritized with our limited county budget instead of infrastructure improvements throughout the county. On Wednesday March 4, 9 AM at County Center, Ordinance: "Hold a public hearing to consider the adoption of an ordinance to amend the County's Mobility Fee Program Ordinance in order to remove the RP-2 distinction in the rural assessment district." ACTION: Tell your County Commissioners who should pay for road costs in new residential development which destroy our open rural land. Please attend and bring a sign.

Zoning Hearing meetings: March 16th and April 13th at 6pm, learn about protecting our remaining Rural areas.

Planning Commission Meetings: March 9th and April 13th at 530pm, learn about protecting our Comprehensive Plan and holding the Urban Service Boundary.

**STOP PLASTIC BAGS ACTION:** Sierra Club Florida has created a campaign to ask Publix to stop using single-use plastic bags at check out. **Go to our website and Sigh the petition**. **Sierra Club's position is RE-DUCE, REUSE and RECYCLE - "not when it doubt throw it out".** We need and can do better for our oceans and our future.

## WATER: Benjamin Ochshorn, Water sub-committee chair

Southwest Florida Water Management District has issued a 5-year assessment of the Hillsborough River. Sierra Club has been listed as a stakeholder and is doing an analysis.

Senate Bill 1656/ House Bill 715: Reclaimed Water. At the time of article submission, the draft bill includes:

#### **Continued from Page 3 - Conservation Committee Report:**

★ Prohibition against Surface Water Discharge – with exceptions: Implementing a statewide prohibition seems unnecessary and possibly dangerous, as well as expensive- costing an estimated \$28 Billion – which would be billed to water users. Justified as a way to provide more water when water conservation would reduce demand – why should we be watering our lawns with drinking water while we are forced to drink sewerage water? Tampa is investigated a variety of methods to provide sufficient water.

★ Potable Reuse: Sets rules for using sewerage water for drinking water. It is critical that the water is safe for people and for the Florida aquifer. The water must meet not only existing standards, but also must have safe levels of "Constituents of Emerging Concern," which are potentially dangerous components found in sewerage for which safe levels are disputed or not known.

★ Greywater Incentives: require incentives to developers to reuse water

**TREES:** back on our list because Florida HB 1159 stripped out some tree ordinance protections. The International Society of Arboriculture (ISA) has a certification process, and training for arborists to identify unsafe trees but no separate certification.

**M-CORES:** Contact FDOT <u>fdot.listens@dot.state.fl.us</u> and let them know that you oppose the M-CORES project: 3 new major toll roads that will destroy large swaths of Florida's last remaining rural lands, pollute waterways, and threaten endangered wildlife including the iconic Florida panther.

## **Transportation Committee report:** Current - HART PRIORITIES

1. Tampa Streetcar Extension and Modernization (Tampa) 237 million in capital costs paid by Federal Transit Agency (FTA), FDOT and local. Ten to twelve modern streetcars added for service with completion date of 2024-2025. Modernization is 2.7 miles, extension is 1.2 miles, north to Palm Ave by Florida Ave and Tampa St back south to original endpoint.

- 2. Bus Rapid Transit (BRT) Arterial USF to Downtown Tampa Study (HART)
- ★ · Nebraska Ave, Florida Ave, Linebaugh Ave, & Fowler Ave. Increases connectivity, safety for walk/bike, and quicker travel times with 60%-75% dedicated bus lanes.
- ★ · Florida Ave North to Linebaugh Ave East to Nebraska Ave North to Fowler Ave East to University Area (USF), going south it uses Tampa St as Florida Ave becomes one way..
- 3. Regional Rapid Transit Study (TBARTA)

★ • Connecting Pasco to Pinellas through Hillsborough County, Wesley Chapel to downtown St. Petersburg. 13 stations along 41 mile route along I-275, desired 10 minute frequency is impossible using elevated expressway.

Six options for project moving forward: No Build! (our preferred option), no stations, or four with escalating costs and increased dedicated lanes.

NOT ON LIST: Ferry Project from South County to MacDill AFB/South Tampa Commuter Route, with non-peak service to Downtown Tampa and St. Pete

## Sierra Club files lawsuit to Save the Serenova!

On February 6 the Sierra Club filed for a suit to challenge the Army Corps of Engineers permit to build the Ridge Road Extension thru the Serenova Preserve. Along with the lawsuit, we filed for an emergency injunction to immediately halt construction. Already dozens of gopher tortoises have been

excavated from the area. Native burrow habitat for over 300 specialized species, including the endangered Eastern Indigo Snake has been wiped away. Land has been cleared. Wetlands are being filled.

The planet is at a crisis point. We can't afford to lose more of our large natural areas to sprawl. This 6500 acre preserve was purchased and presented to the citizens as compensation for the ecological damage caused by the Suncoast Parkway alignment. It was given to the citizens in perpetuity. It provides abundant wildlife habitat and is the southern anchor of the Cross Bar/Starkey wildlife corridor. The proposed Ridge Road Extension is nothing less than a generational betrayal of a sacred trust and promise.

The Sierra Club is a non-profit, and picks our battles wisely, but think we have a very good case. We need your help.
