Anne McEnerny-Ogle is running for re-election as mayor of Vancouver and has been endorsed by the Sierra Club. She is closely aligned with the values of the Sierra Club. All questions in her endorsement interview were thoroughly answered with concrete examples of the ways she is working towards a cleaner, safer, and more equitable city, When talking about the climate action plan that targets emissions reductions by 80% by 2030 and carbon neutrality by 2040 with much depending on PDX and Clark public Utilities. She doses favor mass transit lanes on the I-5 bridge. She strongly is in favor of preserving and adding trees and adding to the tree canopy. Anne wants to add air quality measuring equipment in Vancouver.



Vancouver Lake is an Economic Asset

Have you thought much, or spent time, at Vancouver Lake recently? If you have, you may be aware that "Van Lake" is a gem and very much an economic asset, for Clark County and nearby areas in SW Washington.

However, Vancouver Lake mostly gets overlooked by the governmental bodies who should be, but aren't, taking care of it. In recent years, infestations of Eurasian milfoil and toxic algae blooms have made the lake off limits to many residents and users. Thanks to the efforts of Friends of Vancouver Lake (FoVL), the milfoil was treated and is now nearly entirely gone. Toxic algae remains a problem during hot weather.

A 2015 study of Vancouver Lake by Portland State University geologist Curt Peterson found that "future maintenance and preservation to be entirely dependent on restoring floodplain groundwater levels and corresponding lake water levels." Historically, the lake flooded annually and had abundant and healthy water. Then, dams were built on the Columbia and altered the floodplain. Periodic closures of the lake force cancellations of sailing, kayaking and rowing activities as well as swimming.

A public-private partnership is needed to acquire and direct funding to restore and maintain the lake. Obvious choices are the ports of Vancouver and Ridgefield, working with the Corps of Engineers. Vancouver Lake is important to residents and should not be dismissed as a frill. Good or bad, it will make its presence known.

Following national Sierra Club's outings restart on July 5, Loo Wit has offered and scheduled five outings, on July 28 and Aug. 12 (sea kayak), Oct. 1 (cycling), Oct. 14 (sea kayak) and Oct. 21 (cycling). No hiking outings were scheduled due to no available hike leaders. Outing signups on Loo Wit's Meetup site were good, with good responses after a very long pause – since mid-February of 2020 due to Covid.

Sea kayak outings were held on Lake River (July 28) for beginners/novices, and at Scappoose Bay on Aug. 12 for intermediate paddlers. Participants returned to Scappoose Bay on Oct. 14. Cyclists rode to Vancouver Lake/Frenchman's Bar County Parks on Oct. 1 and pedaled the Burnt Bridge Creek Trail in Vancouver on Oct. 21.
