#### **DuPont State Forest: Protected lands and Blue Ghost Fireflies**



Join us on Wednesday, May 1 when Jeff Jennings, a former engineer with DuPont Chemical in North Carolina, will discuss how DuPont State Forest, a 10,415-acre wooded area located between Hendersonville and Brevard, was protected from private development.

Also presenting will be Dr. Jennifer Frick-Ruppert, Professor of Biology and Environmental Science at Brevard College, who will describe the Blue Ghost Firefly, one of the charms of DuPont Forest.

The Blue Ghost Firefly, is a lampyrid beetle found in the southern Appalachians, especially in DuPont State Forest. Observed primarily in May and June, they have a luminescence characterized by a steady glow, in contrast to a species-specific pattern of flashes. They may emerge as early as April or as late as June or July, depending on elevation and climate and are usually found in shady, moist habitats, characterized by a thick, spongy leaf litter and dense tree cover.

Jeff Jennings is an engineer and small business owner

who lives with his family in Mills River. He moved to WNC in 1991 to work as an engineer at DuPont's Brevard Site, which is now DuPont State Forest. An avid hiker, he quickly became active in local environmental groups. When DuPont announced plans to sell 7600 acres of forest surrounding the plant in 1996, Jeff organized a successful Jennifer Frick-Ruppert



effort to have the State protect the land. Working closely with Chuck McGrady of the Carolina Mountain Land Conservancy, as well as Rex Boner and Dick Ludington at the Conservation Fund, they succeeded in preserving this pristine wilderness area.

Dr. Jennifer Frick-Ruppert is a Professor of Biology and Environmental Science at Brevard College, where she has taught since 1997. She earned her Ph.D. in Zoology from Clemson University in 1995. She teaches courses in environmental perspectives, biodiversity, biology, and natural history and was awarded the 2003-2004 Award for Exemplary Teaching. Originally from South Carolina, Jennifer grew up with a love of nature and an appreciation for her surroundings. Her long awaited book, Mountain Nature: A Seasonal Natural History of the Southern Appalachians, was published in 2010 by UNC Press. It has received several notable reviews for its quality and lively writing style and was a finalist in the Philip Reed Memorial Award for Outstanding Writing About the Southern Environment.

### **Our Mountain Treasures: The Future of Our National Forests**

On Wednesday, June 5, join us for a presentation by Jill Gottesman, outreach coordinator for The Wilderness Society, to discuss the future of our national forests.

Every 10-15 years, our National Forests get a fresh look and a revision on their

management plans. Pisgah and Nantahala are overdue, but the process is underway and it is time to speak up for our forests. The United States Forest Service is well into their first year of the plan revision process and asking the public for input on the management future of these public lands. During this presentation, Jill will give an overview of the multi-year plan revision process and describe how interested citizens and groups can participate. She will

also describe The North Carolina's Mountain Treasures Campaign, the over 300,000 acres of western North Carolina for which The Wilderness Society, the NC Sierra Club, and other partners hope to gain better protective measures in this new Forest Plan.

Come ready to be inspired by spectacular photos and by the incredible opportunities ahead.

Jill Gottesman brings the skills of a diverse work history in nonprofit management, environmental education, wilderness therapy and social work to her role of Outreach Coordinator for The Wilderness Society's southeastern regional office. Before joining The Wilderness Society, she was Outreach Director at Georgia ForestWatch. She received her BA in Recreation and Resource Management from the University of GA, and her Master of Social Work degree from the University of NC Chapel Hill, but regards her years working and studying in the outdoors all across the country as the most valuable experiences of all.

## State Issues Update By Ken Brame

## Sign on-line petition to Gov. McCrory to proclaim June as "Solar Month"

While mostly symbolic, the proclamation would recognize what the solar industry contributes to our state: that it generates \$1.7 billion dollars and has more than 1,100 companies employing 15,000 people, including western North Carolina's own FLS and Sun Dance. The petition encourages more solar and clean energy companies to locate here, and most of all, sends the signal to clean energy opponents that this industry is not just thriving, but it is here to stay. #### **Renewable Energy Portfolio Standard (REPS)**

North Carolina state legislature introduced two bills to repeal the Renewable Energy Standard. H 298 and S 365 not only get rid of our clean energy standard, they remove wind energy from the definition of renewable energy. They also reclassify peat, fossil fuels, and nuclear energy as renewable sources. Please contact your state legislators listed below to ask for a vote against any attempt to change the NC Renewable Energy Standards.

**Fracking** - This year's 2013 NC state legislature passed a new Senate bill, S 76 on fracking that wiped out last year's promise that no fracking permits would be issued without a separate vote of the legislature. Please contact your state legislators (below) to ask that they vote to review the Mining & Energy Commission's recommended rules to be sure they are adequate before fracking permits are issued. State that consumer protections in last year's fracking bill should be upheld, that fracking wastewater underground in NC is a bad idea, and that lawmakers shouldn't rush oil & gas development by removing protections for the public.

Building Codes - The NC legislature is considering bills,

HB 120 and SB 108, to move to a 6-year cycle for improving residential building codes (versus the long-standing 3-year cycle). The bill also proposes to shift code interpretation away from the state's professional building inspection departments and code officials and, instead, be conducted by the NC Building Code Council. There are so many reasons these are bad ideas – from hurting home buyers and future home owners, to the 75+ and 100+ year impacts of these decisions, to insurance rate risks, to making the state less attractive to businesses moving in, to making it harder on builders with big changes every 6 years compared to small, incremental changes every three. Please protest to your legislators.

**Good News** - The State Dept. of Environment and Natural Resources filed a lawsuit seeking to force Progress Energy to stop leaking toxic pollutants from the Asheville power plant's coal ash ponds into groundwater and the French Broad River. The suit comes 2 months after a notice of intent to sue Progress Energy over the coal ash pollution was filed by the Southern Environmental Law Center on behalf of the Sierra Club, Waterkeeper Alliance and Western North Carolina Alliance, stating Progress Energy is in violation of the Clean Water Act.
