Biofuels: A Fully Integrated Local Energy System - Feb. 5

Join us on Wed., Feb. 5 at 7 pm to welcome Melita Kyriakou who will discuss Biofuels. No business exists in a vacuum: output from one becomes the input for another in an interconnected web. Melita Kyriakou will explain how Blue Ridge Biofuels set out to become a community fuel provider seeking to improve our region's air quality and fuel security. Blue Ridge Biofuels did so by capturing a valuable resource generated in WNC for use as biodiesel fuel for vehicles and heating homes. Besides discussing biodiesel, she will talk about her company's other projects, including the Cooking Oil Recycling Program and the F3 Project: Field to Fryer to Fuel. By diversifying the company and offering new and innovate services and products, BRB is working to increase the sustainability and resiliency of our local communities. Beyond Coal: Success and Future Plans - Apr. 2

Join us on Wed., April 2 at 7 pm as Asheville Beyond Coal organizer Emma Greenbaum presents an update on past successes and plans for future campaigns.

2013 was a red letter year for the Sierra Club Asheville Beyond Coal campaign. Through smart organizing and advocacy, local lobbying, and litigation, the campaign has made great strides toward retiring the Asheville Coal Plant and moving

Western North Carolina onto homegrown, clean energy solutions.

To date, 152 coal powered plants have been closed throughout the United States. In Asheville, 5,500 petitions

were delivered to Duke Energy requesting the retirement of the Asheville Power Plant with transition to clean energy. Come learn about the big successes of last year, including the City of Asheville Clean Energy Resolution and the Rally for Our Future that was held in August. Learn how you can engage in the fight against climate change right here in Asheville!

Emma Greenbaum joined the Seirra Club's Beyond Coal campaign in September of 2012, after serving a year with Green Corps, the field school for environmental organizing. During her time with Green Corps, she worked on several campaigns including the successful Beyond Coal campaign in Chicago, IL and Food and Water Watch's Fair Farm Bill Campaign in New York state. In August 2010, Emma graduated with her BA in Economics and International Development, with a focus on Latin America. During her time at American University, she was a student leader and organizer, working on campaigns ranging from fair trade to workers rights on campus.

EPA creates 'carbon pollution standard' for new power plants

The Environmental Protection Agency (EPA) has published a groundbreaking new proposal, creating the first-ever federal carbon pollution standard for every new power plant built in America. This is a game changer for the climate — especially because power plants are our single largest source of carbon pollution.

Stand with the Sierra Club and support this groundbreaking regulation to ensure a cleaner, healthier future for everyone.

The unlimited dumping of carbon pollution is the chief cause of climate change. Reducing the amount of carbon pollution from power plants is a life-saving measure that will protect our children, our nation and the world from the devastating effects of climate change. The EPA needs to hear from you - add your voice in favor of this historic regulation!

We have 60 days to tell the EPA we support this effort to reduce the deadly effects that carbon pollution has on the health of our children and our environment. Corporate polluters are already doing everything they can to block this important health protection. Will you join others around the country in saying you believe we must put people before polluters and protect our children and future generations from climate change?

Buncombe County passes 80% carbon reduction resolution

On December 3, 2013, the Buncombe County Commission adopted a resolution calling for an 80% carbon reduction goal with at least 2% per year reduction. They also approved investing the first \$800,000 in energy efficiency initiatives over the next few years (which will save the county over \$175,000 per year in energy costs). The vote was 5-2 in favor, including moderate Republican commissioner David King.

About 50 supporters turned out for the commission meeting. Supporters spoke from several environmental

organizations, clean energy and energy efficiency businesses. Three of the five commissioners who voted in favor, including David King, Holly Jones, and Brownie Newman attended the local WENOCA Sierra Club group holiday party and awards ceremony on Dec. 4 to thank the group for their contribution. David Gantt and Ellen Frost also voted in favor. Brownie Newman, the sponsor of the initiative, gave credit to the Sierra Club for the huge volume of emails and calls the commission received. He went as far as to say that without the Sierra Club's advocacy, the resolution may not have passed, and certainly would not have passed with the same vote count. This is a great step forward for the county and our region.

SAT, FEB 22 - HIKE RATTLESNAKE LODGE & BEYOND – Approx 5.2 miles round-trip on this mostly easy hike. will start at Ox Creek Rd and stay mostly on Mountains-to-Sea trail, then on to the Main Reservoir trail for some variation on the theme. Plan to learn about the interesting remains from the old Rattlesnake Lodge, which burned down in 1926. It's a nice place to stop for lunch, too. Wear good foot wear and bundle up. Please email or write hike leader if you'd like to bring your well-behaved doggie - who must be on leash at all times. Meet at 10:30 am in Asheville, back around 4:30 pm. SAT, MAR 22 - GREEN RIVER GAMELANDS - PULLIUM CREEK TRAIL - Moderate with some easy level of difficulty. Approx 6.5 miles round-trip on this there & back trail with elevation gain of 900 ft. Meet in Asheville at 10 am and return about 5:45 pm. It's a beautiful trail that ends up at the Green River just below the narrows, with rapids moving through large boulders. On the way, there's a tedious creek crossing with wiggly step-stones, so wear good footwear and consider a hiking pole. Plan to learn about the beautiful early-blooming wildflowers there as well. **NOTE:** Sorry, no doggies this trip due to Pullium Creek crossing. SAT, APR 19 – DEVIL'S COURTHOUSE TO FLAT LAUREL CREEK TRAIL – Distance is approx 6 miles, rated as moderate/easy. This hike offers some beautiful vistas in addition to the panoramic view from Devil's Courthouse. Learn about the ravens which congregate on the rock outcrops along the trail, and learn to identify them. Not a great deal of elevation change - around 500 ft. However, the Mountains to Sea section is rather rugged, with intermittent tree roots and 10" steps/rocks. Makes good footwear essential, and may be hiking poles as well. We'll be doing a loop from Black Balsam parking area to MST going to Devil's Courthouse. Then we'll return via Little Sam Knob trail, which takes us to the Flat Laurel Creek trail. From Devil's Courthouse, there is view of mountains across two state lines if visibility is good. Meet in Asheville at 10 am and return around 5:30 pm. This hike is for experienced hikers only. Hard 2 Recycle Event held April 26

A Hard 2 Recycle event will be held on Saturday, April 26 from 8 am - 1 pm at the City Tail Gate Market, 161 S. Charlotte (Public Works Building) in downtown Asheville. The free public collections are held quarterly in different areas of Buncombe County, as well as one in downtown Asheville, to bring awareness to other consumer items that may be recycled.

The goal is to educate, collect and divert items that would normally end up in the landfill such as styrofoam, electronics, blankets, batteries, used cooking oil, metal, wiring, pet foods/cleaning supplies, hard-covered books, eyeglasses, art supplies, musical instruments, etc.

There is a \$6 handling fee to recycle TV's and CRT computer monitors. To check out the complete list of items you may recycle and sign up to receive future event notices, go to www.ashevillegreenworks/hard-to-recycle.html.
