PETITION FOR REVIEW

Pursuant to Section 19(b) of the Natural Gas Act, 15 U.S.C. § 717r(b),
Federal Rule of Appellate Procedure 15, and Circuit Rule 15, Rogue Riverkeeper,
Rogue Climate, Cascadia Wildlands, Center for Biological Diversity, Citizens for
Renewables/Citizens Against LNG, Friends of Living Oregon Waters, Oregon
Physicians for Social Responsibility, Oregon Wild, Oregon Women’s Land Trust,
Sierra Club, and Waterkeeper Alliance hereby petition the United States Court of

Appeals for the District of Columbia Circuit for review of the following orders of the Federal Energy Regulatory Commission (“Commission”):

1. Order Granting Authorizations Under Sections 3 and 7 of the Natural Gas Act, *Jordan Cove Energy Project, L.P., Pacific Connector Gas Pipeline, L.P.*, 170 FERC ¶ 61,202 (March 19, 2020) (certificate order);
2. Order Granting Rehearing for Further Consideration, *Jordan Cove Energy Project, L.P., Pacific Connector Gas Pipeline, L.P.*, FERC Accession No. 20200518-3010 (May 18, 2020) (tolling order); and
3. Order on Rehearing, *Jordan Cove Energy Project, L.P., Pacific Connector Gas Pipeline, L.P.*, 171 FERC ¶ 61,136 (rehearing order)

The certificate, tolling, and rehearing orders are attached as Exhibits A, B, and C, respectively. In accordance with Federal Rule of Appellate Procedure 15(c), a list of the parties served with copies of this Joint Petition is attached as Exhibit D.

All of the petitioners were intervenors in the Commission proceedings below. Petitioners timely filed a request for rehearing of the certificate order, which was denied by the rehearing order. Thus, this Court has jurisdiction to review the Order Granting Authorizations pursuant to 15 U.S.C. § 717r(b).

This petition for review is timely filed within 60 days of the Commission's denial of rehearing in accordance with 15 U.S.C. § 717r(b).
