## Sierra Club and Allies File for an Injunction to Restore Amendment 1

The Sierra Club, the Florida Wildlife Federation, St. Johns Riverkeeper and the Environmental Confederation of Southwest Florida represented by Earthjustice filed suit today asking the courts to force the Florida Legislature to return Amendment 1 funds to a conservation land buying fund.

"We are asking for Florida's courts to uphold the constitution as amended by the voters," said Sierra Club Florida Conservation Chair Tom Larson. "The legislature needs to be held accountable for ignoring the will of the people."

The funds from documentary stamps on land transactions, which are expected to reach \$740 million next year, were diverted by the Legislature to accounts that had nothing to do with land acquisition. Among other things, they were used to pay state executive salaries, ag-

### A Letter to the Editor

### Response to Paul Caragiulo: Hunting on Conservation Land (Herald Tribune, Sept 2, 2015)

Paul Caragiulo's opinion piece defending his vote to endorse hunting on environmentally-sensitive lands is articulate and calmly rational. I especially appreciate his expressed desire to preserve more land. I hope he backs it up by re-funding the Environmentally-Sensitive Lands program. He omits one key detail, however, in his zeal to make his opponents seem hypocritical: the language enabling the Environmentally-Sensitive Lands program calls for recreational, aesthetic and *non-consumptive uses only* (emphasis mine).

Non-consumptive uses do not include hunting. State and Parks statute and regulations are very clear on that point. Killing an animal consumes it, and removes it

from its place in the natural native landscapes the ESL program was established to preserve. A landscape without its animals is a Potemkin Village, in which all the props may be there but the functions are gone.

It is disingenuous of Mr. Caragiulo to cite Sierra Club policy, a last resort for distressed and overburdened ecosystems, when there is only one species that is experiencing overpopulation in Sarasota County – feral hogs – but there is plenty of evidence for species extirpation, thanks in large part to the generosity of this Commission toward the development industry.

If the past offers a window to the future, the management plans we will see for these lands will be shams, prepared behind closed doors with special interests at the table and opposing voices shut out of the process. They will be justifications for an a priori conclusion.

I don't care whether Mr. Caragiulo takes his kill home to the freezer. It's disregard for the legal basis of ESLs that bothers me – and should bother all of us.

the intent of the voters in the use of the funds placed in trust under this constitutional amendment."

The November 2014 ballot summary stated: "Funds the Land Acquisition Trust Fund to acquire, restore, improve, and manage conservation lands including wetlands and forests; fish and wildlife habitat; land protecting water resources and drinking water sources, including the Everglades, and the water quality of rivers, lakes and streams; beaches and shores; outdoor recreational lands; working farms and ranches; and historic or geologic sites, by dedicating 33 percent of net revenues from the existing excise tax on documents for 20 years."

An extraordinary 75 percent of the electorate voted for Amendment 1 proving that the people of the state understand the need to protect the richness of Florida's wild heritage and unique waters.
