WHAT TO BRING ON SPRING OUTINGS: Prepare for a variety of conditions. Bring water, lunch and snacks, layered clothing, hats, gloves, sunglasses, insect repellant, appropriate sturdy footwear as well as skis/snowshoes if appropriate. ALL OUTINGS INCLUDE CONSERVATION EDUCATION ACTIVITIES!

That way, the leaders will know ahead of time how many people to expect. Requiring an RSVP call or email ahead of the outing is an experiment which we will continue through July. - Thursday, June 7, (late afternoon), Explore the Geology of Doe Ridge. A geologist will join us for a 1.5 mile walk in the rolling terrain of Doe Ridge, featuring geologic phenomenon and beautiful views. There will be some cross country so wear sturdy shoes, bring water and if you have binoculars bring them. To RSVP and for further information contact Mary 805-217-5563, marymikeshore@gmail.com.
- Sunday, June 10, (morning), Coldwater Campground to Red Lake. Begin at the Coldwater campground in the Mammoth Lakes Basin, and hike on use/game trails to Skelton Lake, pass some mining ruins to explore before arriving at Skelton Lake, then hike gently uphill along a creek to Woods Lake, then down to Red Lake, and back down to Skelton Lake via another stream which often has lots of trout visible. There are also several beautiful meadows, a couple of waterfalls, and possibly wildflowers. From Skelton Lake either return to trail head via same game/use trails, or via the Duck Lake trail if participants prefer. Total hike will be around 7 miles, elevation gain is approximately 1300 ft. - The State Mining and Geology Board has opened the discussion for changes to the state's backfill requirements for metallic mining (i.e. gold mining). Opening up the current regulations to change will most likely loosen regulations, not strengthen them. Reclamation regulations appropriately require mining companies to clean up their toxic wastewater, fill in the pits, and lower the height of the waste mounds for safety. Companies are to grade the slopes to match the natural contour as much as possible and replant so the land can be re-purposed. Any loosening of these regulations will invite more pit mining in California. The next public meeting is June 13, 9am-12 pm, in Sacramento. Please come if you can! - Write Mayor Garcetti and ask him to not reduce or eliminate irrigation on their Mono County lands. LADWP initially notified ranchers, who lease DWP property in Long Valley, Little Round Valley, and Round Valley that they may not irrigate their fields. Then LADWP backed off and will allow the ranchers to irrigate this summer with a reduced amount until they can prepare an environmental assessment. ROLG is monitoring this issue and is preparing a letter to the LA Mayor in response. - Visit Conglomerate Mesa! It is a wonderful place adjacent to a forest of Joshua Trees. The BLM decided to allow exploratory drilling here but is requiring the mining company to bring in drilling equipment by helicopter. Water will be trucked in once a day. Although this phase of the project has a smaller impact on the environment (noise, night lights, and dust), it could lead to a pit mine with cyanide heap leaching that will destroy the mesa morphology, its unique geology, and wilderness qualities. See the Briggs Mine in Panamint Valley for an example of what Conglomerate Mesa could turn into. - Good News: The American Pika has often been regarded as seriously threatened by climate change pushing the species to higher and higher elevations in order to survive until they had nowhere further "up" (and cooler) to go to. New studies show the cute animals can adapt better to hotter and drier as well as colder and wetter habitats than previously thought. - In the latest development to the conflict of the Mammoth Community Water District with Ormat's **geothermal expansion**, including new drilling, MCWD has requested the reopening of the Environmental Review of Ormat's already approved drilling plan. MCWD cites new evidence that (they say) provides conclusive evidence that geothermal fluids are in Mammoth's groundwater basin. More: https://www.sierrawave.net/mcwd/.
- Responding to lawsuit by four environmental organizations, federal judge Joseph Spero has rejected the US Fish and Wildlife Service's 2015 decision not to list the as endangered the Bi-State Distinct Population Segment of **Greater Sage Grouse**. Total population of Bi-State sage grouse is estimated at a little under 10,000 individuals in a few adjacent counties in California and Nevada. USFWS had cited the collaborative plan developed by federal, state, and county leaders (including ranchers and energy producers) to preserve the species. The judge noted the elements of the plan were not mandatory and did not ensure the preservation of the species. The judge did not mandate endangered listing but ordered a hearing to address steps to be taken in the light of his decision. - In May, California became the first state to require that almost all new single-family homes have **solar panel power** starting in 2020. Currently about 20% of new homes include solar panels.

- After extremely **high tree mortality** in California forests over the past two years due to the combined effect of drought and Bark Beetles, the Bark Beetle forecast for 2018 foresees significantly less tree mortality. The estimate is between 3 and 26 million projected tree deaths in 2018 compared to 27 million in 2017 and 62 million in 2016. - On April 28, California met 73 % of its electric power needs from renewable energy sources.

- Although funding for the **Yucca Mountain nuclear waste repository** was deleted from the Trump's final budget, the issue is back in the news with proposed legislation sponsored by California Representative Darrell Issa that would re-start the development of the repository and increase its capacity from 70,000 to 110,000 metric tons. Inyo County Supervisors have been concerned about reopening the project located 17 miles from the Inyo/Nevada border. More: https://www.sierrawave.net/yucca-mountain-repository-back-in-the-news/.
