RE: Nebraska 2019 Legislative Session, Week Ending January 18

WEEK IN REVIEW

Friday, January 18th was the 8th legislative day. Bill introduction ends on the 10th legislative day, Wednesday, January 23rd. Hearings are just now starting to be scheduled.

On Monday, January 14th we gave a legislative briefing at the Missouri Valley Group's Executive Committee meeting. We will give a comprehensive legislative briefing to the Nebraska Chapter's Executive Committee at its Saturday, January 26th meeting; after bill introduction ends on Wednesday the 23rd.

Additionally, on Thursday, January 24th we will give to the membership a public legislative briefing during the Sierra Club's regularly scheduled program meeting. This will be at 7:00pm at the First United Methodist Church, 7020 Cass Street.
