#### 2018 LEGISLATIVE SESSION

The 2018 legislative session was unique in many ways. This was not simply the "2<sup>nd</sup> Session" of our state legislative cycle that began in 2018, it was technically the "3<sup>rd</sup> Session" due to a "Special Session" being called in late 2018 to solve the State's numerous budgetary holes and problems. The "Special Session" was overall a complete failure.

As for the "2nd Session of the 56th State Legislature," the way the Oklahoma legislative cycle functions, allows for certain bills (specifically, bills that were not outright killed in the 2018 session) to be "carried over" to the 2018 session. Happily, we monitored these carryover bills (in addition to reviewing ALL the NEWLY filed legislation), and the "carryover bills" of most concern to Sierra Club and other like-minded groups (HB2318 and HB2132, so-called "Prosperity District" bills which we helped hold back in 2018) were killed this session. We breathed a sigh of relief once these bills were formally dead.

The biggest fight of all this session was around funding (and how TO fund) education and vital services. It started with the "Step Up" plan, which your Oklahoma Chapter proudly helped defeat, and ended with a modest success by getting rid of bad ideas like taxing wind with a gross production tax, and getting the ACTUAL gross production tax on oil and gas raised back to 5%— the Oklahoma Sierra Club firmly pursued taking the gross production tax back to 7% (previous to 2014, Oklahoma paid a 7% g.p.t., one of the lowest in the nation; and now at 5%, we are still the second lowest g.p.t. in the nation).

Lastly, it must be noted that the Speaker of the House, Representative Charles McCall, clearly played ugly partisan games this session, going so far as to table legitimate requests made on the House Floor, while also refusing to allow bills to be heard that had overwhelming public support, such as the bill that would have ENDED the Capitol Gains Tax, saving Oklahoma taxpayers roughly \$400 million per year.

#### A FEW BILLS THAT DID NOT MAKE THE SCORECARD

- HB2638 was simply a repeat of a bad idea that your Oklahoma Chapter of Sierra Club defeated with a formal lawsuit in the summer of 2018. This bill sought to "tax electric vehicles and hybrid vehicles," at rates completely out of line with their environmental impacts and at rates higher than what gas-powered vehicles pay in Oklahoma. Well, we did it again—this bill never even got a vote on the floor.
- HB2756 (later converted to HB1532); this bill would have created incentives for the purchase of electric vehicles and installation of public and home EV charging stations. This bill would have also extended, revised, and puts some limits on tax credits for compressed natural gas vehicles and fueling stations. This bill was heavily lobbied against by the oil industry and, sadly, did not pass.
- HB3337 must be discussed due to our success in preventing this bill from moving forward with a potentially tragic clause that would
  have allowed for the State of Oklahoma to establish a government agency capable of selling Oklahoma's water to other entities, including
  the State of Texas. The Oklahoma Chapter of Sierra Club has been fighting back this terrible idea for years, even going so far as to
  establish a formal white paper and position on what are known as "Interbasin Water Flows" which in short assure that water systems are
  not so damaged by drawing out water from a basin that it impacts downstream ecosystems. We lobbied hard, and we helped kill this bill
  once again
- HB3210, known to us simply as the "Pro Solar Energy Bill," was introduced by Representative Claudia Griffith, and we are happy to share that

this bill grew out of an Interim Study held in December of 2016 at the Oklahoma State Capitol that your Oklahoma Chapter of Sierra Club organized. Sadly, Representative Pfeiffer (Chair, House A and B; Natural Resources and Regulatory Services) and then Representative Watson (Chair, Natural Resources) refused to give this bill the time of day, and it died in committee.

• We are happy to share that the "Agricultural Drone Bill," HB3132, was finally put down as well. This bill was a very clear attempt to insulate corporate farms and agriculture from public view. We are very proud to have led the charge on killing this terrible bill, for both citizens AND animals!

#### SUMMARY OF MAJOR LOBBY AREAS

The Oklahoma Chapter of Sierra Club, by way of a Legislative Committee, a full-time lobbyist, and the efforts of the now-seasoned Red Earth Citizen Lobby Corps, lobbied 16 separate bills this session using "legislative alerts," emails, phone calls, and most importantly weekly face to face meetings at the State Capitol. Sierra Club made sure that Oklahoma's Senators and Representatives knew what we were concerned about, and what we believed was best for protecting Oklahoma's air, land, and water. For 2018, we were also aided by Oklahoma Beyond Coal's "Online Advocacy" team for amazing member outreach.

#### Wind Energy Had Some Vocal Support

This session was a HUGE victory for wind energy. Most importantly, we DEFEATED SB 888! SB888 needs to be discussed as evidence of what happens when "lobby powers" combined with poor legislative processes combine to take a bill that originates as one issue (and a GOOD issue we must add), is then completely subverted into a BAD bill on a completely different issue. SB888 started out as a bill that would have eliminated the subsidization of the sale of ethanol at gas stations—but ended up being a very bad "anti-wind business" bill. Luckily, we helped to defeat this horrible end-of-session legislation with a strong and impressive lobby effort combining all three arms of Oklahoma Sierra Club/ Red Earth Lobby Corps/ Oklahoma Beyond Coal.

#### Renewable Energy Had its Day in the Sun

Your Oklahoma Sierra Club not only helped create an "Interim Study on Solar Energy," we also once again hosted an annual "Lobby Day"— and once again we focused on educating legislators on the truths and facts and on-the-ground-realities regarding renewable energy in the State of Oklahoma. We are second in the nation in wind, our solar potential would put us sixth in the nation, and we are a Top 20 state nationally in "total renewable energy production. Given the economic benefits, we see this continuing as a cornerstone of our legislative efforts for the next 3 years.

#### Electric Vehicles and a GIANT BUDGET HOLE TO FILL!

Sadly, we got within striking distance of Oklahoma becoming one of the few states to pay incentives to citizens for the purchase of electric vehicles. We literally lost this one by about 2 votes! And sadly, some bills that would have ended coal incentives and ended ethanol incentives were both killed without getting any full votes—even though the State of Oklahoma Tax Incentives Commission clearly stated BOTH subsidies should be eliminated to help out Oklahoma's budget crisis.

#### Other Actions and Activities

We once again held a pre-session volunteer lobby training in January of 2018, this year at Gopuram restaurant, and we were honored to have Sierra Club's national State Lobby Director (Jen Hensley) attend our public event. She also joined us for a separate meeting where she offered insight into how to grow and improve our lobby efforts at all levels.

In addition to our pre-session lobby training, our lobbyist and director Johnson Bridgwater also travelled to all three local Groups to present a "Lobbying 101" session, and to detail important legislative issues. Record numbers of attendees this session proved there is a strong appetite in Oklahoma for everyday people wanting to make a difference at the Capitol.

We cannot leave out one of the most exciting actions of the 2018 legislative session—the participation and volunteering of the Oklahoma Chapter in the statewide teacher strike that focused its efforts at the Oklahoma State Capitol. We were honored to lobby on behalf of Oklahoma's teachers and state employees, while being able to lobby to support renewable energy and push back against Oklahoma's Big Oil Oligarchs. Sadly, the OEA (Oklahoma Education Association) canceled the strike at the worst possible moment, at the height of attendance at the State Capitol. Oklahoma Sierra Club wanted to see the strike continue, as did our numerous members who both work, and are retired from, Oklahoma's education system.

#### **GRASSROOTS EFFORTS**

#### THE LEGISLATIVE COMMITTEE

Oklahoma Sierra Club has a chapter-level Legislative Committee to help wade through the countless bills, to help focus where the most attention is needed, and to help with the non-stop outreach efforts needed throughout session as well as to help make specific events the best that they can be.

#### THE ACTUAL GRASS ROOTS—OUR VOLUNTEER LOBBYISTS

The Legislative Committee works to reach our members who have indicated an interest and a willingness to help with specific needs during legislative session—whether it is a phone call, a letter, an editorial, or directly meeting with legislators, our member volunteers are the backbone of our work. Red Earth Citizen Lobby Corps logged dozens and dozens of hours at the State Capitol, and they were a prime reason SB1465 was DEFEATED!

#### LEGISLATIVE SCORECARDS

The scorecards are based on votes on bills chosen from among our priority issues and taken together provide a strong composite representation of each legislator's relationship to environmental issues in the State of Oklahoma as a whole. The following are summaries of the specific bills selected:

#### **BILLS ON SENATORS' SCORECARD**

**SB1576:** Sen. Mike Schulz, R-Altus and Rep. Charles Ortega, R-Altus, prohibits the construction or operation of a proposed wind energy facility or proposed wind energy facility expansion from encroaching upon or otherwise having a significant adverse impact on the mission, training or operations of any military installation or branch of military as determined by the Department of Defense Siting Clearinghouse, the Federal Aviation Administration and the State of Oklahoma.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was signed into law on May 2, 2018.

**SB1465:** Sen. James Leewright, R-Bristow and Rep. Tim Downing, R-Purcell, prohibits any local communities from restricting, taxing, prohibiting or issuing any ordinance regulating the use, disposition or sale of food containers such as plastic bags or foam cups.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was defeated in the Senate.

**HB2756:** Rep. Leslie Osborn, R-Mustang and Sen. Kimberly David, R-Porter, modifies a tax credit for investments in qualified clean burning motor vehicle fuel property to allow credits to be issued for the purchase of electric vehicles and home charging equipment.

- -Oklahoma Sierra Club SUPPORTED this bill.
- -The bill was defeated in the Senate.

**HB2959:** Rep. Todd Thomsen, R-Ada and Sen. Marty Quinn, R-Claremore, repeals language related to 10-year assessments of electric power and energy requirements.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was signed into law on April 11, 2018.

**SB888:** Sen. Josh Brecheen, R-Coalgate and Rep. Jeff Coody, R-Grandfield, eliminates the refundability of the zero-emission tax credit. It permits zero-emission tax credits generated but not used on or after Jan. 1 to be carried forward for up to 10 years.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was defeated in the Senate.

**SB1412:** Sen. Mike Schulz, R-Altus and Rep. Charles McCall, R-Atoka, modifies the apportionment of revenue to from the Used Tire Recycling Indemnity Fund to the Department of Environmental Quality.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was signed into law on May 3, 2018.

#### BILLS ON REPRESENTATIVES' SCORECARD

**HB1035x:** Rep. Dennis Ray Casey, R-Morrison, Rep. Kevin Wallace, R-Wellston, Sen. Eddie Fields, R-Wynona, and Sen. Kimberly David, R-Porter, increases the cigarette tax by \$1 per pack. The "STEP UP" funding bill. The bill would have increased the gasoline tax by \$0.06 per gallon and the diesel tax by \$0.06 per gallon. The bill would have increased the gross production tax discount rate on all wells from 2 percent to 4 percent. The bill established revenue allocations.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was defeated.

HB 1033xx: This was yet another attempt to raise revenue without fully addressing the gross production tax. This vote was held late at night, after all of us that work the Capitol had long gone home. Political games, this bill was brought to a vote by Senate leadership, and it was defeated. Rep. Dennis Ray Casey, R-Morrison, Rep. Kevin Wallace, R-Wellston, Sen. Eddie Fields, R-Wynona, and Sen. HB2959: Rep. Todd Thomsen, R-Ada and Sen. Marty Quinn, R-Claremore, repeals language related to 10-year assessments of electric power and energy requirements.

- -Oklahoma Sierra Club OPPOSED this bill.
- -The bill was signed into law on April 11, 2018.

**SB888:** Sen. Josh Brecheen, R-Coalgate and Rep. Jeff Coody, R-Grandfield, eliminates the refundability of the zero-emission tax credit. It permits zero-emission tax credits generated but not used on or after Jan. 1 to be carried forward for up to 10 years.

-Oklahoma Sierra Club OPPOSED this bill.
