## **OKLAHOMA CHAPTER**

# 2019 LEGISLATIVE SESSION

---

The 2019 legislative session, formally known as the First Regular Session of the 57<sup>th</sup> Legislature, marked the first legislative session under the Governorship of Kevin Stitt. The overall tone was subdued, while the overall message was clear—all power was bent towards a “profit over people” Governorship that favors business interests over the public good. The session also resulted in the granting of immense power to the Office of the Governor regarding the Governor’s power and ability to name and appoint agency heads, including positions that directly impact the State’s ability to protect, or not, the environment across the State of Oklahoma.

Just as the session was starting, the Governor selected Ken Wagner, a long-time associate and employee of disgraced EPA Administrator Scott Pruitt, as Oklahoma’s new Secretary of Energy and the Environment. Secretary Wagner clearly revealed his support of the Governor’s agenda by actively participating in the legislative process. He personally introduced, and then heavily lobbied for, SB1003, the so-called “Environmental Audit Privilege Act,” a bill that completely favors corporate interests over the interests of the public good and will greatly impact the environmental health of the state and its citizens.

SB1003 was just one of several ALEC (American Legislative Exchange Council) originated bills the Legislature pushed through, all of which not only favor corporate power over democracy, they will negatively impact the air, land, and water in Oklahoma. SB1001, the Ban on Plastic Bag Bans bill, was another ALEC-based bill that passed. This bill takes away the rights of cities and towns to manage their own affairs by making it illegal for them to place limits or fees on materials known to be driving widespread pollution, like plastic bags and Styrofoam cups. Even if their own residents want such ordinances, they can no longer pass them. Sadly, the New York Times published a study showing that the Oklahoma Legislature sits at the top of the list of states where “pay to play” business legislation is passed through the state legislature—that is, bills originated not by constituents or local interests, but bills delivered to legislators by out-of-state corporate interests.

On a positive note, the Oklahoma Chapter of Sierra Club was very pleased to help support the introduction of several pieces of legislation that sought to support the expansion of renewable energy in the State of Oklahoma. We are happy to report the passage of HB2095, a bill we supported that expands Oklahoma’s clean energy tax incentives to now include certain types of electric vehicle charging stations. And though not successful, we worked hard to improve and expand the solar energy market this session. Currently, Oklahoma ranks 46<sup>th</sup> in the nation in overall production of solar energy, whereas all analysts agree we should be about 6<sup>th</sup> in the nation. Several pieces of legislation would have paved the way to expanding solar energy in Oklahoma, but sadly, the Governor’s office, along with OG&E and various oil and gas advocates, made sure NONE of the solar legislation received the support needed in either the House or Senate to make it out of committee—all solar legislation failed in committee this session. Opening up solar energy to a free market in the state of Oklahoma remains one of our biggest aims legislatively as we head into the 2020 session. ***We would like to thank Representative Denise Brewer, Senator Dave Rader, Senator Paul Scott, and Senator Mary Boren for their various efforts to improve and expand the solar energy industry in the State of Oklahoma.***

Our lobbyist and director Johnson Bridgwater travelled to Green Country Group to present a “Lobbying 101” session, and to detail important legislative issues. Johnson was joined by a new renewable energy lobby organization called the Oklahoma Power Alliance which specializes in supporting wind, solar and battery stored renewable energy.

On March 27<sup>th</sup>, we held our largest event in many years at the State Capitol. Known as Oklahoma Water Lobby Day, we partnered with numerous member-based organizations including Oklahomans for Responsible Water Policy, Trout Unlimited, Save the Illinois River, LEAD Agency, Green Country Guardians and others to voice our mutual concern over the general decline in water quality across Oklahoma. Guest speakers included Casey Camp-Horinek, Drew Edmondson, and Pam Kingfisher. The day was spent tabling, lobbying, hosting educational sessions, and it was capped off by a press conference.

The Oklahoma Beyond Coal campaign was heavily involved in the 2019 lobby session, mainly focusing on protecting the booming wind energy industry from oil and gas interests that have been working overtime to try and stall our amazing wind energy industry. Oklahoma Beyond Coal also helped rally Oklahomans and legislators to support several pieces of pro-solar energy legislation. Sadly, none of the solar bills made it out of committee due to strong opposition from OG&E, and a lack of support from the Governor's office.

## GRASSROOTS EFFORTS

## LEGISLATIVE SCORECARDS

---

The scorecards are based on votes on bills chosen from among our priority issues and taken together provide a composite representation of each legislator's relationship to environmental issues in the State of Oklahoma as a whole. The following are summaries of the specific bills selected for 2019:

### **BILLS ON SENATORS' SCORECARD**

**HB2095**, by Rep. Terry O'Donnell, R-Catoosa and Sen. Stephanie Bice, R-Oklahoma City, extends the one-time tax credit for investments in qualified clean-burning motor vehicle fuel vehicles and equipment to December 31, 2027. It provides the credit for fuel delivery equipment including EV equipment will be 45 percent of the cost of the qualified clean-burning motor vehicle fuel property.

- Oklahoma Sierra Club SUPPORTED this bill.

-The bill was signed into law.

**SB0702**, by Sen. Greg McCortney, R-Ada and Rep. Charles McCall, R-Atoka, establishes a moratorium on the Department of Environmental Quality (DEQ) permitting of any discharge from a subject mine to streams fed or supported by water emanating from sensitive sole source groundwater basins or subbasins, excepting cases where the DEQ issues a permit to correct compliance issues.

-Oklahoma Sierra Club SUPPORTED this bill.

-The bill stalled in the House of Representatives.

**SB0826**, by Sen. Stephanie Bice, R-Oklahoma City and Rep. Dustin Roberts, R-Durant, creates a one-time tax credit for investments in qualified 100 percent electric vehicles of \$3,000 and plug-in hybrid vehicles of \$1,500 and property related to servicing the vehicles.

-Oklahoma Sierra Club SUPPORTED this bill.

-The bill stalled in the House of Representatives.

**SB1001**, by Sen. James Leewright, R-Bristow and Rep. Dustin Roberts, R-Durant, prohibits political subdivisions from restricting, taxing, prohibiting or regulating the use, disposition or sale of auxiliary containers.

- Oklahoma Sierra Club OPPOSED this bill.

- The bill was signed into law.

**SB1003**, by Sen. Mark Allen, R-Spiro and Rep. Mark McBride, R-Moore, creates the Oklahoma Environmental, Health and Safety Audit Privilege Act to encourage voluntary compliance with environmental and occupational health and safety laws. It prohibits a regulatory agency from adopting a rule or impose a condition that circumvents the purpose of the act.

- Oklahoma Sierra Club OPPOSED this bill.

- The bill was signed into law.

## **BILLS ON REPRESENTATIVES' SCORECARD**

**HB1403**, by Rep. Justin Humphrey, R-Lane and Sen. David Bullard, R-Durant, authorizes the Oklahoma Water Resources Board to determine instream flows for specific, defined streams, decide upon committees dedicated to these streams and use data on instream flow determinations and make specific kinds of determinations on water use based on this data.

- Oklahoma Sierra Club SUPPORTED this bill.
- The bill stalled in the Senate.

**HB2095**, by Rep. Terry O'Donnell, R-Catoosa and Sen. Stephanie Bice, R-Oklahoma City, extends the one-time tax credit for investments in qualified clean-burning motor vehicle fuel vehicles and equipment to December 31, 2027. **HB2150**, by Rep. John Pfeiffer, R-Mulhall and Sen. Mark Allen, R-Spiro, requires it to be considered a taking pursuant to Article 2 of the Oklahoma Constitution and relevant statutes whenever a municipality, county or other political subdivision, other than the Corporation Commission, adopts or implements an ordinance, resolution, rule, regulation or other form of official policy concerning oil and gas operations that has the effect of substantially interfering with the use and enjoyment of the mineral estate.
