# **Don't Dump on SC!**


S. C. Sierra Club is leading the charge to protect the environment: Don't Dump on South Carolina! For the past year the South Carolina Sierra Club has been a lead organization fighting to prevent passage of H.3290. This bill would remove the current au-

thority of counties to control what trash comes into a county and where it is dumped. The opposition is currently trying to attach it as an amendment to another bill-H.3847.

We need to pressure our senators and representatives to oppose this legislation and the maneuver of the amendment. Call or e-mail your senators and representatives letting them know your opposition.

### YOU NEED TO ACT IF YOU BELIEVE>>>

1. You believe that South Carolina should NOT continue to be the nation's dumping ground. We have already opened our borders to low level nuclear



- 2. You believe that South Carolinians know what is best for South Carolina. You are tired of the role that out-of-state big money interest plays in defining policy in South Carolina. Lobbyists from the big national waste haulers are spending a lot of time and money convincing our politicians that the free market should be the only factor that determines what trash comes into South Carolina and where it goes.
- 3. You believe that South Carolina is a beautiful state with beautiful places and that these places should not be turned into landfills. Right now we have about 30 years of available landfill capacity at our current rate of disposal. If we open up these landfills to the rest of the nation, the current landfills will quickly fill and we will need to find more sites for landfills. And, of course, the General Assembly and the waste hauler lobbyists have no plan [that they will share with us] as to where these new sites will be.
- **4. You believe in recycling.** One reason we have the capacity cited above is because the counties mandated recycling goals which were very successful in diverting recyclable material from the waste steam. Waste haulers make their money on volume. There is no incentive to recycle.

### Saturday, March 22 • Nine Times Preserve

Join me and Frank Holleman, conservationist and attorney for the Southern Environmental Law Center, as we day hike and explore Nine Times Preserve in Pickens County. The Nine Times Preserve is not only an ecological treasure of the upstate but a perfect example of how local citizens, local and national environmental groups, and government work to protect and preserve our public natural lands. We will also have a chance to share thoughts and ideas with Frank on some important environmental issues facing our southeastern forests and learn more about what the SELC is dealing with in our state and forests.



**5.** You believe you are going to lose weight this year. And you probably have a few excess calories to burn toda

And you probably have a few excess calories to burn today. So get mad about this piece of legislation and shake your fist. Pound out a letter, craft an e-mail or make a call to your elected official while running in place. And once you do it, stretch and pat yourself on the back.

### THIS IS WHAT YOU CAN (yes you can) DO

- 1. Go to the South Carolina General Assembly web page and find your Senator and House member.
- 2. Send the letter, e-mail or make the call: I am against (and you should be too) H. 3290 (which takes away the authority of SC counties to say no to out of state waste) and the amendment to H. 3847. [Note: This bill itself isn't bad..it provides funding for dealing with e-waste. The problem is the guts of H. 3290 have been prepared as an amendment. It is the usual tactic of trying to sneak something into another bill and hope no one notices.]

### Easy Resolutions To Keep

- 1. Keep the TV off. You could get so much done today if you spend less time watching reruns and you could cut down electricity usage too.
