#### For Arizona Governor

#### Sandra Kennedy

#### About the Endorsement Process

The Grand Canyon Chapter's extensive endorsement process includes evaluating candidates' completed questionnaires, reviewing voting records (for incumbents and previously elected officials) and community and civic participation, and, in some cases, conducting personal interviews with the candidates. All endorsements are approved by elected Chapter leaders (Executive Committee). The recommendations in this guide reflect the Chapter's belief that the candidates understand the importance of environmental issues, will work to protect the future of Arizona's natural treasures, and will represent the public honorably as elected officials.

#### For U.S. House of Representatives from Arizona



#### Congressional District 3: Raúl Grijalva (i)

(i) = incumbent

Representative Grijalva is an environmental and social justice champion. As ranking member of the House Natural Resources Committee, he is often the voice for protection of Indigenous culture, wildlands and wildlife, and clean air and clean water. Grijalva has led the charge to keep intact the mineral withdrawal on lands surrounding Grand Canyon and to permanently protect those public lands by introducing the Greater Grand Canyon Heritage National Monument Act. He has also led efforts to stop the proposed Rosemont Mine from destroying the Santa Rita Mountains. Sierra Club is pleased to again wholeheartedly endorse Representative Raúl Grijalva.


#### Congressional District 6: Anita Malik

**Anita Malik** has never run for public office before, but has made it clear she will be an environmental leader. She will focus on justice, fairness, and equity in the natural and human environments and has experience with doing just that in her business and computer technology work. She wrote, "As a woman in tech and in startups, I have often had to lead the way fighting for other women and minorities. . . . In fact, I was named to FOLIO's "40 Under 40" list for leadership with East West magazine and the ability to eloquently promote and support a multicultural America, equality and justice." #### Congressional District 7: Ruben Gallego (i)

Long before his election to the U.S. House of Representatives, **Representative Gallego** was a strong advocate for action on climate change. He spoke up consistently for solar energy and a timely transition away from fossil fuels, including with various veterans' groups. As a veteran, he sees clearly how climate change is a threat to our national security and has been a persistent advocate for taking action, challenging his colleagues in the House to do more to address it now. Gallego has fought and consistently voted against legislation and riders that would harm our air, water, lands, and wildlife. Sierra Club enthusiastically endorses Representative Ruben Gallego.



**Dr. Hiral Tipirneni** has never held elective office, but ran a very strong campaign in the special election for Congressional District 8. Dr. Tipirneni is an emergency room physician with 20 years of experience in the Phoenix area. She wrote, "As a candidate, I have spoken repeatedly and advocated for the critical importance of preserving our natural resources, combating climate change, working towards a green economy, protecting our public lands, and ensuring environmental justice throughout not only Arizona but our entire nation." Sierra Club enthusiastically endorses Dr. Tipirneni in her run for U.S. House of Representatives.





#### Congressional District 9: Greg Stanton

**Greg Stanton** served as Phoenix mayor for six years before deciding to run for Congress in the ninth district. As mayor, he supported efforts to reduce the city's greenhouse gas emissions, expansion of the light rail and city buses, and increasing energy efficiency and the use of clean renewable energy. He is a strong supporter of parks and other public lands and believes we must do more to clean up our air and water, not less as is being proposed by many in Congress. Sierra Club is pleased to endorse the candidacy of Greg Stanton for the U.S. House of Representatives.

#### **Ballot Measures**

#### Proposition 306 Will Harm Clean Elections!

Prop. 306 is one more bad idea from an Arizona Legislature that is out of touch with the people. Sierra Club



strongly supported Clean Elections in 1998, when it was placed on the ballot via a citizen initiative, and has consistently supported it as the Legislature has sought to neuter its enforcement to discourage candidates who would rely on people rather than big money interests to fund their campaigns.

The Citizens Clean Elections Commission is an important part of the Clean Elections program as it serves as a key watchdog, helping to safeguard our elections. It is nonpartisan and doesn't do the bidding of one party or another. Prop. 306 would weaken the Citizens Clean Elections Commission and subject it to more control by whoever is governor, via a governor-appointed board. This would make it difficult for the Clean Elections Commission to fulfill its responsibilities to voters, including providing accurate and nonpartisan information on the candidates and enforcing key elections rules. **Please vote NO on Proposition 306.** 

#### Proposition 419 (Flagstaff) Inadequately Funds Pedestrian and Bicycle Improvements.

Sierra Club recognizes transportation planning is not only a key function of the state and federal government, but also local government. However, the process the city used to determine whether to put this sales tax on the ballot was flawed for several reasons. The City staff didn't bring forward any information to the Citizen's Transportation Tax Commission about greenhouse gas emissions and climate change despite the fact that the City Council has directed the City to produce a Climate Action and Adaptation Plan. Surveys demonstrate that the people in Flagstaff strongly support bicycling and pedestrian infrastructure, yet the amount of the sales tax that will be used to address these needs is woefully inadequate. If this sales tax is approved, it will actually create MORE TRAFFIC congestion. We urge a NO vote on Proposition 419.

### Proposition 127 Will Reduce Air Pollution that is Fouling Our Air and Changing Our Climate.

Sierra Club is committed to protecting the health of the people of Arizona as well as our abundant and beautiful public lands, including national parks, forests, wildlife refuges, rivers and streams, and wildlife.

But all of these are at risk because of human-caused climate change. We already see the impacts in record heat, perennial drought conditions, and intensified forest fires. The heat amplifies some urban air pollutants, aggravating ground-level pollution and increasing health risks for the most vulnerable in our communities, including asthma sufferers. Prop 127, the Clean Energy for a Healthy Arizona initiative, will help us to begin addressing climate change by reducing our reliance on dirty fossil fuels for generating electricity. It will require utilities such as Arizona Public Service (APS) and Tucson Electric Power (TEP) to generate half of their electricity from clean renewable sources by 2030, up from 15 percent today.

Passage of Prop 127 will mean fewer smokestacks spewing pollution into our air, fewer water intensive power plants, and more energy from clean, reliable solar. **Please vote YES on Proposition 127!** 



### Proposition 420 (Scottsdale) Gives Voters a Say on Construction in Preserve.

Sierra Club supports Prop. 420 to amend the city charter to require a public vote for any new construction on Mc-Dowell Sonoran Preserve land and for determining the use of Preserve funds for anything other than land acquisition and building approved trails.

We appreciate some aspects of the proposed Desert Edge project, particularly those educational aspects offered by Arizona State University and efforts to provide greater accessibility for people with disabilities. The \$61 million, six-acre, 47,000 square foot tourist attraction is better suited to a location off Preserve lands to avoid diminishing the very qualities for which it was established. Please vote YES and give Scottsdale residents a better voice in the future management of their beautiful McDowell Sonoran Preserve.


