**Greer Island to Remain Natural** 

Concerned about the potential for negative environmental impact of the proposed 300' terminal groin at the north end of Longboat Key, your Manatee-Sarasota Sierra group filed a motion to intervene, joining petitioner Joe McClash in requesting an administrative hearing concerning the Florida Department of Protection's intent to issue a permit. A hearing was scheduled for late January.

Sierra's motion was based on concerns that the hard groin would interfere with the nesting of sea turtles and the migrations of manatees. The structure would have permanently altered Greer (Beer Can) Island, a natural beach environment used by the public for recreation. Sierra maintained that rising sea levels should be considered. Sierra and McClash reached a settlement with the town of Longboat Key, removing the terminal groin from the present project for at least five years. The two permeable groins farther south will continue in the plans.

## PROTECT THE SARASOTA 2050 PLAN MARCH 18

The traffic situation around the University Parkway/I-75 intersection is the "Poster Child" for why we need to keep the protections promised in the Sarasota 2050 Comprehensive Plan. Recently, the *Sarasota Herald Tribune* highlighted the increasing gridlock in that area, soon to be compounded by the opening of the new mall, as well as many new homes being added to Lakewood Ranch and villages on the planning tables.

This is exactly the bleak future that Sierra Club, and many other organizations, warned about in the numerous hearings when the 2050 plan was being forged. We are facing gross failure in planning and decision making by our elected officials. And, in the face of this awful example of overcrowding the roads, and lack of money to fix it, they are now working feverishly to destroy the very protections we worked so hard to build into the 2050 Plan, under the guise of making it "workable for the developers". One of the key components of the plan is the Fiscal Neutrality, which requires the developers to pay for the increased infrastructure necessitated by their developments outside the Urban Service area. Removing the Fiscal Neutrality shifts the burden of these huge costs to the current taxpayers: you and me!

The proposed changes to the SRQ 2050 plan will come before the County Board of Commissioners on March 18 at 1:30 in the afternoon at the Commission Chambers on Ringling. We need to show up, and speak up! It does make a difference when the Commissioners hear what the public is thinking.

# Devil in the Details

Citizens who waded through the massive changes proposed for Manatee County's Land Development Code found more than the "reorganization" unveiled in October. Currently proposed revisions are a massive rewrite of the present Code spearheaded by the significant change from review of General Development Plans to Concept Development Plans.

The process will give initial approval to projects based on minimal details that are not even specified in the new code. These plans will come before the Planning Commission and Board of County Commissioners for approval. Final Site Plans will not be required to be approved by either the Planning Commission or the Board of County Commissioners. Large developments of 100 homes or more will require concept development plans in the proposed code, while the current language requires a preliminary site plan for 10 or more dwellings.

Many other revisions of the Code are objectionable. Significant sections relating to standards are removed, particularly environmental standards. The chart of proposed changes on the County website does not indicate that they remain. Some, but not all, appear to be transferred to manuals including the Public Works Manual. They will be out of sight of the public.

The proposed code removes maximum densities from residential zoning categories and removes requirements for compatibility. The public should be alarmed by the potential for vast changes in their neighborhoods.

For several years the County has engaged in a "How Will We Grow" exercise that was intended to give citizens input through advertised sessions and active speaking engagements by staff. The public understands that the implementation process will involve changes to the Comprehensive Plan. Sierra members believe that any Land Development Code revision should be done with the intent to implement Comprehensive Plan changes that may be needed for the County's future planning, with sufficient public review.

Until the concepts incorporated in "How Will We Grow" are made part of the Comprehensive Plan, including low impact development and form based codes, and more overall planning done about the goals for change, it does not benefit the County and the public to implement changes to the LDC that will remove specific elements of developments from public review.
